Notice is hereby given, that the Council of the Town of Stayton, Marion County, Oregon, deems it necessary and expedient and hereby declares its purpose and intention to improve that portion of Second street beginning at the north line of Water street and running thence north to the south line of Ida street and beginning at the north line of Ida street and running thence north to the south line of High street, all in said town, county and state, at the expense of the owners of adjacent and abutting property, by bringing said portions of said street to the established grade, constructing cement concrete curbs wherever same do not now exist and paving said portions of said street with a hard surface pavement, the kind or character of which shall be one of three kinds or characters, namely: Asphaltic Concrete on a Bituminous Base, Warrenite-Bituminous or Portland Cement Concrete, or said improvement, as specified by the Council after receiving the bids for the making thereof, said improvement to be made in accordance with the plans and specifications for said improvement adopted by the Council on the 2nd day of May, 1922, and which are now on file in the office of the Recorder of said town, and which for greater certainty and convenience and for more detailed description thereof, are hereby referred to and made a part hereof. Notice is further given, that the Recorder of said town will receive bids for the making of said improvement up to seven o'clock p. m. of the 15th day of May, 1922. Bids will be received on any or all of the different kinds or characters of pavements set forth in said plans and specifications for the making of said improvement now on file in the office of said Recorder. Myers, superintendent of the state employment institution for the blind at Portland, to proceed with the installation of equipment necessary to the enlargement of the institution's broom making department. Myers recommended the move as necessary to give employment of the inmates of the institution and expressed the belief that the product of the broom department could all be disposed of at a profit.

A request of Dr. G. C. Bellinger, superintendent of the state tubercular hospital, for authority to install a radio-phonograph for the entertainment of patients at the hospital was tabled by the board for the time being. Dr. Bellinger explained to the board that the patients at his institution were more or less isolated and were not in condition to participate in the recreations and amusements common to the inmates of other state institutions and recommended the radio-phonograph as a feature which would admirably meet the needs of his institution. It is probable that the installation will be authorized after the board has had time to investigate its feasibility.
