

EXHIBITS FOR POLK COUNTY FAIR GATHERED

Dallas, Or., Aug. 21.—Exhibits are being crowded into the commercial club rooms in a rapid manner and are being placed in condition for good display practically as fast as they arrive. To make them suitable for exhibition purposes requires considerable time and much painstaking work. When the stamp of approval has been placed on a sheet of wheat or other grain by Mrs. Robert Sachler, secretary of the county fair board, assurance is given that all its fine points have been brought out and that it will stack up favorably with exhibits obtained from any section of the state. Exhibited at Salem Polk county's display will give any county in Oregon a close race for first honors. Mrs. Sachler is thoroughly covering the entire county in securing these exhibits and is being assisted to a great extent by J. E. French. Between the two of them the county has been pretty well scoured, but there are still more to come. The secretary of the board will gladly call on any one that has grain they are desirous of exhibiting.

Mrs. Sachler states that this year she finds the farmers are seeing in considerable for the raising of but one kind of grain, where last year they would plant three or four different varieties. This is following along the lines advocated by the Oregon Agricultural college.

J. M. Campbell, agent of the Southern Pacific company, announces that his company will make special rates during the three days of the fair—October 5, 6 and 7. One and one-half times the regular fare will be charged over their lines from any point in Polk county for a round trip ticket.

SCHOL CLUBS URGED TO PREPARE EXHIBITS

Dallas, Or., Aug. 21.—Max Crandall, an expert accountant from Portland, is now engaged in the office of Joseph Willis, county superintendent of schools, in auditing the reports and books of the various school clerks in Polk county. This work will probably take him about two weeks to finish. The work is done annually on the order of the county court.

Mr. Willis and his deputy of late have been sending out letters to the various members of school clubs in the county, both the boys and the girls. These letters call attention to the fact that the state fair will start September 25, and if the clubs wish to send an exhibit it will be necessary for them that all final reports be completed at once in order that they may be forwarded to the Oregon Agricultural college at least 10 days before the fair starts. These final reports count 50 per cent toward winning the prize and especial care should be shown as to the manner in which they are made out.

KU KLUXERS INITIATE 450 ALIENS IN CHICAGO

Chicago, Aug. 21.—Defying threats of prosecution, 25,000 Knights of the Ku Klux Klan initiated 450 "aliens" in the suburbs of Chicago Saturday night, it became known today.

The convulse was held in the outskirts of the city. Most of the klansmen came with automobiles, which were parked in a great semicircle around a field.

In the center of the field a great cross covered with cotton from the street was the shrine where the candidates took the oath. The cotton was fired when the oath was taken.

For the first time since the Klan was organized newspaper men were admitted.

REVOLT IN KLAN LED BY DEPOSED GRAND GOBLIN

Atlanta, Ga., Aug. 21.—Acceptance of leadership of the insurgent forces of the Ku Klux Klan thruout the country was announced here today by G. B. Kimbro, Jr., of Houston, Texas, deposed grand goblin of the invisible empire.

Kimbro declared he would remain "in the fight" until Edward Y. Clarke, imperial wizard problem, and his associates had been removed from this office.

A movement, started in Tennessee several weeks ago, seeking Clarke's removal, has now spread to 25 states, he said.
