PAUL H. HAUSER BUYS BROTHER'S STOCK IN STORE

Announcement has been made that Paul H. Hauser has purchased all of the interest of Lloyd Hauser in Hauser brothers' sporting goods store at 372 State street as well as his interest in the building occupied by the business and will continue to conduct it at the same location. This is the culmination of a friendly suit instituted in circuit court in which Henry Crawford was named as receiver for the property. PROJECTS TO BE RECLASSIFIED

Denver, Colo., Jan. 8.—Scientific reclassification of irrigation projects with respect to productive capability under the most intensive methods is necessary here, for the federal government can give relief to settlers, in the opinion of representatives of water users and farmers of all western states in conference with reclamation service officials here. Yesterday, the conferees appealed to Washington by telegraph to state whether or not irrigation department will allow users to form their own irrigation project organizations. Delegation also declared that one adjustment essential to their satisfaction was a congressional provision in the reclamation act for appropriation for a fund to absorb the loss where lands may become classified as permanently non-irrigable. It was further stated that lands classed as non-productive at present, should be held in suspension of payments until thoroughly reclaimed.

NO CONFIRMATION OF MAIL CAR ROBBERY

Chicago, Jan. 8.—Reports that a mail car was entered and robbed Tuesday night in the Chicago & Northwestern railway could not be confirmed today. Rumors in the federal building were to the effect that parcel post matter valued at less than \$500 had been stolen, but the postoffice inspectors' office and the railway officials denied any knowledge of such a theft.

With low grades forcing two contenders for varsity berths off each team, basketball fans are in considerable doubt as to the result of the Oregon-Willamette basketball tilt next Saturday night.
