REVIVAL MEETS AT THE ARMORY

The revival meetings at the armory are increasing in interest and power as well as in attendance.

FEDERATION OF COMMUNITIES MEETS THURSDAY

When the Marion County Community Federation meets at the chamber of commerce here Thursday night at 8 o'clock it is expected members will be here from all over the county, not only to participate in the election of officers and executive committee, but to take part in the discussion of important topics coming up.

Included in questions for discussion will be rural dance halls and the proposed child labor law, both of considerable importance to outlying communities, as there is a dance hall measure before the legislature as well as the child labor amendment.

Dr. Walter M. Brown, to be in charge of the child health work here for the next five years for the commonwealth foundation of New York will also be present at the meeting to become acquainted with various community representatives.

John H. Scott will speak on a suit survey for Marion county and in addition there will be two minutes talks from representatives of each of the various communities in the federation. Two new communities, Fruitland and Hayesville will be represented at Thursday's meeting.

State Forester F. A. Elliott has called a meeting of the state board of forestry in Salem next Friday to consider proposed changes in the forestry code and whip the proposed new code into shape for legislative consideration. Enforcement of the law is said to be difficult owing to certain weaknesses, and it is claimed that court interpretation is different from the intention of those who wrote the act.

Other matters to come before the board will include a bill aimed to promote reforestation on private cut-over or otherwise denuded forest land through a change in taxation, and another bill allowing the state to acquire through gift or purchase deforested or reproducing forest type land. Another measure provides for camp fire licenses.

MA FERGUSON TAKES OATH OF OFFICE AS GOVERNOR OF TEXAS

to take an active part in the administration.

The investiture of the woman governor was a notable event. A few thousand of her fellow citizens witnessed the simple impressive ceremonies in the hall of representatives while from 20,000 to 25,000 stood outside.

So great was the crowd attempting to witness the inaugural that the governor's party was unable to enter when it called at the door. Six thousand persons jammed the hall. Finally police reserves were called and cleared a passage-way so Mrs. Ferguson could get to the platform.

As she came forth, Mrs. Ferguson was greeted by a tumult of noise and music. The "old gray mare" band from Brownwood, which brought the mare herself into the capitol, struck up "The Eyes of Texas Are Upon You" as Mrs. Ferguson, accompanied by her husband, former Governor James E. Ferguson, came out to the front of the platform.

Mrs. Ferguson wore a black silk gown, trimmed with wide gray fur and gray beads. Her hat was brown and clove fitting with black goose quills. She wore a black coat.
