

FISH BILL UP IN SENATE ON SPECIAL ORDER

Interest in the legislature as far as today's program is concerned, centers on the senate, where at 2:30 o'clock this afternoon the fish commission bill is a special order. It is one of the main incidents in the fight between the legislative organization and the governor, providing that appointment of the state fish commission be taken out of the governor's hands and placed with the state board of control.

The banking code, introduced in the senate, will also be before the upper body for third reading and final passage today. It, however, is not expected to bring up much of a debate, since it has been thoroughly thrashed out by the bankers of the state and the banking committee of the legislature, and most of the members know how their constituents want them to vote on the measure.

Some debate may arise today over Garland's bill providing for Bible reading in the public schools. The measure, which provides for the tenets of any sect or system, but to give students basis for moral character and respect for law. It provides that passages to be read from the Bible in the school throughout the year be selected by a commission composed of nine members, one of whom shall be the state superintendent of schools, one Catholic, one a Jew, one a Christian Scientist and the other five from Protestant denominations, not more than one, however, from any one denomination.

Proposed Salary Bills Would Add \$58,120 to Taxes

Salary increases totaling \$58,120 a year for county and state officers of Oregon are proposed by 22 bills now before the legislature and these measures do not include proposals to create new jobs, nor do the increases include the indefinite increases in pay provided for circuit judges or the added expense that would be incurred by the increase of the state traffic squad from 5 to 25 officers.

Compared with the session of 1923, when salary increases were among the things taboo, the change in the economy viewpoint of the session shows a radical alteration. House bill 219, by Mott, increasing the pay of most of the district attorneys of the state, accounts for \$17,400 of the additional burden that would be piled onto the taxpayers, and senate bill 26, by Staples, raising the pay of the seven supreme court justices from \$5250 to \$7500 a year each, account for \$15,750 more. The state officers who would benefit by the bills now in effect are: Secretary of state, increase from \$4500 to \$6000 a year. State treasurer, \$4500 to \$6000. Attorney general, \$4000 to \$6000. Deputy labor commissioner, \$1800 to \$2400. Dairy and food commissioner, \$2000 to \$3000. Secretary to governor, \$2000 to \$4000. Deputy secretary of state \$3000 to \$4000. Deputy state treasurer, \$3000 to \$4000. State traffic chief, \$2400 to \$3000.

JUSTICE COURT BILL AMENDED

Amended to make it effective at the expiration of the term of office of the present incumbent, Representative McCallister's bill to place the justice of the peace of the Salem district on a flat salary of \$2400 a year now meets the constitutional specifications, it is believed. The bill was amended in the senate committee after an opinion had been rendered by the attorney general that the constitution prohibits any decrease in the salary of a judicial officer during his term of office. Other amendments made in the senate give the county court the power to fix the allowance to be made for office rental and clerical help of the justice. In the original bill \$100 a month was allowed for clerical help and \$50 a month for office rent.

GENERAL STAFF GIVES TO WHITE BILL OF HEALTH

A general military staff, after investigating charges made by Major Charles Gjedsted, discharged employe of the state military department, that there were irregularities in the accounts of Adjutant General George A. White, rebuked Gjedsted and urged that Gjedsted be tried by court martial. The investigation, coupled with a report of Arch J. Tourtellotte, accountant, gives White a clean bill of health.

Gjedsted charged that four years ago White included claims for upkeep and repairs for his private automobile in vouchers presented to the secretary of state. Gjedsted, in an affidavit filed with Governor Pierce, also claimed that small mileage vouchers dating back to 1921 were irregular. This assertion is also found without basis by the investigators. The difference, believe the state treasurer, will make up any losses the state may incur through the administration of the act.
