Austin, Texas, Feb. 11.—(By Associated Press.)—A resolution calling for an opinion from the state's attorney general on legality of the Ferguson amnesty measure passed yesterday by the senate was unanimously adopted today by the house of representatives.

A referendum measure will be put before the people of Salem in a special election early this spring to decide whether Mayor R. H. Giesy's permanent bridge program will be carried out. The working committee of aldermen and citizens appointed by the mayor met last night and detailed work of bringing the necessary information out in graphic form to a special committee, made up of Fred Erickson, D. B. Herrick, W. H. Dancy, H. M. Rogers, city engineer, and Walter Lowe, street commissioner.

Either a bond issue of approximately \$500,000, or a millage tax of 1 or 1 1/2 mills will be the proposition put up by the city council for referendum action, and proponents of each plan of financing discussed the matter last night.
