FLU EPIDEMIC IS WIDESPREAD

The present epidemic of influenza at Salem high school is the most extensive in the history of the school, according to statistics issued this morning by J. C. Nelson, high school principal, covering the month ending March 20 of this year. One hundred forty-nine pupils, 54 boys and 95 girls, were dropped from the attendance rolls of the school during the month. During the previous month, which had a normal attendance, 23 pupils were dropped. The percentage of attendance for the month ending February 20 was 86.3. For the month ending March 20 the percentage was 51.5, which is the lowest percentage ever known in the history of the local school.

During previous epidemics the individual cases of flu have been much more violent, but never before has the disease been so widespread.

PAPER MILL AT CANAS BOUGHT BY CROWN MILL

Vancouver, Wash., March 21.—Purchase by the Crown-Willamette Paper company of all the property of the Henry Pittock estate and of Fred W. Leabetter at and near Canas, Wash., for approximately \$500,000 was announced today by the company through the Clarke County Abstract company.

The property involved in the transaction includes all of Lady's Island, all the shore line on the Columbia river in Canas, and property west of Canas; all un-sold platted and unplatted property in Canas; all land on LaCamas lake, including a reservoir which supplies the paper mills of Canas with water and all ditches and riparian rights of the LaCamas Water Power company. Fred W. Leabetter's home and the Pittock home on LaCamas lake are excepted from the sale.

The Crown-Willamette Paper company announced today it would put up a million dollar mill for the manufacture of paper bags alongside the present paper mill on property included in the purchase announced today.

But the bank book of Swartz for the estate shows \$1865.53 on hand, or about \$200 more than Swartz had reported in his final showing. This is accounted for, as a theory, that some of the checks written by Swartz to pay claims against the estate have not yet been cashed.

Ed D. Smith, banker of Jefferson, has been named as administrator of the Keuzell estate to take up the tax ends of that estate and settle them. The appointment was made on petition of F. Miriam Swartz, daughter of Swartz, and executrix of his estate.

REVIVAL SERVICES HERE

Special evangelistic services, extending over a period of three weeks, will be held in the Jason Lee Methodist church beginning Sunday evening, March 22. The series will close on the evening of Easter Sunday. Services will be held twice each Sunday at the regular worship hours and each evening of the week at 7:30 o'clock, with the exception of Saturday, when no services will be held.

The campaign will be under the leadership of the pastors of the local church. The newly organized orchestra of nine pieces will assist the choir in leading the song service each evening. An added feature will be the use of a new set of song books during the services.

Bids for the work involved in traveling the entire road between Silverton and North Silver Creek Falls were opened at the office of the county court this noon. The contract for hauling the rock has been let to A. Latham of Halt, who entered a bid of 79 cents a yard. It is estimated that 3000 cubic yards of crushed rock will be used in surfacing the road. I. N. Howe, of 1155 D street, Salem, was awarded the contract for hauling the rock. Although no definite scale was set in the contract, it is estimated that Howe will get a total of \$400 for hauling the rock. The distance of hauling varies from one to nine miles, which is the length of the road. Work on the road will begin on April 27.

THINK SHEPHERD KILLED ANOTHER

Chicago, Mar. 21.—A fourth death, that of Otto Graf in Salina, Kans., twenty years ago is being investigated by Judge Harry Olson of the municipal court in connection with the alleged murder of William N. McClintock. Graf was a brother in law of William D. Shepherd, foster father of McClintock, now charged with murder.

After Graf's death Shepherd is said to have succeeded to the management of the drug business in Salina.

Julie Graf, daughter of a Salina barber and sister of Otto, is said to have been married to Shepherd when he was lying in bed with an injured neck, reported at that time to have been broken, and when he is said to have believed he would die.

Charles B. Wyrick of Chicago, son of a former clergyman of Salina, already has conferred with Judge Olson and recalls Shepherd when the latter was living there.
