CONVICTS SHOOT POLICE OFFICER IN RUNNING DUEL

Sacramento, Cal., April 22.—Floyd Hall and Joe Tanko, escaped convicts who shot Police Officer Clyde Nunn severely yesterday in an automobile running fight, were still at large today, with city police and county officers searching city hideouts and countryside. The men are murderers and fled from a life imprisonment sentence at San Quentin state penitentiary two weeks ago by going over its walls.

The young highwaymen, one armed with a rifle, shot Patrolman Nunn as he overhauled them as they rode in an automobile which they had commandeered along with its owner, F. R. Harlow. They were seen by many citizens, nearly all of whom later identified prison photographs of the escaped convicts as those of the bandits of yesterday, who also are believed to be the men who shot and killed H. J. Litsberg, a merchant in his store here last week.

The shooting of Patrolman Nunn was dramatic and without warning. The holdup of Harlow by the bandits was witnessed by citizens, who saw one bandit climb into the front seat with his two year old daughter. The second occupied the rear seat.

Nunn and another partolman, A. J. Taylor, each in his auto were returning to their homes going off duty. The policemen learned of the Harlow episode and overtook the bandit car after a few blocks.

Taylor's car cut in front of the Harlow machine and Nunn challenged the bandits. A rifle shot was the reply and Nunn fired with his pistol until he lapsed into unconsciousness. Taylor pursued the fleeing bandits, but lost trace of them.

Nunn was shot in the chest, the bullet passing around his ribs and emerging from his back. He is not believed to be fatally wounded.

of the interior department.) The senator is charged with appearing illegally before the department to prosecute Campbell's oil prospecting permits.

Haste said he took up the matter, which had to do with a permit originally granted to L. E. Lincoln, with Booth himself on the same day. The Lincoln permit is one of those involved in the indictment under which Wheeler is being tried.

Fred Musger, Lewistown, Mont., restaurant proprietor testified that H. C. Glesser, former secretary to Campbell, who was a government witness, told him in Lewistown last January that "Wheeler did not have anything to do with government permits" and that he was hired to protect Campbell from L. C. Stevenson. Stevenson is a business rival of Campbell in the Montana oil fields.

Glesser previously denied on the stand that he made the statement.

W. G. Peley, Washington attorney testified that Campbell employed him to take care of oil permits before the department of the interior. The indictment against Senator Wheeler charges that he appeared in these cases for Campbell and accepted a fee for so doing. According to Peley, Senator Wheeler had no part in the Campbell land cases before the department.

WIRE TRANSMISSION OF PHOTOS ESTABLISHED

Chicago, April 22.—Transmission of photographs by wire which only yesterday was in its experimental stages, today is on an established business basis. The American Telephone & Telegraph company which recently perfected a process of picture transmission, has announced that commercial offices in three cities—Chicago, New York and San Francisco have been opened for public business. Certain periods of each day have been set aside for sending photographs between Chicago and New York and between Chicago and San Francisco.
