CHILEAN REVOLT SUBDUED

Santiago, Chile, June 8.—The uprising in the northern province has been crushed by the Chilean troops, an official communique announced. "Owing to the assistance of our services," the communique adds, "thirty of them were killed and a number wounded. The leader of the revolt, a local noble, died. Four hundred prisoners were taken to Iquique, capital of the province of Tarapaca. The troops sustained no casualties."

Actors' Strike Ties Up Macloon Shows; Jane Cowl Cancelled

Owing to a strike called by the Actors' Equity association, Jane Cowl and her supporting cast, who were to appear in "Romeo and Juliet," at the Grand Theater Tuesday night, will not appear according to schedule. Word of the strike arrived in Salem by telephone this morning.

The company was to have come here directly from San Francisco. No reason for the actors' strike has been announced. "I regret this unavoidable occurrence," reads the telegram from Louis O. Macloon, manager of the company, "which is beyond my control and renders it impossible for me to fulfill my contract."

San Francisco, Cal., June 8.—Louis O. Macloon, theatrical manager of San Francisco and Los Angeles, announced here yesterday that he will dispose of his active producing enterprises on the Pacific coast until he has reached a settlement with the Actors' Equity association which Saturday night prevented the final performance of a two weeks' run here of "Romeo and Juliet" under his management with Jane Cowl starring.

The action in calling the strike was taken by Theodore Hale, attorney and western representative of the Equity association, who asserted Mr. Macloon had abandoned rehearsal of another play in which Miss Cowl was to star and which was to have had virtually the same cast as that of the Shakespearean production without paying the actors for the two weeks' wages called for by the equity contracts.

The whole question is whether Miss Cowl and her company are permanent repertoire company or a company engaged for an individual production," said Mr. Macloon, who is also manager of the "Lady Be Good" company which opened here last night and of the "No, No, Nanette" company now in its nineteenth week in Los Angeles.

"I have posted a check and offered to leave the dispute to arbitration under the agreement of the Actors' Equity association and the Managers' Protective association. It is understood Mr. Macloon is disposing of his interests to Edward D. Smith of Los Angeles, former associate of the Shuberts.

Announcement that Saturday night's performance would not be given was made to the audience about an hour after the time set for the curtain to rise.

A statement by Mr. Hale said that unless Mr. Macloon reached an agreement with the Equity association, action would be taken to close "Lady Be Good" and "No, No, Nanette."

(Continued from Page One) ting fighting, and drivers with defective lights or other equipment about their cars. "The number represents nothing compared with the number the Salem police have dealt with," declared Giesey. "They have given 10 warnings, rendered assistance ten times, where they have made one arrest. I am ready at any time to go to jail for the Salem Police department and the state traffic department. "Ordinary drivers are not arrested on Salem streets for exceeding the speed limit unless they are going at least 25 miles an hour, although the official speed limit is 20 miles, he stated. There have been a few cases of arrests of drivers going under this rate, but the arrests came on stormy nights when they should have driven unusually slow. "In most cases they are going 50, 55 or even 60 miles an hour," he maintained.

Not even drop in to see me. I resented that." QUIBBLING IS THROWN OUT BY M'MAHON

(Continued from page one) clares it was never contemplated that courts should be used for quibbling over questions of this kind and declares "it is fair to say that fully one-third of the time of all courts in this state is taken up by contentions of this kind that are interposed for the sole purpose of doing an injustice by applying certain established rules of procedure not within the purview of the rules."

The case in question arose when viewers in leaving out the new highway assessed damages to accrue to Shields at \$300. Shields protested and sought \$2,000. This was refused. He instituted proceedings in the law side of circuit court but these were thrown out, and he then sought to enjoin the whole proceedings by a writ for injunction, which is the present case. The county, in answering, merely set up the proceedings so far followed out. Shields attorneys then demurred to the answer, setting up the grounds which Judge McMahon slaugthers in his decision.

Judge McMahon's decision is in full as follows: "In this case a demurrer was interposed to the answer upon the ground that a resolution was not properly signed by the County Judge and Commissioners; that the roadway was not described in definite terms; that notices are insufficient, because the returns thereon do not affirmatively show that W. J. Culver is County Roadmaster; that it is not properly stated that the road viewers were sworn; that the description of the roadway is insufficient in that it refers to the 'S. P. R. R.' but doesn't state what the 'S. P. R. R.' is, etc., etc.

"There is nothing here to show that any person has been misled or injured in the slightest degree."

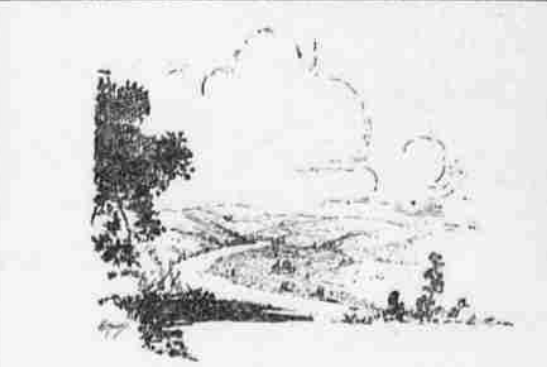
