

32 KILLED IN TRAIN WRECK

CHINESE ASK PROGRAM OF RETRIBUTION

Shanghai Seething City of Indignation and Unrest With Foreigners Reported in Grave Peril.

Shanghai, June 16.—(By Associated Press)—One foreign life for every Chinese life taken in the Shanghai riots was the slogan adopted by Chinese in posters distributed today after the killing of William W. MacKenzie, an English subject yesterday. Otherwise the situation remained unchanged, a seething city of indignation and unrest.

Further reports received up to 11 o'clock tonight from Chungking, Kluang and Nanking, (points on the Yangtze river) described the situation at those points as increasingly grave.

Foreigners at Nanking are considered in danger. Chinese employed there by Japanese and British firms are on strike. The British consul and his family are reported to have taken up residence at the American consulate. The principal menace at Nanking, how ever, lies in the possible cutting off of water and food supplies.

War On Foreigners

Washington, June 16.—(By Associated Press)—Anti-foreign agitation in the Canton vicinity is causing uneasiness in that place and nearby cities. Consul General Jenkins informed the state department in a dispatch sent from Canton June 14, and received today.

During a student demonstration in Wuchow on June 8 a mob yelled "kill foreigners" and threw stones at the American Baptist hospital the message said.

British Protest

Shanghai, June 16.—(By Associated Press)—The British consul general here today vigorously protested to the civil governor, and also to the foreign commissioner because of the killing of William MacKenzie, a British subject, last night. MacKenzie was shot by Chinese agitators.

Peking, June 16.—(By Associated Press)

Responding to representations from foreign legations, the Peking government today brought detachments of General Feng Yu-hsiang's troops into the city for guard duty, and also posted detachments outside the principal offices of foreign firms and foreign residences.

Several companies of General Ling's troops also arrived in Peking this afternoon, but it is doubtful that they will be able to cooperate with General Feng's men.

McNary Returns for Summer; Says Dawes Sincere In Purpose

Federal aid to states, the failure of congress to enact farm relief legislation, and the national plan of reclamation were commented upon today by United States Senator Charles L. McNary, who returned last night from Washington, D. C. Also the senator commented on failure of the Tongue Point submarine base, declaring that the government has not been fair with Clatsop county. The senator gives Vice President Dawes credit for sincerity in his fight for revision of senate rules, but says the senate already has what Dawes seeks.

"Congress, during the last session, was generous in the total sum appropriated out of the Federal Treasury to assist in the development of Oregon," said Senator McNary. "It should have been, because more than one-half of the state's area is owned by the government and consequently unutilized.

"If the people of Oregon could tax its largest land owner, the Federal government, in my opinion they would be willing to forego the aid they now receive from the National government, which is far less than the state and counties would receive if the land was under private ownership and of course subject to the burden of taxation."

WOLF OF L'SALLE STREET SOUGHT FOR BOND FRAUD

Los Angeles, Cal., June 16.—(A. P.)—Evidence of a gigantic plot to market stolen bonds from Chicago, Kansas City and St. Louis today spurred federal and county officials to an intensive search for John W. Worthington of Chicago, so called "wolf of La Salle street" who disappeared from a sanitarium near here last Wednesday.

Negotiable securities stolen from the Security Trust and Deposit company of Chicago, aggregating approximately \$148,000 in value, have been traced to southern California, said County District Attorney Asa Keyes today. Numbers identical with some of those on the stolen bonds have been located on sales slips said to have been issued by Worthington or his associates.

DEPOSITION OF WITNESS NOT NEEDED

Sworn Statement of Informer All Required For Issuance of Warrant Court Holds.

The constitutional rights of Albert Quartier were not encroached upon when officers raided a place operated by Quartier and his wife at 1122 Crystal Springs boulevard, Portland, on March 31, 1924, and seized a still, according to an opinion of the supreme court today. The opinion, written by Justice Bean, affirms the lower court for Multnomah county where the case was tried by Judge T. E. J. Duffy.

Quartier set up the claim that the affidavit on which the search warrant was issued was defective in that no deposition was taken by the magistrate, and it was claimed that the search was illegal in that the search was not made by officers to whom the search warrant was issued. Neither of these claims is upheld by the supreme court.

"It has never been the practice in this state," says the opinion, "to require the deposition of witnesses in addition to the sworn statement of an informant as a prerequisite to the issuance of a warrant for arrest. We can conceive of no good reason why such a practice should be required in the case of the issuance of a search warrant."

OREGON BETTER FIXED FOR ROADS THAN WAS ROME

There are at present 500 miles of paved roads in Oregon, and 2,000 miles of macadam roads, it was stated this noon by Roy Klein, state highway engineer, in a speech before the Salem Kiwanis club at the weekly luncheon of the club. The great bulk of the work has been done since 1915, he stated.

Mr. Klein estimated that 80 per cent of the traffic in the state. The annual increase in traffic is from 30 to 40 per cent, he declared, the increase being due to increased tourist traffic and increase in the number of cars sold inside the state. Last year a count was taken at Jefferson of the number of automobiles passing a given point on the Pacific highway there, and the number was found to be between 1500 and 2000 a day on the average, Mr. Klein stated. Fully 40 per cent of the traffic was from outside the state.

GENERAL WHITE LEADS PARADE

Medford, Or., June 16.—For the first time in the history of the Oregon national guard a full brigade marched through the streets of an Oregon city today, when led by Brigadier General White, nearly 2500 members of the 2nd brigade paraded through the business section of Medford while enthusiastic crowds lining the streets cheered them to the echo.

A national record for the Oregon national guard was also believed to have been established today by the fact that everyone of the 150 officers in the line of march, commanding from brigades to detachment, was a veteran of the World war.

The spectacle as the infantry and artillery behind the regimental bands marched through the streets was most inspiring one, and according to Brigadier General White was put on chiefly to demonstrate that the members of the Oregon national guard appreciate the treatment they have received from the people of the city.

NEW EUGENE HOTEL OPENED

Eugene, Or., June 16.—The new Eugene hotel, built and furnished at a cost of more than \$480,000, was formally opened last night.

The new structure, seven stories in height and with 183 guest rooms, was thronged with Eugene people and out-of-town guests. Approximately 400 attended the opening banquet.

F. A. Clark, one of the lessees of the hotel is an ex-Portland man, having managed several hotels there.

ISABEL POPE WILLING TO SPLIT ESTATE

Girl Who Waited at Bed-side of McClintock To Wed Him Is Ready To Share Fortune.

Chicago, June 16.—(By Associated Press)—Miss Isabel Pope will divide William McClintock's \$1,000,000 estate "50-50" with Iowa cousins of his mother if she will leaving it to William Shepherd, his foster father, in broken, she testified upon cross-examination in Shepherd's murder trial today.

Miss Pope added that \$100,000 of the estate was to go to Mrs. William Shepherd, wife of the defendant and foster mother of "Billy" in the event the pact with Iowa relatives was carried out.

REGENTS BAR REPORTERS FROM MEET

Board Chooses To Consider Faculty Change Controversy at University In Secret Session.

Eugene, Ore., June 16.—Several changes in the faculty personnel of the University of Oregon were made by the board of regents of the institution, meeting here late yesterday afternoon, in open session, and then the regents went into another executive session, to discuss recent denunciations brought about at their last meeting.

Newspapermen present at the meeting were barred from the room when Dr. James H. Gilbert, representing the faculty committee of re-opening the denunciation cases, asked that a committee of the board of regents meet the faculty committee. This the board refused, on the ground that the matter must be settled so that re-appointments may be made in the faculty before the opening of the fall term. The faculty committee was not ready to meet the board yesterday, it was said.

ARREST WOMAN AS SUSPECT IN YOUNG MURDER

Los Angeles, Cal., June 16.—(By Associated Press)—Another arrest, that of a young and handsome woman was declared imminent today by Edward King, investigator of the district attorney's office in connection with the killing of Grace Coogan Young, former widow of Patrick Coogan, olive millbonaire.

The dead woman's husband, Dr. Thomas W. Young, already has confessed his part in the killing and, King said, is believed to be shielding his accomplice.

RETIRED PROSECUTOR SUES KLAMATH PAPER

Klamath Falls, Or., June 16.—W. P. Myers, who quit office last Saturday as acting district attorney, following a prolonged newspaper criticism of his office, last yesterday brought suit for libel against the Klamath Falls Evening Herald, seeking \$10,000 damages for alleged defamation of character. The ex-prosecutor announced at the same time that six similar suits would be filed against the newspaper.

SCHOOL BUDGET OF \$646,910 PASSED BY LONE TAXPAYER

The annual taxpayers' meeting was held at the office of the city superintendent of schools last night.

The budget, as presented by W. H. Burgiard, school clerk, showed total expenditures of \$646,910.63 during the school year 1924-25, with receipts amounting to \$647,099.51. The figures were swelled by sums borrowed and later paid back. One hundred six thousand dollars was borrowed during the year, which made the receipts amount to that much more. The sum of \$157,125, was paid back on current indebtedness, swelling total expenditures by that amount. At present there is a current indebtedness of \$2,500 at the bank, as compared with an indebtedness of \$33,000 at the close of school a year ago.

69 INJURED WHEN CARS ARE DITCHED

Track Weakened By Rain And Twisted By Lightning Gives Way Under Speeding Train.

Hackettstown, N. J., June 16.—The toll of dead in the wreck of a Delaware, Lackawanna and Western railway special emigrant train near here early today, mounted to thirty-two at six o'clock tonight. Thirty-six persons are in a critical condition in hospitals.

TRUCK WEAKENED BY RAIN AND TWISTED BY LIGHTNING GIVES WAY UNDER SPEEDING TRAIN.

The wreck was caused, according to railroad officials, by an earth slide in last night's storm. The train was filled with emigrants who were returning to a visit to their native land accompanied by children and grandchildren. The cars were decorated with banners reading: "See the old country again."

On the plover up roadbed beneath the locomotive lay the twisted body of a little girl in flimsy nightgown.

Mrs. Duncan Dunn, who lives about 500 yards from the crash, sounded the first alarm. She telephoned physicians, who called hospitals at Dover, Phillipsburg, Easton and Morristown. Hundreds of rescue workers had arrived by daylight and two relief trains began receiving the injured.

Twisted by lightning and tracks gave way beneath the train and the cars and engine piled up on one another. Reports said the train carried 132 passengers, mostly aliens from Chicago en route to Hoboken, where they were said to sail for Europe today. Most of them were asleep when coaches pounded upon one another into the steam and scalding water burst from the wrecked locomotive.

The engineer, fireman and conductor were killed. Fifteen bodies have been taken from the wreck and others are believed to be beneath the debris.

It is reported it was said that lightning struck one of the rails, throwing it out of place, that a landslide led to the severe storm had covered the rails and that the track also had been undermined.

Washington, June 15.—(A. P.)—Three distinct phases of the troubles in China take form as the result of study of the Washington government's mass of reports from that country and a canvass of expert opinion in government circles. Canton has been recaptured from Yunnanese defenders by Cantonese soldiers representing the radical wing of the followers of the late Sun Yat Sen.

An anti-foreign agitation springing from troubles in Shanghai has spread up the Yangtze river causing disorders in many cities.

A conflict which western observers think may overshadow all other departments beyond the end of 1925 impends in northern China as 1925 reveals military powers, with Peking and the armed domination of most of China as the prize.
