The employment bureau at Salem showed a slight slump during the past week over the previous week, but continued far above normal. It is thought that the holiday of July 4 may have affected the situation. During the week 255 men applied at the local bureau, operated by Sam Phillips of the local Y.M.C.A. Of the number 215 were placed in jobs. Two hundred and thirty-five men were requested by employers, and 230 were returned. Most of the activity centered in the field of farm labor, although many were set at common labor in the city. Agricultural laborers, including berry pickers, harvesters and flax pullers, registering totaled 153. Two hundred and fifteen were asked, 155 were referred and 150 were placed. Thirty-three farm hands were placed in jobs. Forty-two common laborers applied for work, of whom 33 were placed. Two carpenters were hired through the local agency. With the exception of one hotel housekeeper and one nurse all the activity among the women was confined to the agricultural field during the week, 47 agricultural laborers being hired.

BOAT SERVICE TO PORTLAND NOT TO CEASE (Continued from Page One.)

ing shallow bars, reports indicate that the federal appropriation allowed for clearing the river channel was \$24,000, of which not more than \$10,000 has been spent.

Regular customers are being taken care of by trucks while the boat is forced to lie idle.

"I'm not going to quit as long as there's any possible way to get the Northwesters up here," said Mr. Karr this morning. "The boat's going to run all summer if it can possibly be done." The immediate concern of transportation officials is that federal authorities may decide to abandon the project of dredging the channel, which has now been going on for two months. It is considered of vital importance to hold the run continuously, for if the river is not used for transportation purposes the federal authorities will not keep the channel open.

A pile driver is to be brought up from Portland in the near future to do jetty work in the vicinity of Grand Island, a piece of land some 5 miles long, devoted largely to flax growing and truck gardening. Piles will be driven at the south end of the island, which is located just north of Wheatland Ferry, 12 miles down the river from Salem. All the water will be thrown to the east side of the island, and the west side channel left dry. It is understood that a special government appropriation has been made for jetty work.

The Montecello, the government dredge, has just completed cutting through Edridge bar, some 18 miles below Salem, having spent 10 days at that point. It will next be moved to the upper Weston bar, two miles farther down the stream. It is expected that it will take from three to five days to cut through the bar there, after which it will be brought back to Lincoln bar, 8 miles below Salem. A considerable amount of work has already been done on a Lincoln bar, and it is expected that a few days will be needed to make the channel clear through there. The boat will be able to resume its run within two weeks unless something unforeseen occurs, Fred Karr states.

The Northwestern is the largest show water boat afloat, which is given as one reason for the difficulty in getting her through, although she draws less water than many show water vessels of smaller dimensions. It is stated that a boat of shorter length and with a narrower beam, requiring a narrower channel, would stand a better chance of getting through.

DOG POISONING CONTROVERSY IS AGITATED ANEW

Wes Salem, Or., June 5.—The controversy between George Aschenbrenner and Frank Einfeldt over the poisoning of Aschenbrenner's dogs on June 23, took on a new angle here today when Aschenbrenner came forward and announced that he had succeeded in persuading Colonel E. Hofer, president of the Oregon State Humane society, to write a letter to Mrs. F. W. Swanton of Portland, manager of the society, urging that the case against Einfeldt be pushed as vigorously as possible. Colonel Hofer indicated in his letter that, if possible, he would be at Einfeldt's trial himself. The trial has been set for next September. The letter was written July 2.

Trouble between the two men, Einfeldt and Aschenbrenner, was commonly goes by the name of Brenner. Aschenbrenner states that it originated over a piece of property bought by him, to which Einfeldt laid some claim as having started to purchase it at a previous date. After a considerable amount of agitation between the two men Einfeldt was removed from the property, which adjoining a lot to which he has a clear title. Aschenbrenner states that Einfeldt still drives over his property to get to his own, without permission from Aschenbrenner.

Aschenbrenner denies reports circulated by Einfeldt's friends to the effect that the dogs were poisoned by means of a bait. Gossler states that he examined the animal and found that it had been done with ground glass, similar to that which was thrown to Bobbie, the "wonder dog," in Salem some time prior to the fatal occurrence in West Salem. FRENCH RUSH WOMEN FROM DANGER ZONE (Continued from page one)

is understood to be General Guillaumet, commander in chief of the allied operations in the Balkans during the World war.

Dispatches from Fez yesterday represented the situation in a highly pessimistic light, with wholesale defections of hitherto friendly tribesmen and an insufficiency of French troops to hold the line against Abd-el-Krim's drives in the direction of Fez and Taza.

Action Explained. This caused such a stir in Paris that Premier Painleve issued an explanatory note declaring that "public opinion ought not to allow itself to be disturbed by such episodes, which are customary in colonial wars."

The impression prevails, nevertheless, that Abd-el-Krim is active in developing upon a larger scale than any heretofore attempted, calling for drastic action on the part of the French command.

The French have begun a counter movement and this is making considerable headway, according to the latest advices from headquarters.

Taza has become the center of interest on the Moroccan front. The tribes north of that city, which previously have sided with the French now have rebelled, throwing their support to Abd-el-Krim and thus increasing the danger to Fez from the east.

French officials circles however, expressed themselves as reassured by the measures to be taken to meet this new development.
