## METRIC SYSTEM MEANS A SAVING

Los Angeles, Cal., Aug. 5.—Millions of years lost in the nation's school rooms during a single generation by failure to adopt the metric system of weights and measures was the estimate presented to the American Chemical society's meeting here today by Professor Eugene C. Bingham of Lafayette college, Easton, Pa.

Professor Bingham also declared that discarding of the present English system in favor of the metric tables would simplify buying.

The total gain, he said, would mean a revolutionary advance in national economy through the mere use of the decimal point.

In a resolution adopted today by the society's council, manufacturers of photographic plates, films and chemicals were requested to publish approved metric formulas in addition to the English formulas.

"Time-saving can be accomplished in the schools, it was pointed out, because a vast number of school hours is devoted to mastering the English system, while the metric system can be learned with relatively little effort.

One benefit to the school pupils would be the virtual elimination of common fractions from arithmetic.

during the trial as if they were having a Roman holiday, made great sport of it and some of them were bitterly unjust and unkind to the people whose hospitality they accepted, and of whose noble qualities they knew little or nothing. The fact is they were among a clear-sighted and thinking people who have no superiors in natural intelligence and excellent qualities in the world."

The people of Tennessee, Governor Peay said, know that evolution is and in the very nature of things must always remain a speculation and a theory. They believe that the Bible is the revealed and inspired word of the Creator of all things and are unwilling for the children to be taught the contrary.

The governor said that there is no federal question in the Scopes case.

"Tennessee is a sovereign state and except as forbidden by the federal constitution, has absolute and exclusive authority to regulate its local concerns and to employ its police powers without any federal interference," he said. "Whether or not the law, when properly construed, prohibits in our schools the theory of evolution, remains to be seen. It certainly prohibits its teaching as a fact. In any event Tennessee would not presume to regulate the schools and methods of instruction in other states and beyond treating with offenders from elsewhere who undertake to tell here how to run her own schools, she will give them no attention."

## BULGARS DENY GREEK CHARGES

Sofia, Bulgaria, Aug. 5.—(A. P.)—The Bulgarian foreign office has denied any movement of forces in retaliation of the dispatch of the Greek troops to the Bulgarian frontier because of the assassination recently of M. Nicolalde, a Greek citizen on Bulgarian territory, and because of alleged terrorist acts against Greeks in Bulgaria. The Bulgarian army, however, was declared ready to do its duty if called upon.

Official information reaching the foreign office is that two Greek detachments started from Solinka and Cavalla, Monday, for the Bulgarian frontier. The foreign office spokesman felt that Greece was acting with great precipitancy and he observed that the Bulgarian government was willing and ready to do full justice as it had already done in the case of the killing of Albanians from Serbian territory which caused protests by the Jugo-Slavian government.
