## SPECTATORS FLEE AS BIG OIL TANK BURNS

Fresno, Cal., Aug. 11.—Spectators were forced to flee last night when the flaming 750,000 barrel oil reservoir of the Shell Oil company at Oilfields "boiled over," after being struck earlier by a lightning bolt. Hastily constructed ditches failed to halt the advance of the seething oil and the home of the superintendent, 100 yards from the reservoir, was destroyed. Small fires were started by the overflowing oil, but no serious damage has been reported.

Every day that the fire lasts, 20,000 barrels of oil will be removed by pumping to the tank farm of the company several miles away.

The loss is estimated at from \$1,000,000 to \$1,500,000 and is covered by insurance, according to officials of the Shell company.

## NEW YORK FACES BITTER BATTLE OVER MAYORALTY

New York, Aug. 11.—(AP)—William M. Bennett, defeated republican candidate in the mayoralty campaign against Mayor Hylan in 1917 announced today that he will enter the republican primary against Frank D. Waterman, fountain pen manufacturer, selected yesterday to head the republican citizens ticket. Mr. Bennett won the republican designation in the primaries of 1917 against John Parry Mitchell, then mayor.

With the naming of candidates by all parties and factions, battle lines have been drawn for a bitter mayoralty campaign on issues, which as already set forth by leaders, range from "malaria" retention of the five cent fare, subway and school construction to the charge as to whether Governor Smith or Hearst shall rule the democratic party in state and city.

Finegan, independent for controller and Alderman George U. Harvey, republican for president of the board of aldermen, were low bidders for district attorney is Charles S. John McCooey, Brooklyn democratic leader, at the same time put out an anti-Tammamy slate made up of Edward J. Hylan, renomination for that term; William H. "Big Bill" Edwards, collector of internal revenue in the Wilson administration and former Princeton football star, for comptroller, and William A. Cokely, real estate appraiser of the Bronx, for president of the board of aldermen.

Medford, Ore., Aug. 11.—With cooler weather and all but one of the 21 fires reported yesterday under control, the forest fire situation in Jackson county this morning was much improved, according to a statement issued by the local forest service.

The one fire of serious proportions is about seven miles from Prospect near the Crater Lake highway, and has burned over about 40 acres, but is confined to an old burned area and will not threaten merchantable timber.

The police now believe that he had been acquainted with Barbe for four years.

The identification of the victim as Barbe is regarded as virtually certain through the disclosure of witnesses who directed Barbe to the plant of the cellulose company at Walnut creek; through the statement of another person that Barbe had told he was going to Walnut Creek to visit his friend, Schwartz, and through evidence at hand that Schwartz and Barbe had written letters to each other numerous times.

Knew Victim Before  
L. G. Shoemaker, a former service man of Los Angeles, told the contrary story that Schwartz and Barbe met in his presence in Walnut Creek in 1921.

The pretensions of Schwartz to have been a chemist and the inventor of a compound for artificial silk making that would "revolutionize the industry" have suffered as the investigation is progressing.

## REDUCED POWER RATE OFFERED LARGER PLANTS

The reduction in Oregon electrical power rates to \$27 per horsepower year for requirements running to 4000 horsepower or more, as ordered by the public service commission in Portland yesterday, is also of importance to Salem as far as it has a tendency to attract new industry or cause extension of those already established. The new rates apply to Salem and elsewhere as well as in Portland.

The Oregon Pulp & Paper company, the only big consumer of electric power in Salem at present, is now on a sliding scale, which under the new rate will entitle the company to a rate of \$27 per horsepower when the paper mill's load at present is a little under 3000 kilowatts and the rate about \$29 per horsepower year. Some extension of the plant is said to be in prospect.

W. M. Hamilton, manager of the Willamette valley division of the Portland Electric Power company, does not consider the new rate of especial importance as an attraction to new industries for the reason, he explains, that power cost in ordinarily a very small item in calculating the cost of operating industrial plants, often figured at around 2 per cent only. Certain kinds of plants are exceptions, requiring much more power than others.

There were three bidders on the job besides Thornley & Jones, contractors, were low bidders and the contract has been awarded to them. Their price was \$3578, including everything.

Work will begin on the building immediately.

## STOLEN MAIL POUCHES CONTAIN SMALL LOOT

San Francisco, Cal., Aug. 11.—E. Cain, postoffice inspector in Chicago in charge of investigation of the robbery Saturday when a mail truck was held up, said eight mail pouches of air mail taken by six men, declared yesterday that a partial check up revealed there were virtually no negotiable securities in the loot. Cain said that such a score obtained would be difficult to cash as the serial numbers had been broadcast to banks.

Actual figures on the amount of loot secured were not available. A reward of \$2000 each for the men, said Cain, was posted by the postoffice department today. The automobile used in the holdup was found abandoned near Colma, a few miles south of here.

## MOTOR REGISTRATION PASSES 200,000 MARK

For the first time an Oregon automobile is carrying license number 200,000. The distinction of having that number has fallen to C. W. Nelson of Bend. This, however, does not mean that the actual number of passenger automobiles has yet reached that number, since the numbers from 80,000 to 99,999 have been reserved for trucks. The actual total license issued is 157,503, of which 152,393 have been issued for passenger cars and 15,200 for trucks.

## THREATEN JEWS WITH MASSACRE

Williamstown, Mass., Aug. 11.—(A. P.)—Arab leaders in Palestine have predicted that the Jews will either relinquish their Zionist movement there or be eliminated by a general massacre. Dr. William E. Rappard of Geneva, a member of the league of nations permanent commission of mandates, said at the institute of politics here today. He was addressing a round table conference on the Mediterranean area.

Dr. Rappard said the Jews in Palestine were emphatically opposed to bolshevism although they were developing agriculture on a communistic basis there. He declared that an international commission to govern Palestine would be "the worst kind of anarchy."

Other speakers testified to the bitterness of the Arabs toward the Jewish population and Zionism.
