**MONGOLIANS ORDER SCIENTISTS OUT; FIND FIRST MEN'S FLINTS**

Dunes which ages ago formed the shore of a lake, since vanished, the expedition discovered traces of human beings which closely resembled the handiwork of the Azilians man found in Europe.

Mr. Andrews believes that this form of primitive culture went from Europe to Asia. He announced his discovery today on the eve of his departure from Peking to rejoin the expedition which is awaiting him about 200 miles north west of Kalgan, on the edge of the desert. The expedition has covered a course of about 4000 miles across the Gobi desert as far as the Altai mountains.

The men who left the remains uncovered by Mr. Andrews and his companions have been named the "dune dwellers" of Shabarack Ussu, taking the name of the place their traces were discovered. Among the dunes of the vanished lake shore were found an abundance of flint and jasper implements and weapons and the remains of fireplaces, with charred animal bones and layers of ash.

No human bones were found. That the dune dwellers were the original discoverers of the dinosaur eggs which Mr. Andrews introduced to the civilized world in September, 1923, was proved by bits of shell neatly drilled for ornaments. These shells were of both the dinosaur and a giant ostrich now long extinct.

In the dune dwellers of Shabarack Ussu we believe we have found the earliest type of men in the development from the ape," Mr. Andrews asserted.

**TOTAL ABSENCE OF DISCIPLINE AT PEN BLAMED FOR BREAK**

M. W. Miller, the present principal keeper, admitted under examination that the convicts staged a riot in the cell house one night recently, demanding more radio music. When the warden was informed of the cause of the riot he ordered that the radio be turned on and the disturbance subsided.

Prior to this the deputy warden had ordered that the radio concerts be given twice a week—Thursday and Sunday nights—but they are now being given four nights a week under instructions from the warden, Miller said.

**Runaways Not Punished.**  
Miller also testified that convicts who break from the institution and are captured and returned are not punished.

"But trusties, who break their word and run away are put in the bull pen when returned," he said. He also said that the hole in the roof could not have been made in less than an hour's time, and explained that the prisoners are searched once every two or three months, some of them often if they are under suspicion.

Other instances cited of where the warden had set aside disciplinary orders of his subordinates were told by the witnesses. Deputy Warden Lilley admitted that he had once placed a man in the bull pen, and the convict had been turned out by the warden. Lilley also admitted that his order containing baseball games in the yard to Saturday afternoon and Sundays had been countermanded.

Interrogated as to whether discipline at the prison had been satisfactory to him, Lilley answered: "Is Without Power."

"In some way it has and some ways it has not."

"Have you had full power to enforce the discipline you would desire without interference?"

"I can't say that I have. Anyway, the public might not stand for it."

"Have there been times when things were done to meet with the requests of the convicts that did not meet with your approval?"

"Yes, sometimes."

Murphy, Gardner and Lilley all testified that they had talked of the laxity of discipline with their superiors, but that nothing had been done to correct it. Murphy said he had never talked with the warden because "he is unapproach-

able." Claire A. Baker, who started his career as a prison guard back in 1897 under Governor Lord and who is now employed as a wall guard, was another witness.

**No Discipline Now.**  
"Compared with the old prison system under former wardens there is no discipline at the prison now," said Baker.

"Lack of discipline is the whole trouble now, and until discipline is established the danger of breaks similar to this is constant. The guards felt it was coming. The experienced guards are always studying the convicts, and when they see them to begin to get 'uppity' and rebellious they know there is trouble brewing. This condition existed prior to the break last week."

**Discipline Destroyed.**  
"There is no disciplinary now, and all orders for punishment apparently have to go thru the warden. The convicts are constantly gaining more ground. They are running the prison. I had one of them, a barge, tell me the other day that they (the convicts) could get any guard discharged they wanted to."

"There has always been two factions among the guards and that has destroyed efficiency."

"Are all of the guards there now efficient men?" Baker was asked.

"Most of them are alright, but there are some guards out there who would be better on a farm or somewhere else nice and peaceful," he answered.

C. E. Charlton, discharged as principal keeper July 1, declared that discipline at the prison has been "miserable since the first of the Pierce administration, as compared to that which existed under former wardens for whom he served."

**Dairymole Denial.**  
"The bull pen is the only means of punishment now in use at the prison, and it has no terror for the convicts. The bull pen is a fake."

Warden Dairymole entered a flat denial to all of the accusations of lack of discipline, assuming full responsibility for the conduct of the prison, and charged that evidence against him as being part of a plot by discharged and disgraced employees to discredit him.

R. J. Carrey, head chapel guard returned to the stand, reviewed his testimony of the first day of the hearing and admitted that Jones and Kelly had for the past month been occupying cell 26 together, and said that Murray was in 29 and Willos in 35.

"Order has been excellent the last year and an example was offered during the legislature when the prison show played for an entire week. When I took over the institution the place was a wreck, with convicts joyriding in state owned cars and being chased back to the institution by the Salem police. Since that time there has not been a complaint received regarding such performances," Warden Dairymole declared.

"If any mistakes have been made, I made them and am solely responsible," the warden said, "for the governor gave me free hand in the management of the penitentiary."

**Have Always Gambled.**  
"Prisoners have always gambled and always will and if there have been any charges made they have been made by men whose duty it was to prohibit it. Men I have discharged for drunkenness have been called to testify before this jury and all I ask is a square deal," Warden Dairymole declared.

Since becoming warden October 8, 1923, there has been perfect order and it has been the purpose to maintain the best discipline possible with the minimum of punishment. Handling of convicts by the methods used years ago, when men were tied up by the wrists overnight and flogged is not tolerated. Lack of employment is the greatest problem at present according to the warden.
