Pierce to Demand Tax Upon Personal Property Be Made

"The terms 'persona estate' and 'personal property' shall be construed to include all things in action, household furniture, goods, chattels, moneys and gold dust, on hand or on deposit; all boats or vessels, whether at home or abroad, and all capital investments; all debts due or to become due from solvent debtors, whether on account, contract, note, mortgage, or otherwise, either within or without this state; all public stocks, all bonds, warrants and moneys due to or become due from this state, or any county or municipal subdivision thereof; and stocks and shares in incorporated companies liable to taxation on their capital as such; and all improvements made by persons on lands claimed by them under the law of the United States, the fee of which lands is still vested in the United States."

The governor adds that an opinion of the attorney general has held that the statute as quoted is to be interpreted just as it reads. He declares that repeal of the state income tax law from which \$2,579,000 has been collected, with more to come, has increased the burden on real property.

"I feel that as governor of this state," the letter concludes, "I would be derelict in my duty if I did not continue in every honorable way to bring about a more equitable distribution of the burden of taxation. I know full well that the present assessment laws are not equitable, and that the tax burden is not being justly distributed. I know of no better way

The non-competitive basis on which county exhibits were arranged this year at the state fair has brought out exhibits that are truly representative of the various sections of the state and are, incidentally, the best sort of advertising obtainable.

County agents and others here to take charge of these exhibits one and all, express themselves as more than pleased with the new ruling. E. R. Ostman of Medford, for six years supervising Jackson county's exhibit, said today: "Everybody is satisfied this year. Everybody is satisfied alike. State fair patrons will go away this year with a definite memory of exhibits instead of the jumbled lot which has prevailed heretofore. The people themselves are the judges this season. Folk will, for instance, remember that Jackson is essentially a fruit section, with pears a specialty." H. E. Warner, also of Medford, is an assistant in this both.

C. R. Richards, county agent of Coos county, and his assistant, J. L. Smith of Marsfield, are equally outspoken in their appreciation of the change. Myrtle wood products, white cedar and dairy products are featured in their booth.

Douglas Fruit Fine.

Douglas county shows fine grapes and apples. It is advertised as "the county of diversified crops." Broccoli, a leading product, this year was not available for exhibition as it is now between seasons. One thousand cartons are said to be shipped out from Douglas county this year, according to C. O. Garrett, in charge of the display.

Washington county, another diversified crop section, is featuring a mammoth chaff squash, weighing 125 pounds. Alfalfa is shown conspicuously, the county claiming one acre of Grimm alfalfa for every dairy cow. Fran C. Pluke and O. T. Whorton are in charge of this booth.

Folk county has one of the most interesting displays, showing principally flax. Fine samples of both Blue Dutch fiber flax seed and the straw are in display. Eight to twelve bushels of seed to the acre is claimed, with 700 acres of grain
