SUBSCRIBERS TO LINEN MILL STOCK WANT TO PAY UP

With a number of subscribers to the new Oregon Linen Mills, Inc., coming in and asking permission to pay up their entire stock subscriptions at once and with new subscriptions coming forward voluntarily asking for subscription blanks, things continue to look rosy for a rapid progress toward getting actual work on the mill under way.

The board of directors of the mill have not decided as yet whether or not they will accept subscriptions in full at this time, or only take payments on subscriptions as the board calls for them, inasmuch as the 7 per cent interest on the preferred stock does not commence to run until the stock shares are received there is a desire on the part of some to pay up their entire subscription so that interest payments will start. The board, on the other hand, is not certain just how soon it will need the money and may decide not to accept payments in full now so as to avoid the earlier interest payments.

It is likely the board will hold its next meeting about October 12, or a short time after the first payment of 10 per cent is due to be in on October 15. At that time it will be known just what per cent of the first payment is in, and if the payments are heavy enough it is likely definite action will be taken at once toward selection of a manager leading up to the selection of a site for the mill.

Almsworth won the state high school championship for two consecutive years in addition to the open A. A. U. championship at Portland last year. Harold Carlyle will meet Haddock both candidates for the 145-pound berth on the O. A. C. squad. Haddock has won two years' training and Carlyle three years and a bout full of action and fight is promised.

Powell, 175-pound variety man, will meet Frank Byran, 158-pound variety. Byran is Pacific northwest intercollegiate champion and captain of the O. A. C. variety team, while Powell holds three Pacific A. A. U. championships. Talker against Roberts will furnish the contest between heavyweights.

MILLER, LUX LAND CUT UP

San Francisco, Oct. 8.—The extensive holdings of Miller and Lux, Inc., comprising approximately 800,000 acres of California land, are to be divided and placed under cultivation, a syndicate of bankers announced here. Cultivation and development of the properties, estimated to be worth \$50,000,000, will be brought about through the issuance of \$25,000,000 in bonds during the first part of next week by the syndicate headed by Peirce, Fair & Co. and Blyth, Witter & Co. The Miller and Lux company also own 200,000 acres of uncultivated land in Oregon and Nevada which is to be included in the development plan. Practically all of the properties have remained idle since their acquisition by the late Henry Miller, cattle and land baron, from Spanish grandees during the early days of California.

WANTS DIVORCE BUT SEEKS NO ALIMONY

Mildred E. Hamel, in seeking a divorce from Dewey E. Hamel, charges that her husband used intoxicating liquors excessively for two years, that he had been arrested and lodged in jail for violation of prohibition laws and that he had brought other similar law violators to the house and lodged them there much to her humiliation. She also charges he used physical violence against her and that he was insolent and domineering. She declares that although her husband is an able bodied mechanic, capable of seeking a good living she wants no alimony and wants her maiden name of Winslip restored to her. They were married at Vancouver, Washington, July 6, 1922.

WITNESSES PUT BLAME ON MURRAY

(Continued from Page One) started to run around the corner of the building toward the turnkey's office. Then Murray turned and followed close behind Jones. Crawford said he then shouted "Break!" and ran into his office in the basement portion of the office wing, directly under the warden's office. From there he went back into the dormitory under the turnkey's office. When he entered the dormitory Crawford said he heard scuffling in the turnkey's office just above, closely followed by shots apparently fired in the turnkey's office. Asked how many shots were fired Crawford said he did not know. "There were a lot of them, but I could not say how many," he said.

Runs Up Stairs

Immediately after the firing ceased Crawford ran upstairs and into the turnkey's office where, he said, he found things in general disorder. On the floor were three rifles, a revolver and 50 sixty cartridges, some of them loaded—some empty. The arsenal in the northwest corner of the room was hanging in the door of the arsenal in the northeast corner. "The lower half of the window looking out upon tower No. 1 had been shattered by bullets," Crawford said. From the turnkey's office Crawford said he proceeded to tower No. 1 where he found Guard Wesley lying dead upon the floor just inside the door. On the floor a few feet from him lay a revolver, and to one side was a pool of blood. Crawford was unshaken in his testimony under cross examination. J. S. Murray, chief clerk at the prison, was also on the stand this morning to identify Murray and his companions in the break or regularly committed convicts at the prison. The attempt of the state to establish through him the

fact that Murray had escaped twice previously was related by the defense, and the state abandoned this act for the present.

Warden On Stand. When the noon recess was called Warden A. M. Dalrymple had just taken the stand. The little court room was crowded to its seating capacity this morning and there were several people waiting in the hallway to get in. Among the spectators were Bishop William O. Shepard and Rev. W. W. Youngson, Methodist minister of Portland, who occupied front seats. Murray was more cheerful this morning than at any time during the trial so far. As he passed out of the room between two guards at the noon recess he motioned toward his father and mother in the front seats and smiled broadly, making a gesture of elation.

In keeping with the surprise and thrills which have marked his entire career of crime the defense of Murray did the unexpected again in outlining their case yesterday afternoon. Instead of basing his case upon extenuating circumstances and seeking a verdict less severe than first degree murder, as had been intimated in his opening statements and generally anticipated, King told the jury that he expected to present evidence substantiating an acquittal on the grounds that Murray was so mistreated and persecuted during his confinement in the prison as to place his life in jeopardy, and to justify him in seeking to escape even at the cost of taking human life to secure his liberty.

King in describing to the jury the various degrees of murder and the verdicts they were authorized by law to find, explained that there were extenuating circumstances which, if not justifying acquittal, would amply support a finding of guilt of second degree murder or manslaughter. King submitted that he would prove that Murray and his comrades, Ellsworth Kelley and James Willos, were under the influence of Merawanna, a drug placed within their reach by the prison authorities through negligence, at the time of their break, and that Murray might have been influenced in his past misdeeds by the effects of a blow on the head when he was about 14 years old. He described Murray as the normal son of a good and respected family who had been forced into an unhealthy environment by the war, and who had become a victim of bad associates.

Supporting his contention of justification for the contemplated break and the murder of Guard John Sweeney, which murder the defense refused to admit, King pointed out that Murray had at various times been confined to the "bull pen" for real or imagined offenses against prison rules, that one of the guards over the "bull pen" had a mania for killing and a record of having killed five men, including one prisoner in the "bull pen"; that two shots had been fired into Murray's cell in the "bull pen" by guards without cause or justification, and that convicts confined to the "bull pen" were in constant fear of their lives.

"It was understood among several of the convicts, and the defendant had been so informed that six of them had been marked to be killed upon the slightest provocation," Judge King told the jury. "Simply because there are laws which make it a crime to escape, it does not follow that one is not justified in defending one's self from even an officer of the law to escape death. "There is no evidence here to show that any conspiracy did exist which premeditated killing. Conditions existing at the prison not only inspired but encouraged attempts at escape. The state was negligent in not providing adequate guards against escape. The only shots fired in this break were those necessary to secure their liberty, and not one shot was fired after they got outside the walls."

Examination of witnesses yesterday afternoon was confined to establishing the corpus delicti. The only challenge of evidence offered by the state came when the defense objected to the introduction of a 32-20 bullet identified by Dr. W. Carlton Smith as the bullet taken from the head of Mr. Sweeney, and which the state alleged was fired from the gun carried by Murray. The objection was overruled. Other witnesses examined read:
