

PROSECUTION OF HEILIG ORDERED BY CITY COUNCIL

The Heilig theatre will be prosecuted for erecting its new electric sign without sufficient authority from the city council if instructions given City Attorney Kewitz by Mayor Gleason last night are followed out. Following a lengthy discussion in city council meeting the mayor told the city attorney to prepare the complaint and he would sign it.

The attack on the theatre for putting up the sign without approval from the light committee of the city council was started by Fred A. Williams, chairman of the light committee. Williams declared that the sign weighed a ton and a half and that it is attached to a corner of the building where it is exposed to storms, and that moral and legal responsibility for any injuries that might occur rest on the city.

Williams further stated that the Heilig theatre has failed to comply with the state law in getting the approval of its facilities by the state fire marshal, particularly relative to exits.

"The theatre is crowded every night," said Williams. "My family goes there. And unless it complies with the state law I am going to move that its license to operate be revoked."

Alderman Hal D. Patton sided with Williams, declaring that the theatre's exits are inadequate and that it shouldn't be allowed to operate unless it complies with the law. Patton said he had called the attention of the management to the defect before the remodeling of the building was completed.

After the discussion the mayor said he would entertain a motion to prosecute. No one made the motion, so the mayor instructed the city attorney to draw up the complaint and said he would sign it.

ASSOCIATED CHARITIES NEED OFFICE ROOMS

Mrs. John A. Carson, president of the Associated Charities, appeared before the city council last night and asked the city if possible to provide a building where the organization can be housed this winter.

Mrs. Carson said that two rooms were needed and that it was necessary that they be downstairs rooms, in the central part of the city. She said the headquarters should be made available as soon as possible. A larger expenditure of money will be necessary this winter than last, she said.

The subject was referred to the public buildings committee of the council.

Willamette Football Team of Thirty Years Ago Lines Up for Brief Scrimmage Here Again

Claimed to be one of a very few football teams in the United States of an age with its members all still alive and well, the Willamette university eleven of 1895 appeared on Sweetland Field here Saturday at the time of the Willamette alumni game. The reunion marked the first time the team has been together since it passed through its season of 30 years ago, the first active football season ever staged in Willamette football history.

The two teams, the first and the last, the alumni and the varsity, lined up against each other for a few minutes, following which a younger generation of alumni took the field in a regular game against this year's team.

Hawley One Member

When the team of 1895 posed for its picture it numbered among its members such men as W. C. Hawley, later to become a United States congressman, L. H. Van Winkle, now attorney general for the state of Oregon, and others including nearly every trade and occupation, a mayor of Albany, a school board director at Salem, a tobacco dealer at Eugene, an attorney at Portland, a Y. M. C. A. director at Frankfort, Kentucky, a dairyman near Salem, a physician at Mount Angel, a newspaper editor at Lewiston, Idaho, and others.

The first string consisted of: H. H. Olinger and Rt. (pronounced "Art") Gules, ends. Olinger is now a dentist in Salem, chairman of the school board, and at one time or another holder of honors in the Rotary club, the Elks club, and other organizations. Gules, the fastest man on the '95 team, has moved around considerably since graduation. His home is supposed to be in Woodburn most of the time. He has been postmaster

Others Well Known

Bert Savage and Bert Macy, tackle, Bert Savage and his brother Mark who played in the back-field, are first cousins to Lute Savage, veteran penitentiary guard, who has been in a perilous condition since the historic prison break of August 12, when Lute was shot just below the heart while attempting to stop the convicts. Bert has occupied several positions, including that of city editor of the Lewiston Tribune at Lewiston, Idaho, chief of police, and prominent worker in the state chamber of commerce of Idaho. Macy, the other Bert, is a practicing lawyer in Salem. He has been city attorney here.

John Williams and Don Truitt, guards.

Williams is at present a business man in Eugene. Truitt's whereabouts is not definitely known here. He was last heard from somewhere in Alaska.

Van Winkle Center

J. E. Webb, center, Webb is now a practicing physician in Mt. Angel. L. H. Van Winkle, present state attorney general, played center at the start of the season, but an injury kept him out of the line-up before the season was well advanced. The injury was to his knee, renewing an old hurt sustained when Van Winkle's horse, upon which he was riding while working as deputy county assessor, fell on him the previous summer.

Chester Murphy, quarterback and captain. Murphy is now practicing law in Portland. When the team was first organized he was the only one of the whole squad who had ever seen a football game played, according to the version offered by the veterans.

familarly known as "Baldy." With his head still as innocent of decoration as it was then, Savage is now a salaried man, owning a ranch a few miles south of Salem. He has a residence in this city, living here much of the time, but absolutely denies that he is "retired." Mark Savage has the distinction of being the only player on the '95 team who has sent a child through Willamette. His daughter, Odell Savage, graduated in 1920, later marrying a classmate and becoming Mrs. Merrill Olinger.

Hawley Then President

Fullback, Walter Page. Page is now a Y. M. C. A. director at

Frankfort, Kentucky. Right half, J. McCormick, alternating with Billy Evans. McCormick is a tobacco dealer in Eugene. Evans is manager of the Commercial Book store here.

W. C. Hawley, who was at that time president of Willamette university, worked out with the players, although he did not enter any official games. It was the regular thing in those days, the old veterans explain, for members of a college faculty to suit up and take the field along with the students.

The team was coached by C. R. "Brock" Morse, now sporting editor of the San Francisco Call. I. H. Van Winkle was manager.

There were in the season of 1895 four schools competing for state honors in football. Oregon Agricultural college at Corvallis, came to Salem and played Willamette early in the season, the Salem team disposing of the Aggies by some 20 points to 0. The game was played at the state fair grounds, no regular athletic field then existing on the Willamette campus. Practice was held by the Bearcat aggregation on the spot where Eaton hall is now located.

The state university disposed of Pacific at Forest Grove, leaving Willamette and Oregon to settle the state title between themselves.

Played For Title

The Willamette-Oregon tilt was slated for Thanksgiving day. The story is still told here how a delegation of rooters from Salem went to Eugene on that day, taking the streetcar, then driven by an old white horse, out to the Oregon campus, which was then "away out in the country." An old negro drove the horse, they say, and an altercation of some kind arising between the rooters and the negro, the Willamette delegation piled off the car, lifted it off the tracks, and went on their way to the game.

The game ended 6-0 in favor of Oregon.

Football tactics being less refined then than now, the Oregon authorities had gone over old Kincaid field, where the game was played, with a disc harrow the day before the game, it is said. At any rate, everybody agrees that the field was soft with mud, and the Willamette backs were considerably slowed up. A story told on "Baldy" Savage, which he denies,
