FUNDAMENTALIST TO GIVE SERIES OF LECTURES HERE

The first of a three weeks' series of fundamentalist lectures to be given by Guy Philip Phelps, noted fundamentalist, is scheduled for Monday evening, November 1. The entire series of lectures is to be given in the First Evangelical church of Salem.

New York, Oct. 31—(AP)—Traditional rivalries and colorful inter-collegiate battles today found eastern gridirons largely blanketed with snow.

Uncertainty October thus closed in form. It burst upon eastern football with a gale three weeks ago. Later teams struggled across muddy battle grounds in a drenching rain. Quagmires were general today.

Illinois had hoped for firm footing and fair weather today for its mighty backfield ace, Red Grange, in his efforts to beat undefeated Pennsylvania at Franklin field in the stellar attraction on eastern fields.

Army's undefeated machine underwent a last minute change for the game with Yale at New Haven, Scheffler being sent to the backfield in place of Traphel. Neither team worked out on the snow covered field yesterday. The bad going was regarded as affecting the teams equally.

Columbia, with its best eleven in years, has the possibility of breaking the long list of Cornell triumphs. Gloomy Gil Doble brought here an undefeated team which has piled up an impressive scoring total.

A revamped Brown line, which includes much green timber made necessary by injuries, gave Dartmouth little to fear at Providence. At Princeton a heavy backfield combination was chosen to face Swarthmore as a result of the prospect of a muddy field.
