SAY SITUATION IN DAMASCUS STILL SERIOUS

London, Nov. 2.—(A. P.)—A dispatch to the Evening News from Haifa, Palestine, says the situation in Damascus, where the French recently put down an insurrection, is still critical while the surrounding country is seething. The French authorities are said to be imposing heavy fines on the city.

Owing to the Damascus insurgents' failure to deliver rifles in accordance with the terms laid down by the French, a fine of 10,000 pounds sterling was imposed on Monday.

Of the 3000 rifles demanded, only 1655 were delivered and further fines of 500 pounds must be paid each day until the last rifle is handed in, the correspondent reports.

The French guaranteed there would be no further bombardments, but barbed wire barriers have been erected in the streets to prevent ambushes.

The city is reported quiet, but with strong revolutionary undercurrents. The country to the north, the dispatches say, is in a state of complete revolution. The telephone lines have been cut. Motor cars are held up within three miles of the city and the passenger trains robbed.

Omaha, Neb., Nov. 2.—(AP)—A mother's fight to have her son's sweetheart's divorce set aside, to save herself from being "crowded out of a home" was successful Friday.

The case made two women opposing principals in a divorce action.

Mrs. T. M. Joseph, mother of Thomas Joseph, 30, asked the court to nullify the divorce decree granted last August 31 to Mrs. Alta Christian, who, she said, her son intended to marry, were it upheld.

"They are trying to crowd me out of a home," the mother said. "I never had any trouble with my son until he met this woman." Mrs. Joseph told of many instances of affection displayed between the two. Details of their conduct, before and since the uncontested divorce was granted, led the judge to revoke the decree with the observation that Mrs. Christian "had not played fair with the court."

PERSIANS OUST KAJAR DYNASTY

Teheran, Persia, Nov. 2.—The Mofltes of national assembly, adopted a resolution deposing the Kajar dynasty which has ruled the country since 1779. The vote was 80 out of 85 in favor of deposition.

The resolution says that the ruling dynasty is deposed for the sake of the national welfare and that a temporary government in accordance with constitution and national laws, has been entrusted to the premier, Reza Khan.

The resolution says it is left to the national assembly to decide on a permanent form of government.

ELECTRIC LIGHT USERS HERE ARE ABOVE AVERAGE

Using the customary basis, Salem should have a population of 23,170 if the number of electricity users were the only criterion. However, based on other figures, the population would be about as follows: On increase in water permits, 25,480; on school enrollment, 22,540; on postal receipts, 22,580. These figures prepared by the chamber of commerce, indicate that Salem has a percentage of electricity users considerably above the average of the ordinary American city in proportion to the population.

In 1920, Salem had 5371 electricity users; in 1921, 6037; in 1922, 6899; in 1923, 7491; in 1924, 8319, and in 1925, 9022, with the 10,000 mark to be reached at most any time.

In 1920 about 300 farmers were using electricity and now more than 700 farm homes are lighted from juice drawn from the Salem plant.
