## LOAD LIMITS ON COUNTY ROADS PROMULGATED

The county court today issued an order putting in effect weight limitations on trucks on all unimproved county roads starting November 14 this year and running until May 1, next year.

The weight limitation regulations are identical with those imposed last year, which limit the loads on trucks to 550 pounds the tire inch for wheels on each axle. For instance, if a truck has three six inches in diameter, it is allowed to weigh when loaded under the limitation an amount equal to 357 times 12 inches for both front and back axles.

The county court is advised that virtually all of the counties of the state are getting ready to put on similar weight restrictions in the very near future.

This year a number of lumber camp operators have come into the county court urging an early imposition of the weight restriction.

Last year, during the two weeks time from the issuance of the order to its effective date, heavy rains fell and trucks took full advantage of the situation by pushing out extremely heavy loads over the county roads and cutting them up in many instances so badly as to virtually ruin them for winter use.

Lumber operators, state Judge Hunt, are wailing to the fact that the weight limitations are of great value to them during the winter season.

The lumber and wood hauling trucks are the main offenders on unimproved roads during the winter season. The limitation order does not apply to hard surfaced roads.

## KLAMATH FALLS AND BEND EXPERIENCE SNOW

Klamath Falls, Or., Nov. 2.—A fine dry snow covered the ground in Klamath Falls during the night, but disappeared later in the morning. The snow was reported heavier in the hills surrounding the city, with a brisk snowstorm raging near Pinehurst on the Klamath-Ashtland highway.

## WHITMAN WINS AERIAL ATTACK BESTS BEARCATS

Inability of an inexperienced Willamette backfield to break up the aerial attack of the Whitman college eleven resulted in the fifth successive defeat of the local aggers to an effective date, heavy rains fell and trucks took full advantage of the situation by pushing out extremely heavy loads over the county roads and cutting them up in many instances so badly as to virtually ruin them for winter use.

The game, which was held at the Whitman stadium, was a hard fought one. The Bearcats, unloading a series of delayed cross backs, carried the ball some 40 yards. Flukes were numerous, the first one occurring when Rhodes of the Whitman line, through the Whitman line, grabbed a wild ball and ran 40 yards for a touchdown. The score, which was the first of the game, occurred early in the third quarter and was followed soon after by a run made by Whitman back through the Willamette line and 60 yards for a touchdown. The goal for extra points was missed in both cases.

The Missionary offense took on a more aerial aspect in the fourth quarter than at any other period of the game. Early in the canto two long passes brought the ball to the Bearcat one yard line, from where it was bucked across in three plays. Successfully converting a goal, the Missionaries led 13-0.

A few minutes later a Missionary broke away on a long pass, ran half the length of the field and was nailed on the Bearcat 5-yard line by Reidell, who was playing safely. A line plunge lost one yard, but on the following play the Missionaries, using a cross-back for the only time of the game sent a back romping around right end across the line. The kick was successful.

With the count standing 20-0, Whitman continuing its over-head offense, a forward pass was finally intercepted by a Willamette back, giving the Bearcats the ball on the Missionary 35-yard line.

A long pass by Reidell, which was one of the features of the game, netted 23 yards, although Mumford was stopped practically in his tracks after catching it. Reidell ran back some 10 yards before making the pass, and caught the ball far enough behind the line before running back to make the total length of the pass approximately 40 yards.

A moment later Reidell made another pass, this time to Swelling, who dashed across the line with it. Stolchewitz kicked goal, making the count 20 to 13. With the time practically expired, the Bearcats were unable to score again.

## LACK OF RAIN IN OCTOBER NEARS LOCAL RECORD

With the exception of October in the years 1885 and 1917, the month which closed last Saturday was the driest October ever recorded since official government observations were first taken here 33 years ago. Exactly 93 of an inch of rain fell in Salem during October of this year. October, 1924, saw a total rainfall of 8.31 inches, or exactly 277 times as much as the precipitation during the past month. Official government statistics place the normal amount of rainfall for October at 2.55 inches.

In 1895 and in 1917 October was absolutely dry. Other years that stand out in the record for dry Octobers are 1907, with 50 of an inch of moisture, and 1911, with 31 of an inch. An examination of the records reveals the fact that these years, 1895, 1907, 1911, 1917 and 1925, are the only years on record when there was less than a full inch of rain during the month of October. Rainfall for October in the past few years has been as follows: 1920, 5.91; 1921, 3.96; 1922, 4.21; 1923, 2.21; 1924, 8.31.

Rainfall during September of this year was 1.73. With two months, November and December, of the year 1925 yet to go, the total record of rainfall for the year stands at 24.27 inches.

During the past month the Willamette river fell from exactly two feet below normal to 2.5 feet below normal, the lowest point to which the level of the river has fallen during the year. The drop has been one of the slowest and most gradual on record.

commanding general or commanding officer, or a member of his staff, or a member of the army or navy organization as a whole.
