

REGULATIONS ON CHRISTMAS MAIL ARE DISTRIBUTED

There will be no delivery of mail on Christmas day this year, according to announcement made by local post office authorities yesterday. In connection with Christmas announcements instructions having to do with wrapping and mailing of Christmas packages have been issued. Pasteboard hat boxes and similar packages should be crated. Articles easily damaged should be marked "fragile." Cut flowers, candles, pictures, and other things subject to injury should be appropriately wrapped, the flowers being wrapped with tissue to preserve their moisture.

Postage must be fully prepaid on all mail.

No parcel may be more than 24 inches in length and nine combined. For delivery in Salem and in the first, second and third zones, 70 pounds is the maximum weight. In all other zones 50 pounds.

Uninsured parcels 8 ounces or less in weight may be mailed in street letter or package boxes. Parcels weighing over 8 ounces cannot be mailed in street boxes, but must be taken to the city post office to be mailed.

Christmas gifts and cards addressed to within one day's travel of Salem should be mailed not later than Dec. 29. Within two days' travel mailing should be made not later than Dec. 18. Within three days' travel the date set is Dec. 15. For more distant points, packages and cards should be placed in the mail not later than Dec. 14.

Packages, as usual, may be marked "please do not open until Christmas." If other messages are placed on the packages they will not be available.

Parcel post and third class mail matter may be sent C. O. D. from Salem to any other money order post office.

TO TEACH WOMEN TO USE LIPSTICK

Berlin, Nov. 26.—(AP)—The real art of applying lipstick, rouge, powder, puff and eyebrow pencil soon will be taught to the Berlin maidens at fifty cents per lesson. The scope of a school for training theatrical make-up artists has been extended to embrace the women in the capital. The theory is that more users of cosmetics are to be seen on the streets than on the stage, and the make-up of some of them is not always highly artistic.

Ernst Lotz, for twenty years facial art director of the municipal theater at Nuremberg, will be director of the new institution. Visited in his studio, Lotz was showing a woman how, by skillful application of cosmetics, she could reduce the apparent size of her nose. He decided what he terms the promiscuous manner in which flappers, and especially elderly women, debase themselves with paint and powder. In the majority of cases he said, they defeat the very object for which cosmetics are applied.

MOST COLLEGES FROWNING UPON GIRL SMOKERS

New York, Nov. 26.—(A. P.)—Apparently smoking is frowned upon by most of the large eastern girls' colleges.

Disagreeing with Bryn Mawr, which recently set aside a smoking room in each dormitory, several other colleges have either forbidden smoking outright or deferred action on the matter. At some colleges there are no restrictions, but the habit is discouraged. Goucher college at Baltimore about a month ago forbade students to smoke in college buildings or public places.

At Wellesley a proposal that smoking be permitted on the campus was defeated last week. The practice is forbidden at the college.

Radcliffe and West Virginia forbid smoking.

At Vassar the habit is a matter of the individual's conscience, but the rules disapprove it as injurious to the health. The students, however, have voted against outright prohibition.

Nearly half the girls at Vassar have admitted they smoke. At Barnard smoking has never been forbidden. Last week by a vote of 448 to 442 Mount Holyoke girls voted for smokes. The Massachusetts Institute of Technology, co-educational, has permitted students to smoke at undergraduate social affairs.

John Bull has lifted his eyes in surprise over Bryn Mawr's action. London papers have published the news as a curiosity. The London county council, with 26,000 women in its classes, permits smoking and so does the University of London, where thousands of women students have their own clubs where they smoke.

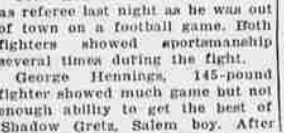
LEWIS IS GIVEN DECISION OVER GEO. INGERSOLL

BRUNSWICK Makes New Instrument

The "Panatrop" a New Competitor In Phonograph Field Will be placed on market in December

The new sound reproducing musical instrument developed by the Brunswick-Balke-Collander Co., in conjunction with General Electric Co., Radio Corp. and Westinghouse Electric Co., known as the Panatrop, has many features among which is compactness and economy of operation. It can be run either with batteries or from any electric light socket at a cost less than operating a small electric fan. It's vacuum tubes last from three to five years. Prices of the instruments, to be placed on the market in December, will run from \$325 to \$600, depending on the style of the cabinet.

Because of the use of the tubes for amplification, the original vibrations from the record might be definitely faint, so that only the lightest possible contact is necessary between the needle and the record thus reducing the wear on the needle and the record to a minimum.

While the phonograph is limited to reproducing sound-waves roughly between 1000 and 2000 per second this instrument reproduces sound-waves anywhere from 100 to 7000 or 8000 a second.
