bor in war time."

Major Jarvis J. Bain, general staff officer and assistant umpire of the Hawaiian maneuvers was questioned regarding the defense project of Oahu. He testified it had been in existence several years and that it included a scheme for "clearing for enemy sympathizers" and the taking of other precautions to assure the security of that island in war.

Unity of command of the defending Hawaiian forces, Major Bain said, was not contemplated "by those who drew up the plan."

The general plan for cooperation between army and navy commands, he said, was "not satisfactory" and has been under revision for about nine months. This plan would fix the responsibility of command in emergency according to the paramount interests prevailing between the army and navy. The paramount interest during the maneuvers was with the army, he added.

"Should the navy have cooperated with the army under the paramount interest plan?" he was asked.

"Yes, sir."

"Did they?"

"No, sir."

"By making differences in the tactical organization of the land forces and holding combined tests in time of peace."

The army, the general said, was organized primarily for duty on land, the navy for duty on water, and "they overlapped at the shore line."

"An additional service which overlapped both of them," he said, referred to Colonel Mitchell's proposal for a separate air service, "would make co-ordination absolutely impossible."

The general pronounced the Hawaiian maneuvers a "success," except that they had to be curtailed on the ground of economy.

Many high army and navy officers are on the prosecution's list, and their examination is expected to run over a period of weeks.

Representative Frank R. Held of Illinois, chief defense counsel, asked for what purpose General Ellinger's testimony was offered and Colonel Sherman Moreland, the judge advocate, replied:

"The evidence is offered for the purpose of rebutting whatever evidence the accused thinks he has offered as a defense."

# STUDENTS TAKE HOLIDAY TODAY

Lincoln, Neb., Nov. 27.—(AP)—Students of the University of Nebraska celebrated yesterday's football victory over Notre Dame with a football holiday today, which was officially declared after thousands of cheering students disrupted classes, forcing instructors out of the class rooms.

School was dismissed Thursday in observance of Thanksgiving day but orders had been given by university authorities that classes would be held as usual today.

Students, having called their celebration well into the night and morning, gathered in front of one of the larger class buildings instead of attending classes and the rally became more enthusiastic. A snake dance and parade were held in the various halls.

# OREGON UPSETS DOPE AND GIVES HUSKIES SCARE

Seattle, Wash., Nov. 27.—The purple tornado of the University of Washington today adorns the football throne of the Pacific coast, as the result of the defeat yesterday of the University of Oregon 15 to 14.

The Oregon eleven entered the game doped to lose by a wide margin, but upset the dope and almost upset Washington's drive for the coast conference title by putting up its best game of the season.

Washington tallied a touchdown in the opening period, but failed to convert for the extra point. Each team scored a touchdown in the second period, the third was scoreless, and the fourth quarter started with the score 12 to 7 for Washington.

Oregon then split the Purple tornado wide open with a dazzling aerial attack, carrying the ball from her 20 yard line across the Huskies' goal.

The Webfooters converted, making the score 14 to 12 to Oregon. Washington then took the ball and started a furious drive down the field which ended in a field goal and defeat for the fighting Oregonians.

Fate decided the issue on that field goal, for the ball, leaving the line of Shilder, whom Coach Hagshaw had sent in to kick, struck one of the goal posts uprights, dropped onto the crossbar, wavered, then dropped inside.

Late in the period Oregon began a drive for another score. Throwing caution to the winds, the Oregonians hurled pass after pass, and the very daring of the attack took the ball to Washington's ten yard line.
