

In compliance with the provisions of Chapter 118, General Laws of Oregon for 1921, and all subsequent amendments thereto, notice is hereby given that the County Court of Marion County, Oregon, will be in session at the Court House in the City of Salem, Oregon, in the court room thereof, on the 30th day of November, 1925, at the hour of 10 o'clock in the forenoon of said day, at which time and place opportunity for a full and complete discussion of the estimates of the amount of money proposed to be raised by taxation for the ensuing year will be given and taxpayers subject to such tax levy when made to be heard in favor of or against any proposed tax levies.
