HAIR KEPT BLOOD FROM SPATTERING

Wounds Were on Skull
and Forehead—Objections
Overruled

Seattle, Wash., Aug. 12.—(AP)—New charges against Wallace Gaines based on testimony of his relationship with his daughter, Sylvia, will be filed if Gaines is found not guilty of murdering the girl at the completion of a trial in progress here, Prosecutor Colvin announced today.

Chief Deputy Coroner Jones testified that blows on the side of the girl's head were made after she had been choked into unconsciousness, that the choking in all probability would have caused her death, lessening the flow of blood.

Seattle, Wash., Aug. 12.—(AP)—After a fight by the defense, enlarged photographs of the body of Sylvia Gaines were admitted as evidence here today in the trial of her father, Wallace Gaines, as her slayer.

Prosecutor Colvin declared the photographs relevant as showing by the situation of wounds how unlikely it was that the clothing of the person who beat and choked her to death beside Green lake here the night of June 16 would have much blood on his clothing.

"The enlargements are unnecessary to show the wounds, and are objectionable because of their gruesomeness," replied Defense Counsel Carney.

"We shall show," argued Colvin, "that the wounds were on the skull and on the forehead near the hair. The hair formed a sort of screen and kept the blood from spattering."

Resumption of testimony in the trial was delayed until 10:30 a. m. today to permit Prosecutor Colvin to question state witnesses before they took the stand. Louis Stern, former companion of Gaines, was to be removed from the King county stockade where he has been held since relating a "confession" of Gaines to the county-city building, so he could testify when wanted.

GROOM OF 91 GETS DIVORCE FROM BRIDE, 73

Portland, Or., Aug. 12.—(AP)—C. A. Wallace, 91, an Indian war veteran, was granted a divorce today from his bride, aged 73, whom he married last May. He charged her distasteful nature ruined their life.

Wallace is the father-in-law of State Treasurer Tom Kay and Mrs. Kay was the corroborating witness. Wallace was one of five Indian war veterans who attended the most recent reunion here. He introduced Mrs. Wallace to his fellow veterans at that time.

The marriage of the aged Mr. Wallace to the Portland woman came as a surprise to the relatives in Salem and in Portland. Before the marriage Mr. Wallace was living with a daughter in Portland. The relatives expressed the opinion that an ulterior motive of the woman was to get possession of Mr. Wallace's property and attorneys were consulted as to the possibility of having the marriage annulled.

CRUSHED BY WHEELS OF A DIRT TRUCK

Klamath Falls, Ore., Aug. 12.—(AP)—Struck by a loaded dirt truck backing into a railroad trestle, William Foley, dump boss for the March Construction company of Spokane, Wash., died instantly when crushed beneath the wheels shortly before noon today. He is said to be survived by a wife in Spokane. There were no witnesses to the accident.

Foley was lying dead beneath a rear wheel when noticed by E. W. Anderson, driver of the truck, whose attention was called to the accident by the sound of a breaking shovel handle, which Foley had been carrying when struck.

Army of White Ants Eat City Records of Pasadena;

Attack Wooden Buildings

Pasadena, Cal., Aug. 12.—(AP)—An army of white ants are engaged in a vigorous offensive against the crown city.

Wooden structures have been attacked to such serious extent that Walter Putnam, chief building inspector, has undertaken an exhaustive survey of all wooden structures in Pasadena.

Discovery of the invasions of the ghost army was made last week when it was found that a large number of municipal records had been literally devoured by the insects in the basement of the city hall. Further investigation into woodwork of buildings under repair or being moved revealed astounding conditions, Putnam reported.

Of 25 varying types of structures examined in the last few days, the inspector said 24 showed evidence of having been attacked by the

ants. In one instance, he declared, a large roof over a public garage would have collapsed within a few months if the menace had not been discovered in time.

Putnam declared the situation was far more serious than at first believed. The ants will destroy an entire wood structure if given sufficient time, he said, threatening every wood building in Pasadena with collapse.

"A thorough survey of actual conditions throughout the city is our first step in combating the problem," Putnam said, "for with our present information we cannot tell at what moment the first building may collapse."

Putnam believes that ant invasion which probably has become serious only in Pasadena, exists to some degree over all southern California.

CRIME LAID TO RELATIVES OF WIDOW HALL

Cousin and Brother Accused of Murder of Rector, Sweetheart

SOIL ANALYSIS ESTABLISHES PLACE

Couple Slain Under Tree Where Bodies Found—Admits Taking Bribe

Somerville, N. J., Aug. 12.—(AP)—A cousin and a brother of Mrs. Edward Wheeler Hall were in jail today, held without bail, accused with her of the murder four years ago of her clergyman husband and his sweetheart, Mrs. Eleanor Mills.

"Crazy" Willie Stevens, the brother, and Henry Carpenter, wealthy cousin of the wealthy widow, were arrested last night, two weeks after the arrest of Mrs. Hall, now at liberty in \$15,000 bail.

All three have pleaded not guilty. State Senator Simpson, special prosecutor, however, says "we have established a case nothing can destroy."

A chemical analysis of blooded soil, he declared, has established the fact that Dr. Hall and Mrs. Mills were slain under the crab apple tree on a deserted farm where their bodies were found. It had been suggested they were killed

CHURCH GOING DENIED WIFE

"Only damn fools go to church," Arthur Wilson is said to have told his wife, Eliza M. Wilson, according to a complaint for divorce she has filed in circuit court. She says he refused to allow her to go to church.

MONEY RULES OVER POLITICS STATES BORAH

Expenditures in Elections Likely to Destroy Government of People

REPUBLICANS IN SOUTH CORRUPT

Delegates Controlled and Managed by Shameless Use of Patronage

Pocatello, Idaho, Aug. 12.—(AP)—Senator William E. Borah, in his speech at the annual Pioneer Day celebration at Camas Prairie here today, declared that "staggering revelations as to the expenditures in money in elections" reveals "money power in American politics."

He expressed the wish that the exposure of "money in politics" will "succeed in arousing the people to the real problem before us" in praising the work of Senator James A. Reed, democrat, Missouri and his special investigating committee. "The senator decried 'political patronage' and in citing an example said that 'the republican organization of the south is held together and sustained by the worst kind of corruption.'"

Senator Borah stressed principally "the arousing of the people to the necessity of dealing with the money power."

Boston, Mass., Aug. 12.—(AP)—Lady Astor came to Boston to go to church. After eluding reporters during her flying visit from Dark Harbor, Me., three days ago she was cornered by a lone news writer as she boarded the steamship Camden for the return trip last night.

"You're perfect nuisances and I have always thought, quite unbecomingly, that you were here to get away from me," she said to the news writer.

"I came down here to go to church and not to be interviewed. It would not look very nice now, would it, to pay my long anticipated visit to the mother church with 400 or 500 reporters and cameramen hounding my trail?"

Lady Astor added she had long wanted to attend a service at the mother church of the Christian Science faith, which she embraced several years ago, she slipped from the Gibson summer home in time for the testimonial service Wednesday.

BUSINESS GOOD STATES HOOVER

Paul Smith's, N. Y., Aug. 12.—(AP)—The general business condition of the country is even stronger than it has been in the past, Secretary Hoover of the department of commerce, informed President Coolidge today. The only places where there have been lags, the secretary said, are in the agricultural, the textile industry and to some extent bituminous coal.

Otherwise industry is in better shape, he added, than at any other time.

Agricultural prices are improving in some commodities, he continued, while the volume of construction is 15 per cent better than last year.

Tipton, Iowa, Aug. 12.—(AP)—Herman E. Shipley, former chauffeur for Jackie Coogan, who committed suicide near Los Angeles yesterday left an estate of about \$100,000.

Shipley served in the Canadian army for a time during the world war. He later joined the American army, from which he deserted and was imprisoned at Camp Dodge.

\$100,000 ESTATE LEFT BY SUICIDE

Mexico City, Aug. 12.—(AP)—The department of war today denied the assertion of Archbishop Leopoldo Ruiz Flores of the state of Michoacan that two priests had been executed by Mexican federal forces in the town of Zahuayo, Michoacan, in connection with the religious controversy.

The statement said there had been no executions of priests anywhere in Mexico. It also minimized the reports of clashes between Catholics and soldiers in the states of Michoacan and Guanajuato.

Harry Wills Ready To Fight Dempsey Without Any Purse

New York, Aug. 12.—(AP)—Harry Wills told the New York Sun today that he is ready to fight Jack Dempsey for nothing, just for the satisfaction of knocking out the champion.

The negro, who has vainly sought a match with Dempsey for nearly six years, joined his manager, Padellino, in calling the champion a "liar," for his assertions that he tried to make the match.

"I've been reading in the papers that Dempsey says he tried to get me in the ring for the last five years," Wills is quoted as saying by the Sun. "He's a liar."

"If he keeps on fussing around with that sort of stuff, he won't have to wait until he gets me in the ring. He can fight me in the street."

"I'll fight Dempsey any time he wants to meet me at Broadway and Forty Second street, and I don't want a penny to fight him either. I'll knock him out so quick he'll be sorry he was ever born."

WHITTEMORE BANDIT LEADER PAYS PENALTY

Baltimore, Md., Aug. 12.—(AP)—Richard Reese Whittemore, leader of a bandit gang that set loose a goal of a billion dollars loot, died on the gallows shortly after midnight this morning in the penitentiary where he slew a guard in escaping a year and a half ago.

The end came quickly for the youthful criminal who led his followers to robbery of nearly \$1,000,000 of the fabulous sum they sought. At midnight he said: "I wish to say good-bye, the best I could wish anybody." At 12:05, eastern time, his body plunged through the gallows trap of the Maryland penitentiary. At 12:22, 14 minutes later, he was pronounced dead.

Less than 20 minutes had elapsed after he stepped onto the scaffold platform at 12:05 when his body, in its casket, was wheeled out of the death chamber. It was claimed by relatives for funeral services at the home of his father, Rawlings V. Whittemore.

The elder Whittemore and Mrs. Margaret Whittemore, the slayer's wife, bade him farewell several hours before the execution. Mrs. Whittemore was weeping hysterically as she left the prison for the last time, but Whittemore appeared unshaken and remained so to the end.

Whittemore, serving a 15-year sentence for burglary, fatally beat Robert H. Holtman, a 60-year-old guard, with an iron bar on February 20, 1925, and walked out of the hospital gate of the penitentiary. He was hanged within a few yards of the spot where the guard was struck down.

SUBPOENAS FOR AIMEE AND ASA

Los Angeles, Cal., Aug. 12.—(AP)—Aimee Semple McPherson, Angelus temple pastor, and District Attorney Asa Keys, were subpoenaed today as defense witnesses in the trial set for August 23 in municipal court of four news vendors charged with selling indecent literature. Attorney Milton Gold announced that Mrs. Minnie Kennedy, mother of the evangelist, Miss Emma Schaeffer, secretary and Deputy District Attorney Joe Ryan would also probably be called for defense.

The four men, Sam J. Steinberg, Harry Smith, John C. Brooks and Manuel Goodman, are accused of having sold copies of a San Diego newspaper containing an extremely frank discussion of Mrs. McPherson's disappearance here last May and purporting to account for her whereabouts during her 35 days absence from her temple here.

STORM CRIPPLES GOTHAM TRAFFIC

New York, Aug. 12.—(AP)—Underground transit and communication lines in New York remained crippled this afternoon from the flooding of tunnels and sewers by yesterday's downpour of rain.

An army of workmen was engaged throughout the metropolitan area in repairing the ravages of the subterranean floods, in an attempt to save millions of New Yorkers from a repetition of their experiences last night, when hundreds were marooned for hours in stalled trains.

This afternoon only one of the four East River tunnels of the Long Island railroad, hardest hit of all the local transit lines, had been cleared of water sufficiently for the movement of trains.

The Union street sewer, emptying into the river directly under the railroad bridge, was extended out a number of years ago, only to have the extension undermined with the result that it fell several feet causing a break in the pipe. About four years ago city authorities, instead of building a new extension, repaired the break in the pipe with concrete. The sewer still remains as repaired, having given no further trouble since that time.

The city sewer at Center street has been repaired before, only to have the lower end of the pipe line washed out during the winter, according to Giesey, who declares that some means of taking care of the situation permanently should be found. The end of the sewer at the present time is at a point about a yard from the water's edge, the sewage flowing absolutely exposed to the air, from there down to the river and floating slowly away on the surface of the water. The Center street sewer drains the entire southern part of Salem.

The state sewer is declared by nearby residents to be practically no better than the city sewer, despite the fact that the state line was extended some three or four yards this week. It now comes exactly to the water's edge, a short distance north of the city's line.

AIRWAYS TO CONNECT ALL BIG CENTERS

President Has Approved Trans-continental and Southwestern Routes

FULL SERVICES IN NEXT SIX MONTHS

Inaugurates Beginning of Civilian and Commercial Aviation in Nation

Paul Smith's, New York, Aug. 12.—(AP)—A transcontinental and a southwestern airway were approved today by President Coolidge as the first two commercial routes laid down by the department of commerce in its development of civilian aviation.

The transcontinental route as approved in conference with Secretary Hoover of the department of commerce will run from New York to Cleveland, Chicago, Iowa City, Des Moines, Omaha, North Platte, Cheyenne and Salt Lake City from where there will be one leg to San Francisco and another to Los Angeles.

The southwestern route will run from Chicago to Dallas and Fort Worth, Texas by way of Moline, St. Joseph, Kansas, Wichita, Oklahoma City and Tulsa.

The routes will represent extensions or consolidations of present lines and will mark the actual beginning of a nation-wide system, which in the opinion of Mr. Hoover will develop into a privately operated air service on a large scale.

It appears probable, Mr. Hoover added, that within six months there will be a full passenger, express and mail service on the routes approved today.

Ann Arbor, Mich., Aug. 12.—(AP)—Drastic limitations of the use of automobiles by students at the University of Michigan will go into effect at the beginning of the fall term, it was revealed in letters mailed out today to parents and guardians of students entered in the school.

The regulations prohibit the ownership or operation of cars by students entering the university this year as freshmen. At the beginning of the second semester the regulations are to be extended to include sophomores.

The city sewer at Center street has been repaired before, only to have the lower end of the pipe line washed out during the winter, according to Giesey, who declares that some means of taking care of the situation permanently should be found. The end of the sewer at the present time is at a point about a yard from the water's edge, the sewage flowing absolutely exposed to the air, from there down to the river and floating slowly away on the surface of the water. The Center street sewer drains the entire southern part
