## HOTEL OF 150 ROOMS HERE PATTON PLAN

Tentative Scheme Con-  
templated Five-Story  
Building on Court St.

Dean Agrees to Lease  
And Operate \$350,000  
Plant for 15 years

An up-to-date, five-story hotel, to be known as Capitol View hotel, and representing an initial cost of \$350,000, will rise on the Patton property at Court and Summer streets if tentative plans announced today are worked out to completion. The tentative plans were made known in detail today by Hal D. Patton, Mr. Patton and his brother, E. Cook Patton, are owners of the property and for many years have made it their home.

Erection of the new hotel will necessitate the raising of the old Patton home property. W. M. Dean, hotel man of San Francisco, who operates several hostleries in the bay district, proposes to lease the hotel and operate it. Mr. Dean with his wife and daughter have been here for several days as guests of Mr. and Mrs. Hal D. Patton. They left for San Francisco today, but Mr. Dean is to return in a few days after making financial arrangements with his bankers in San Francisco to go ahead with the project.

## HOOVER SEEKS INFORMATION ABOUT MOTHER

Northwood, Ia., July 21 (AP)—In a letter to an Iowa woman Herbert Hoover has asked:

"Please write and tell me all you can remember about my mother."

The request was received by Mrs. L. S. Butler, mother of a Chicago attorney, Rush C. Butler, and a schoolmate of the candidate's mother, Hulda Minthorn Hoover. It was in reply to a note of congratulation sent after the Kansas City convention.

Mrs. Butler, when Julia Ann Pickering, and Hulda Minthorn were classmates in a school taught by Joel and Hannah Bean near West Branch, Iowa, where the republican candidate was born. Raised in nearby Quaker communities, the women became close friends during the two years they attended the school.

Miss Minthorn later married an older student at the school, Jesse Hoover, remembered as "a quiet, good boy," by Mrs. Butler.

Hoover's father was the blacksmith at the Quaker village of West Branch. His mother became an authorized preacher in the society of Friends.

Death ended Mrs. Hoover's work when Herbert was but ten years old. His father had died a few years earlier.

Mrs. Butler planned to go to West Branch when Mr. Hoover visits there on his return from California.

## GOOD EVENING SIPS FOR SUPPER

We are advised that Carlie Logan, aircraft editor of the Capital Journal, contemplates trying to break an altitude record Sunday from the local field. We understand Carlie hopes to beat 15,000 feet, and will wear a heavy flannel shirt, a heavy weight sweater and a leather flying jacket as well.

To one of Carlie's dimensions this padding may be enough to alleviate the jolt a man might get by dropping from the peak of a 15,000 feet flight. If we had to substitute for Carlie, however, we would add to our equipment a pair of large over-stuffed mattresses, one over our lumber region at the rear and the other over our supper region in front.

If we were called upon to make a possible unexpected descent from a distance of 15,000 feet at the rate of six miles a minute or more, we would be loathe to depend upon the shock absorbing possibilities of a heavy flannel shirt, a leather jacket and even a heavy sweater, regardless of the fact that we might drop in the soft onion loam of Lake Labish.

Perhaps Carlie estimates if he must drop 15,000 feet he will drop standing straight up and down and because of his general build and contour stick into the ground like a toothpick when he lands and absorb the shock in that manner. If such is his plan we recommend he slip an extra pair of such supports in his shoes to sort of smooth the little jerk with which we know he would slip under such conditions.

Personally, if we were in Carlie's place, after we had donned our flannel shirt, heavy sweater and leather jacket, we would slip on a pair of tennis shoes and start running in the opposite direction from the airfield as fast as our little feet would carry us. Carlie may be interested in the case 15,000 feet hitherward. But as for us we care not how the altitude.

Regardless of what happens we think it inconsiderate of Carlie to spoil our Sunday by making us worry all the time as to whether he will drop onto the soft, yielding blacktop of the Pacific highway or the tougher and more resistant concrete of Jefferson way.

If he finds out he must drop on this flight, we hope he makes up his mind to do so before he reaches the full 15,000 feet and start off by dropping at about 11,000 feet this Sunday, 12,000 feet the next and so on, so that by the time he has to drop the full 15,000 feet he will become inured to it and be able to take it blandly and as a matter of course.

## HIGH STREET TO BE CITY'S WHITE WAY

Cluster Light from Trade  
to New Bridge Planned  
by Owners

Approval Given Proposal  
to Cost in Neighbor-  
hood of \$25,000

Plans for the installation of cluster lights on High street from Trade to the proposed new bridge were definitely decided on at a meeting of the High street business property owners last night. The system of cluster lights as planned is estimated to cost from \$20,000 to \$30,000.

It was decided to rush the installation, and the desire is that the contract be let simultaneously with the contract for the bridge. One important change in the plans will make High street a really scenic avenue, and is a distinct improvement over the plans as first announced. At first it was planned to have the cluster lighting system extend only from Trade to Center streets, but the new plan is to have it extend from Trade to the new bridge.

The clusters will run six to the block, three on each side of the street. The burden of the expense will be born by the approximately 30 business property owners on the street, but it is hoped that some of the residence owners can be persuaded to help. Also it is expected that the county will contribute its proportion.

## HERDER SOUGHT IN WASHINGTON FOLLOWING TIP

Portland, Ore., July 21 (AP)—Search for William Herder, 26, in connection with the Willows Creek, Cal., postoffice robbery and killing of a deputy sheriff, shifted to Washington today when information was received from Goldendale that a man answering Herder's description had been seen near there yesterday.

Sheriff Hurlburt was advised by telephone today that Herder was recognized by a Spokane, Portland & Seattle railway agent late yesterday on an east-bound train. Goldendale officers said the agent was positive of his identification.

Local officers were in touch with railroad agents, and all trains along the line to Spokane were being watched.

Police and sheriff's deputies for 30 hours have maintained a dragnet around Portland, and many of the officers expressed the opinion that Herder was still hiding in Portland.

## HOOVER WILL START DRIVE ON AUGUST 21

Republican Nominee Will  
Open Campaign, Iowa,  
Says Good

Plans for Quiet Week-end  
Broken to Engage in  
Conferences

Chicago, July 21 (AP)—Herbert Hoover will open his western campaign at a native son celebration at his birthplace, West Branch, Iowa, on August 21, his campaign manager has decided.

James W. Good, western manager, made the announcement after a conference here with a committee from West Branch.

Stanford University, Cal., July 21—Abandoning his original plans for a quiet week-end at his home here, Herbert Hoover today began a series of political conferences which will be continued intermittently until the time of his notification on August 11.

Governor C. C. Young of California was invited to luncheon and for a discussion afterwards in Mr. Hoover's study.

During the early days of next week Mr. Hoover will confer with Senator Hiram Johnson and leaders from other Pacific coast states.

Mr. Hoover will spend Sunday quietly at home, but will attend church services, most likely in the beautiful chapel at Stanford university.

Between times, the nominee will work on his acceptance address. Mr. Hoover usually writes and re-writes his papers and speeches several times.

After the speech is ready for the printer, the republican standard bearer will take to the hills, at some point in his home state, for several days of rest and fishing.

While he has benefited by the trip across the continent, the commerce secretary has had many months of hard work with scarcely a break, and he feels both the desire and the need for a brief vacation.

## GIRL FROM FARM NEAR HERE THOT MOTHER OF BABE

Portland, Ore., July 21 (AP)—What police considered a definite clue to a parent of the six-week-old boy found naked in a fern thicket south of Oregon City was offered today by P. A. Bauman, proprietor of an electric store.

Bauman said he recognized the infant in a picture as the baby carried into his store Thursday by a heavy-set girl of about 15 years and a slender, elderly woman. Bauman and a clerk, Miss Margaret Donbrow, obtained information which they indicated the girl was the infant's mother and the other woman the grandmother. The elder woman used the telephone to call a children's bureau.

"I have too many children and want to get the baby into a home," Miss Donbrow quoted one of the women as saying. The girl was apparently caring for the child. The woman was unable to reach the person she sought by telephone, Bauman said.

## PRESBYTERIANS TO DEDICATE NEW \$125,000 CHURCH SUNDAY

Man's regard for his diety has been expressed since the earliest days of civilization, by architecture and the design of his place of worship and the Presbyterians of Salem have completed final plans for the dedication of their new 125,000 church at Winter and Chemeketa streets Sunday with three special services. The First Presbyterian church organization of today is the outgrowth of the United Presbyterian mission formed May 15, 1869, with Rev. T. J. Wilson and his bride, of Pennsylvania, the first minister. ## DESPONDENCY HELD CAUSE OF GIRL'S SUICIDE

New York, July 21 (AP)—Despondency over her failure at a literary career was the motive accepted by police today for the apparent suicide of Miss Virginia Drew, literary protégée of Maxwell Bodenheim, poet and author.

Miss Drew's body was found floating in the Hudson river Thursday afternoon. She was last seen leaving Bodenheim's apartment early Monday. Bodenheim has not been located since early Tuesday morning. Police said, however, that they were not searching for him, and considered the case closed with the medical examiner's verdict of suicide.

The girl's relatives, however, are unsatisfied with the police theory and the explanation advanced by an artist friend that Miss Drew killed herself in carrying out a suicide pact "with a prominent novelist" who believed with her in reincarnation. They believe she was thrown into the river to drown.

The friend, Caroline Novotny, told police Miss Drew telephoned her last week and said that the prominent novelist, whose name she did not divulge, had "cut her to the heart" with his criticism of her work. "Miss Drew then told me," Miss Novotny said, "that he, too, was a believer in reincarnation and that they had made a suicide pact."

## WEST SELECTED FOR WORK'S JOB

Superior, Wis., July 21 (AP)—President Coolidge has filled one of the cabinet vacancies growing out of the presidential campaign, by appointing Roy O. West of Chicago as secretary of interior. The appointment takes effect immediately.

West succeeds Dr. Hubert Work, who resigned from the cabinet to devote himself to Herbert Hoover's republican presidential candidacy as chairman of the republican national committee.

Another cabinet vacancy created by the campaign was Hoover's resignation as secretary of commerce. Although Mr. Coolidge is known to be giving considerable attention to the matter of a successor to Hoover, no indication has been given as to when the appointment will be made.

## Poor Saxophone Artists Warned To Avoid Africa

Chicago, July 21 (AP)—Musicians in general and saxophone players in particular, whose harmony is not of the best, should avoid West Africa in concert tours.

Slitting the mouth of musicians faulty in this regard is a favorite practice among savages in the Cameroon country, West Africa, said Wilfrid D. Hamby, assistant curator of African ethnology at Field Museum, who yesterday set up a new exhibit of large wooden drums from Cameroon.

Other African methods of punishing the musician who produces displeasing sounds, Mr. Hamby said, were slicing off his ears or chopping off his hands.

But the saxophone is unknown in African lands, so far as Mr. Hamby knows.

## HEART DISEASE CAUSES DEATH

John W. Edwards, 44, died unexpectedly at the home of his sister, Mrs. Eric Bartruff, 716 North Front street, Friday, of heart disease. He had laid off from work about six days, complaining of pains in his side and arm, but without realizing the tangerous nature of his condition.

He came to Salem from Idaho in 1918, and has resided here since. Surviving are the father, John W. Edwards, San Diego, Cal., the following sisters, Mrs. Eric Bartruff of Salem, Mrs. H. G. Christie of Creston, B. C., Mrs. William P. Watkins of Salem, and Mrs. R. M. Reardon of Long Beach, Cal., and the brothers, Warren O. and Walter D. Edwards both of Salem, and Percy V. Edwards of Whitehouse, Yukon territory.

Funeral services will be conducted from the Rigdon mortuary on Monday afternoon at 1:30 o'clock, with interment in Cityview cemetery.

## CLEVELAND CLUB AWARDED MILJUS

Pittsburgh, Pa., July 21 (AP)—John Miljus, pitcher, is the property of the Cleveland American league club, Baseball Commissioner K. M. Landis ruled here today.

Landis came here to hear both sides in the controversy over Miljus. The pitcher was waived out of the National league a week ago and then sent back to the Pittsburgh Pirates by the Cleveland management which repudiated its claim to him.

Landis fixed \$16,500 as the sum Cleveland will have to pay Pittsburgh for Miljus.

## SMITH KEEPING OWN COUNCIL ON SPEECH TOPICS

Albany, N. Y., July 21 (AP)—Gov. Smith is keeping his own counsel about what he will say in his acceptance speech, and he has passed the word that the public should not take seriously any unofficial forecasts of his address.

A date for the official notification of the democratic presidential nominee has not yet been fixed, although it is expected to be after the middle of August. A decision probably will be reached in the next few days.

Thus far, Governor Smith has only been working over in his mind what he will emphasize in his address. He intends to keep the gist of his speech a secret up to the last minute and has declared that no one is in position to disclose what he will stress.

Ever since his nomination he has said that he would touch on all points of the party platform. Commenting on a report that he would subordinate prohibition and farm relief in favor of an exposition on reorganization of federal government departments he insisted that he intended to treat both the farm question and the prohibition problem determinately in his speech.

Determination of a date for his notification has been left to Governor Smith, but he has indicated that he will make no decision until he has ascertained when the most advantageous radio hook-up can be arranged.

## Lowenstein Still Alive When He Plunged From Plane, Doctors Declare

Calais, France, July 21 (AP)—Captain Alfred Lowenstein was still alive when he plunged 4,000 feet from his airplane over the English channel, it was concluded by the medical men who turned in their autopsy report today.

At the request of relatives a further examination will be made of internal organs to determine whether poison or disease caused the Belgian financier's abnormal condition at the time of the tragedy. This is based upon the supposition that he tore off the collar and tie which were found in the plane. Evidence has already been given that just before leaving his seat for the rear of the machine, he acted as if he were suffering.

The present autopsy finding disposes of suppositions that he might have met death in the plane. The implication that some other occupant of the ship was responsible for his passing, was thus cancelled. The regular autopsy completed official formalities of the case here.

## MARINES HOPE FOR EARLY END TO CAMPAIGN

Washington, July 21 (AP)—The Marines in Nicaragua hope to reach the end of their campaign against General Sandino within a few months.

Latest reports received at the navy department say that the insurgent leader, and his band, are practically surrounded by the American forces in northern Nicaragua between the Coco and Bonay rivers. Surrender or flight to Honduras are looked for within a comparatively short time.

A campaign of "poaching" the band is being pursued. Marine officers say that Sandino has been isolated from his source of supplies, either by the American troops or by the impossibility of the jungle trails, brought on by the rainy season. It is thought that the only food to reach him is being floated down the Bonay and Segovia rivers.

Marine headquarters here estimate the strength of the Sandino band at 150 men and believe that since the surrender of more than 500 natives within the last two weeks, it is the only insurgent group now in the Nicaraguan interior.

## DOHENY LIBEL SUIT AMENDED

New York, July 21 (AP)—Robert H. Murray, former Mexican oil operator, today filed an amended complaint in his libel suit against Edward L. Doheny, raising the amount of damages demanded from \$100,000 to \$405,000.

Murray claims that Doheny falsely accused him of duplicity in dealing with the Mexican government and asking for funds in 1919 to start a revolution in Mexico.

In a coffin preparatory to its shipment to Brussels.

Brussels, Belgium, July 21 (AP)—Members of Captain Alfred Lowenstein's entourage denounced as "rubbish" rumors that arrests were imminent in connection with the crime hypothesis of the death of the noted capitalist. They said that these reports gained circulation when relatives insisted upon thorough post-mortem examinations to clear up, if possible, the gossip respecting the banker's physical condition during the trip. The reports were reinforced by misinterpretation of the mutilated condition of the body. It was pointed out that this mutilation was such as would naturally result from a drop of 4000 feet and long submersion in the English channel.

The body is expected to arrive at Brussels tonight. It is the intention of the Lowenstein family to have it conveyed to a cemetery immediately and with the strictest official formalities of the case here.
