Chicago (AP)—John Hertz, who was peddling papers not to many years ago, has retired from business, his wealth rated in millions.

His retirement from the chairmanship of the Yellow Cab company board yesterday was accompanied by announcement that his control of that organization had been sold to another one-time newsboy—Charles A. McCullough, president of the Farmalee Transfer company.

Hertz disposed of his entire holdings in the cab company. Those that did not go to McCullough were either given to about 60 employees who started in business with him or sold to them under an arrangement of deferred payments. Still under 50, Hertz plans to spend years of work with play. A few months in Florida then a summer in Europe are among his immediate plans. In England Mr. and Mrs. Hertz will watch their horse, Reigh Count, winner of the Kentucky Derby, in competition with the best thoroughbreds of the Old World. Hertz, who was born in Rutka, Austria (now Czechoslovakia), founded the Yellow Cab company of Chicago in 1915.

MILLARD CASE GOES TO JURY; ROOM PACKED

The closing arguments in the case of Millard vs. Clemens, whereby E. B. Millard asks \$7500 damages for injuries sustained by his 11-year-old daughter, Evangeline, when she fell from the merry-go-round at Clemens' Hazel Green park, were being heard in circuit court Tuesday afternoon and the case went to the jury in the mid-afternoon.

Attorneys for Clemens attempted to prove that the little girl was sitting on the railing of the elevated platform with her feet over the outside edge when the propelling pole struck her and knocked her to the ground below.

Because of the prominence of the two families the case has attracted more than usual attention and the court room has been crowded to the doors during the day and a half that the case has been in progress.

The second case set for the January term and which will open immediately after the Millard vs. Clemens case, is that of the State vs. Clyde Shoemith. Shoemith is held on a burglary charge.

INAUGURATION OF MR. HOOVER WILL BE QUIET

Washington, (AP)—One phase of the speculation that was swirled about the return of Herbert Hoover was definitely quieted Tuesday when he gave his approval to the March 4 inauguration plans of a simple nature.

Beyond the official ceremony of oath-taking at the capitol the program calls for a parade chiefly of military units. The inaugural ball of other days will be omitted.

The plans were made public by Col. U. S. Grant, chairman of the inaugural committee, and E. F. Calladay, republican national committeeman for the District of Columbia, who conferred with Mr. Hoover and Chairman Work of the national committee.

Details of the ceremony, which some had hoped would be of unusual proportions were summed up in this statement by Col. Grant:

"In conformity with the president-elect's wishes there will be no inaugural ball and he will not attend any other ball on March 4. No objection was made to a charitable ball that evening such as was held on the induction of President Coolidge, but Mr. Hoover has made it clear that he and Mrs. Hoover will not attend."

PIERCE TALKS TO KIWANIS ON OLD HICKORY

The importance of the battle between American and British forces for New Orleans 114 years ago was stressed by Walter M. Pierce, former governor, at the Kiwanis club luncheon Tuesday noon, with high tribute paid to the command of the American troops, Andrew Jackson, inaugurated president of the United States 100 years ago in March.

Under the leadership of Jackson the British ambition to hold Louisiana was blasted and they lost approximately 6000 troops against eight killed and 13 wounded for the Americans, Pierce said. Jackson was described as being influenced by books less than any other great man in history and was characterized as the "world's greatest lover and the world's greatest lover and a man cruel yet kind to his friends."

Pierce and his bride, formerly Miss Cornelia Marvin, are leaving in a few days for California. MARY A. WHELAN CALLED BY DEATH

Mrs. Mary A. Whelan, 84, died at her home seven miles south of Salem, Tuesday morning at 11:10 o'clock. She had resided in Marion county for the past 38 years, having come here from Wisconsin in 1890 with her husband, Michael Whelan who passed away 24 years ago. She made her home with her son, R. D. Whelan, here.

She is survived by four sons, two daughters, 18 grand children and two great grandchildren. The sons are J. W. Whelan, Twodot, Montara, E. F. A. A. and R. D. Whelan, all of Salem, and Mrs. J. C. Savage of Wacoona, and Mrs. J. C. McCarthy of Milwaukee, Ore.

AUTHOR OF 70 PLAYS, SHAW'S FRIEND, PASSES

London. (AP)—Henry Arthur Jones, author of 70 produced plays, died at his home Monday night of a lung congestion. He was 77 years old.

Of late years Mr. Jones had been writing of social questions rather than for the theater and in the latest edition of Who's Who he described his recreation as "hunting sedition." In 1920-21 he carried on a vigorous newspaper campaign against bolshevism and against the views of H. G. Wells and George Bernard Shaw. Some of these were published in the book "My Dear Wells."

Mr. Shaw when informed of the death, said, "I have paid so many tributes to the work of Jones when it was really of some use to him that I do not see any need to pay tribute now when it cannot gratify him. We remained good friends to the last."

The father of Henry Arthur Jones was a farmer and his mother a farmer's daughter and it was not until he was 18 years old that he first set foot in a playhouse, being brought up according to strict Puritan traditions. At the age of 16, however, his reading inspired him to write his first play. Eleven years later he saw his first work produced. This was "Only Around the Corner" which was staged at the Theater Royal at Exeter. "A Clerical Error" produced in 1879 introduced him to London.

His first play in London he was able to forsake his vocation of commercial traveler and devote himself entirely to writing for the theater. Noteworthy among his plays were "Mrs. Dane's Defense," "Michael and His Lost Angel," "The Liar," "The Evangelist," and "Cock O' the Walk." Many of his plays were produced in the United States and he was a member of the Players Club of New York. In 1907 Harvard conferred on him the degree of master of arts.
