CALLS RETURNS FROM VICTORIES OVER THE REBELS

Mexico City, (AP)—There was considerable speculation in Mexico City today as to the next role of General Plutarco Elias Calles, who returned here Sunday after a victorious campaign against rebels in northern Mexico.

At the time General Calles surrendered the presidency of this country to Emilio Portes Gil, December 1 last, he declared he was retiring to private life but would always be ready to serve his country in the hour of need.

General belief was that he would find the "hour of need" has passed now and would resign the post of minister of war he accepted at the outbreak of the revolution, and seek the privacy of the home which he has purchased here.

There was another rumor, persistent but without confirmation, that he would quit his post as minister of war, and travel for a while in Europe, perhaps undertaking an official mission in the interest of his country. It was remarked no one probably would consummate such a mission better than the former president.

At the time of his arrival Sunday, when he found President Gil and a tumultuous welcoming crowd awaiting him he pleaded fatigue to interviewers and hurried off to his home to be with his family, promising a conference with the correspondents later.

HUSBAND SLAYS MAN HE FOUND WITH HIS WIFE

Portland, (AP)—Charles Paulin, 22, and his wife, Bertine, who he had not lived together at all during the three years of their secret marriage, found themselves under the same roof today—in the jail—with the spectre of murder hanging over them.

Paulin is charged with the slaying of Harry Nichols, 25, a grocery clerk, at the St. Paul Hotel here, Saturday night. His wife, whom he surprised in Nichols' room, is held as a material witness.

Paulin gave himself up at police headquarters yesterday after police had searched for him for fifteen hours.

"He did not mean to shoot," Paulin's wife declared Monday. "Oh, I know he did not intend to shoot."

"We were secretly married years ago. It was an elopement. We were carried off our feet—it was against my better judgment. We were emotionally and mentally incompatible. He cared nothing for books and reading. I wanted him to study and better himself, but he seemed uninterested to get farther along than cab driving."

"So I maintained an apartment by myself while he lived with his mother and brother."

With another girl, she said, she stopped in for two or three minutes to see Nichols in his room. As they were there Paulin entered and shot Paulin then fled. He later surrendered on advice of his mother who spent the early hours of a bitter "Mother's Day" in persuading her boy against flight.

MEDFORD LINE SURVEYED TO KLAMATH FALLS

Medford, Ore. (AP)—The Owen-Oregon Lumber company of Medford has under consideration extension of its logging railroad line from Butte Falls, the center of its logging operations, to Klamath Falls, according to a statement today by John S. Owen of Eau Claire, Wisconsin, president of the lumber company.

"I think our railroad should be extended to Klamath Falls, and orders have been issued by the board of directors to James H. Owen, general manager, to proceed with the survey. We are going to find out if a line is practical, and it is worth investigating," Owen declared.

COUNTY BRIDGE WORK STARTED

Work on the Killen bridge road east and north of Woodburn will be started within a week and on the Buena Vista road within the next 10 days, says Assistant County Roadmaster Frank Johnson. Johnny Griesbauer will be foreman on the Killen bridge job and Lee Wills on the Buena Vista road. According to Johnson, the entire summer's program will be well underway by June 1.

This week there are crews actually working on only two of the county market roads slated for improvement this season. Lester Ann Cleave and his crew started Saturday afternoon on the Lake Labish stretch of the Brooks-Mt. Angel road. A narrow fill across an arm of the lake will be widened. Johnson says that between 80 and 90 cords of wood will be used to widen the fill. The arms will be corduroyed and then gravelled. Nearly three miles of the Brooks-Mt. Angel road will be improved to meet market road specifications this season.

Two tractors and a crew directed by Bill Melvin started Monday morning on the Salem-Independence road below Halls Ferry.

REFUND ASKED ON HOTEL TAXES

Because somebody named Smith formerly owned the furniture in the Woodburn hotel the present owners, Mr. and Mrs. S. A. Matley, paid \$48.32 in taxes which they claim should have been paid by C. D. Smith, owner of the grocery store and confectionery at the Woodburn arch on the Pacific highway.

Mrs. Matley has written a letter to every member of the county court asking for a refund of the tax paid. She says that they bought the furniture from J. B. and S. E. Clark last May. When they came down to the courthouse several weeks ago to pay their taxes the tax collector said that there was no assessment charged to the Smiths. Mrs. Matley volunteered the information that somebody named Smith had sold the hotel furniture to the Clarks and then the mix-up started.

The county court has turned the matter over to the sheriff for legal judgment. County Commissioner Jim Smith says that any Smith who wants to pay his taxes is welcome to do so.

WEST APPEALS FOR CHANGE IN FARM DUTIES

Washington, (AP)—Representative Simmons, republican, Nebraska, announced today he had called a meeting of the house members from the western cattle producing states for tomorrow to consider making a united appeal to the house ways and means committee to change the tariff status of hides, meats and live animals.

Under the pending bill, hides were left on the free list. A slightly higher duty was provided for certain meats, and the livestock duty was unchanged. Many of the westerners believed a tariff should be placed on hides and higher duties should be assessed on livestock.

The Nebraska member said he was uncertain as yet how many of the states would be represented at the meeting, but he felt certain that all of the cattle producing states would join in the movement.

over to Burdick, in the amount of \$47,500. Named defendants with Burdick, who is a Redmond, Ore., attorney, are his wife, Zoia, his brother and sister-in-law, Mr. and Mrs. Nelson Burdick and Joseph Marsh.

Mrs. Smith declares in her complaint that she lost a considerable sum of money and property several years ago and that Joseph E. Marsh, an old acquaintance, gained her confidence in 1927 and brought Burdick to her residence in Beilleville in October of that year, urging that she retain him in a legal capacity in connection with her losses.

The complaint alleges that Burdick told Mrs. Smith that he was very influential, was an intimate friend of a former governor of Oregon and could bring to justice the people who had defrauded her. He said, too, the complaint declares, that he could bring about the recovery of her money and property, whereupon she paid to Burdick and Marsh \$15,000.

FRED L. BOALT OF PORTLAND DEAD

Portland, Ore. (AP)—Fred L. Boalt, for many years editor of the Portland News, died at his home here Saturday night after a long illness. Boalt had been in poor health for two years and for several months his condition was grave following recurrent attacks of influenza.

A gifted and colorful writer, a fearless crusader and a winning personality made Boalt one of the best known and best loved newspaper men in the state. He came to Portland in 1918 and succeeded Leroy Ritchie as editor of the News, a position which he held until his fall when he was appointed assistant to B. H. Canfield, chairman of the board of the Scripps-Canfield newspapers, of which the News was a member.

18,830 MOLES AND GOPHERS TRAPPED

J. F. Harris, who in the past four years has trapped moles and gophers in Marion county, brought the scalps of 375 gophers and 10 moles to the county clerk's office Monday morning to collect the bounties on them.

INCREASED TAX ON HOPS NEEDED DECLARES MOTT

That the chamber of commerce, when it asks congress to provide for a higher tariff on flax fiber than that offered in the pending bill, should also ask that the tariff on hops be increased was urged upon the chamber at the noon luncheon Monday by James W. Mott, Salem attorney.

Mott said the excuse offered by the ways and means committee in congress for not providing an increase on hops was that the commodity is sufficiently protected already. He said he did not know who had told the committee this, but he knew a delegation of hop men, including E. Clemens Horst, largest grower in the world, had waited on the committee and asked for an increase. Mott said he thought the chamber of commerce should remind the committee of its failure and demand an increase.

This was open forum day at the chamber of commerce, with President Sisson in the chair, and anyone talking who desired. Dr. P. O. Riley of Hubbard extended an invitation to the community talent contest to be held soon at the Elmore theater with 42 communities participating. Salem night is to be May 24, with a silver cup to be given the winner on that occasion.

PADDLES SWUNG IN INITIATION; SUSPEND GIRLS

Long Beach, Calif. (AP)—The father of Margaret Lindsay, 18, who attained her majority at the price of taking her meals from the marketplace, and the parents of nine other young ladies who initiated Margaret with paddles, Monday threatened war on the board of education for suspending their daughters from Polytechnic high school. "I will send Mary Jane to school tomorrow," said Mrs. M. J. Melander, "and we will see whether they refuse to admit her to classes. I am proud of the girl because she told me the truth."

The girls were suspended for belonging to a sorority, contrary to a state law. The sisterhood became known to officials when Joel Lindsay protested that the girls were "too rough" in initiating his daughter into the secrets of the order with wooden paddles. Miss Lindsay, he said, was forced to stay in bed two days and was still dining in the buffet or free lunch counter style. "They are not going to suspend her," declared Lindsay. "The experience already has been painful enough for any girl. She's resigned from the order, anyway."

SANTIAM RANCH TRADE IN COURT

With one on the most bitterly contested cases to be heard in the local court in a number of months, the May term of circuit court in Marion county opened Monday morning. More than an hour was taken in the selection of a jury to try the case of H. W. Cooley and sons vs. James Noland. A day and a half had been allowed on the docket for the case.

The Cooleys started action to recover \$4,000 which they claim is due them from Noland and Noland has set up a counter claim for \$18,000. The Cooleys traded their Santiam River bottom ranch for Noland's Unadilla county wheat ranch. Encumbrances on both they had not expected were found on the wheat crop. Noland claims that sheep, goats and cattle, as well as machinery, which the Cooleys were expected to leave on the Santiam ranch, were missing when he arrived to take charge. SCHOOL ENROLLMENT SHOWS DECREASE

Enrollment records for the Salem public schools continue to show the same small rate of decrease in enrollment as compared with last year's figures as each monthly check-up is made. At the close of school last Friday afternoon a total of 3375 boys and girls were enrolled in the Salem schools, exactly 90 less than the enrollment on the same date last year.

A slight increase over the previous month is shown, however, as the April check-up showed only 3353 enrolled. The decrease as compared with last year exists entirely in the grade schools. Both junior high and senior high school show an increase.

Enrollment totals Friday afternoon were as follows: Senior high school, 1229; Parrish junior high, 500; Leslie junior high, 467; Englewood, 352; Garfield, 373; Grant, 331; Lincoln, 185; McKinley, 281; Park, 306; Richmond, 297; Washington, 227; Highland, 357; total, 5375.
