Silverton—At the practice stock judging contest held at the Clackamas county fair at Canby Wednesday, Prof. Warren E. Crabtree of the Smith-Hughes department took over the following 13 boys to take part in the contest: Clifford Maulding, James Neal, Edson Williams, Victor Hadley, Clifton Hadley, Paul Plank, Robert Hillman, Clyde Verbeck, Arden Miller, Carl King, Norris Langslet, Lyle Keller, and William Baller. At this competitive practice contest each instructor had to designate a team. James Neal, Victor Hadley and three members to represent his and Clifford Maulding were the Silverton members.

At this contest there were eight teams from Oregon and two from Washington. They were in order of which the schools were placed in the contest, as follows: 1, Canby; 2, Independence; 3, Ridgefield, Wash.; 4, Corvallis; 5, Gresham; 6, Silverton; 7, Molalla; 8, Scappoose; 9, Woodland, Wash.; 10, Woodburn.

In all of these teams there were 50 boys.

James Neal of Silverton won first in Jerseys securing a purple grand champion ribbon; second, in Shropshire lambs.

Clifford Maulding won first in Jerseys—white ribbon; James Neal in Shropshire ewes and got a blue ribbon; Victor Hadley, 3rd in Shropshire.

It was stated that Silverton took away more ribbons than any one other team.

From the above local boys mentioned, the three making the highest scores in the different practice contests, will represent Silverton at the Pacific International Livestock Exposition to be held in Portland in October.

Cascade Timber Outlook For Milling Operations Good In Scio District

Scio—Millions of feet of the best commercial saw timber on the west slope of the Cascade mountains are involved in negotiations now apparently nearing consummation, according to well-defined rumors in circulation in Scio.

The timber in question is within a few miles of Scio and it is believed by those in a position to know that preliminary work will be pushed this fall in order that logging and milling operations on an extensive scale may be taken up as early next spring as weather conditions will permit.

Practical timbermen from Portland, believed to be representing the Ballin interests, were in Scio this week on business connected with proposed deal. They visited the W. M. Beran timber tract a few miles east of Scio, and it is understood the parties interested arrived at a tentative agreement and that final details will be taken up as soon as practicable.

It is probable, in the opinion of practical timbermen, that crusting of the tracts involved will be taken up as the next step in the negotiations which have been pending for several months. It is given out as fact that satisfactory arrangements have been made for the use of the mill site at the Liska place. This fact, coupled with the accredited report that cruisers will soon be in the field, is generally accepted as conclusive evidence that a bona fide deal will follow and that lumbering operations on a large scale will be carried on for several years.

H. D. Langille and Mr. Hazen were in from Portland this week and it is said they expressed satisfaction with the prospects for timber adjacent to the present site of the Ballin mill plant. It has been estimated that commercial timber is available to keep large plants in operation for an indefinite period of years.

It is presumed that markets for the output will be established in Portland and that in all probability that feature of the matter has been definitely settled. However, there seems to be some speculation in the minds of local people as to whether the timber will be worked up at the mill near Scio or whether it will be transported in carts or otherwise to larger plants. In any event, it is believed that establishment of extensive logging operations on the Beran property will have a tendency to stimulate business in Scio and vicinity and provide employment for 25 to 40 men.

Prospects for final consummation are considered more favorable now than at any previous time during the present year.
