Rank Injustice

By a decision of four to three, the Oregon supreme court has refused a rehearing of the Boloff case and confirmed the defendant's sentence of ten years in prison for having joined the communist party. The decision is not only the most reactionary one in the court's history but in conflict with the spirit of the constitution as expressed in the bill of rights.

One has but to read the opinions of Justices Rossman, Brown, Kelly and Campbell and then to contrast the dissenting opinion of Justice Bell, concurred in by Justices Bean and Rand, to realize that human rights have been sacrificed for technicalities in the majority opinion, and the fact that courts were instituted to construe the law in the interests of justice lost sight of.

The anti-syndicalism law, under which the conviction was obtained was passed during the hysteria of the world war when constitutional rights had been temporarily suspended for the preservation of government and public safety. The emergency long since passed. Though the legality of the law has been sustained by stretching the constitution unduly to thwart liberty, it has no place on the statute books and should be repealed. As Justice Bell states:

It was never intended that such statutes be invoked to silence by force the complaints or criticisms, however unjust or unreasonable, made against existing social, economic, or political conditions. Even the sovereign state cannot sit in judgment upon a man's conscience and dictate to him how he shall think or speak concerning such questions. As a matter of fact, free expression of opinion is the best antidote for the various kinds of ills with which our body politic is afflicted.

Boloff, an illiterate foreign laborer, who never attended school a day in his life, and who can neither read or write, who had never been convicted of any crime, was one of 13 indicted on the evidence of a Portland policeman for having signed a card for membership in the communist party. No evidence was presented that he ever said or did anything to teach or advocate crime or physical violence. In fact he did not know what it was all about, but joined because he supposed it was a workingman's party.

On the same evidence that Boloff was convicted upon, two others of those indicted were acquitted and the indictments dismissed against the other ten. Boloff, the most harmless and ignorant of them all, is the only one punished, thus saving the state from a "red menace" he did not know existed. Is this justice? Is this equality before the law? If the communist party, with its infinitesimal following really endangers the state, why not penalize its leaders instead of its harmless pawns? As Justice Bell further says:

The state, having shown that the defendant joined the communist party, apparently sought, under the theory of conspiracy, to hold him responsible for all of the strange doctrines and teachings that any member of such organization ever advocated—whether the defendant believes in or even knows of the same. Applying the same logic, if some democrat should go so far as to assert in a public speech that all republicans should be shot at sunrise, then every member of the democratic party would be guilty of crime.

Unjust decisions, excessive penalties, police tyranny and the attempt to forcibly suppress conscience, ideas, speech, and other inalienable rights do more to make communists than all the propaganda peddled. They supply real grievances against society. The courts have made a martyr of Boloff, thereby stimulating communism.

It is now up to Governor Meier to rectify a great wrong and a rank injustice by exercising his pardoning power and freeing Boloff. That is a privilege conferred upon executives especially to prevent miscarriages of justice.

No Federal Wage Cuts

It is hard sometimes to understand the Hooverian logic. For instance the president declares he will "sternly oppose" any general wage cut for federal employees. The dispatch states:

While the president kept his own counsel, no doubt remained as to his position. He was represented as feeling that the government must maintain its scale to retain responsible public officials; that a federal wage cut would set the country a bad example, and that the buying power of federal as well as other workers must be maintained.

However, when everyone else in the country is forced to take either wage slashes, or reduction in income, is it a good example to punish the taxpayer by keeping the well paid federal officials and employees out of line with the rest of the country, at the taxpayers' expense? With living costs decreasing, why should those on government payrolls be exempted and receive what amounts to substantial salary raises, through the increased purchasing power of the dollar? Why the necessity of maintaining tax eaters on war time wages while the taxpayers are forced to endure depression hardships?

With a treasury deficit of nearly a billion dollars last year, and facing a deficiency of two billions this year, why should not an attempt be made to balance the budget by substantial wage reductions, as private industry is forced to? What kind of example is this for government to set, the spending of 50 percent more than income, running deeper and deeper into the red, with the president proposing new dolies for banks and railroads and congress appropriating billions for all sorts of wild schemes, but rejecting economies?

The house committee promptly tabled four bills before it calling for 10 percent reductions in the pay of all federal officials, starting from the president down, including congressmen and the courts, but exempting those receiving under \$1500 a year, which would have meant a saving of \$165,000,000 annually. In this they followed the president's desires, presumably because they did not want to take a wage cut themselves, despite their assertions that their hearts bled for the poor taxpayer who pays them.

\$20,000 DAMAGE SUIT BEING HEARD

Circuit Judge Hill Thursday took under advisement the case of L. F. Warting vs. George F. Vick in which the matter of money for services performed was alleged. Both sides waived a jury trial in this case and allowed the judge to hear it.
