

WATER RULING IRKS MAJORITY OF PETITIONERS

Silverton—The representatives of the 700 petitioners to the mayor, council and water commission concerning the water rates apparently not satisfied with the decision of the commission in returning to the former rates. The following explanation is presented in defense of their expressed wishes that a change be made:

"In view of the fact that a lengthy report of the proceedings of the Silverton water commission and the mayor's committee session recently held, has been given extensive publication, it seems no more than fair that the petitioners who asked for reduction of water rates may make known their viewpoint.

"The prayer of 715 interested patrons of the water system of Silverton, should not be ignored.

"In view of the present depression and the fact that the wages of the workers and the profits of the business have been reduced, the petitioners believe that the expense of procuring water and the expense of operating the plant should be reduced. Hence, the petition of a goodly number of the patrons of the Silverton water system, asking (not demanding) a hearing.

"It is the belief of the petitioners that water can and should be furnished at a lower rate than is now being charged. An examination of the books and accounts of the water commission bears out this contention. The books do not disclose very much economy in operation now being practiced.

"About the same expenses are kept up as prevailed during the flush and prosperous time. About the same as when the bonded indebtedness was \$45,000 instead of \$20,000.

"There is no question but that the system is, and should be, self supporting. However, the petitioners believe, this does not require or justify the collection or the spending of the sum of \$18,000 per year at this time. It may have been necessary when the bonds were \$45,000 and interest on this whole amount had to be paid. Now that the bonds are only \$20,000 and the interest is proportionally reduced it is deemed not necessary.

"A further examination of the books and accounts of the commission and their statement of June 30, 1932, discloses that the commission now has on hand and unused, the sum of \$5,000 and over. If the rates charged during June, 1932, were continued until next April, 1933, the time when the next \$5,000 bond and interest is due, there would be approximately \$12,000 in the hands of the water commission. After paying the \$5,000 bond and \$900 interest April 1, 1933, there would remain \$7,100 or about the sum \$700 over or added to the present surplus.

"The petitioners, who are reasonable, honest and earnest workers and business people and our neighbors and friends, who have the best interest of the people at heart, do not believe it advisable or wise or necessary at this time of shortage of money, to build up a large reserve or surplus or a large sinking fund far beyond the needs of the present and immediate future. On the other hand, they do believe that the strictest economy should be practiced. While others are taking a cut in salary and curtailing expenses, the water commission should do the same.

"One of the contentions of the petitioners is they do not like the thought of being compelled to pay \$1 minimum or a service charge which entitles them to no water. They would have been satisfied with the small amount of water for the first \$1.

"Those petitioners who live outside the city limits of Silverton are deserving of some consideration. They have built their own lines to connect with the Silverton system and have put in their own meters, all at their own expense. Their contributions to the Silverton system has helped to some extent to pay the expenses of operation and the payment of the bonds. They should not be entirely ignored.

"The operation of the Silverton water system would run more smoothly with satisfied customers than it possibly can with even a few hundred who feel they have not been dealt with impartially and fairly."
