## HOBOS HONOR SONG WRITER

Cincinnati, Jan. 13 (AP)—Claiming the late Stephen Collins Foster, famous song writer, as "one of their own," American hobos announced plans today to erect a memorial in his memory. Today was the 69th anniversary of Foster's death. "Foster was a typical 'ho,'" said Jeff Davis, who is "King of Hoboes" by virtue of his office as president of the International Itinerant Workers' Union. The memorial, a bronze tablet, will be placed on one of the walls of the Bowers House in New York died in 1844. 11\*

Writer of many of the world's best-loved songs, Foster drifted from city to city—Pittsburgh, Cincinnati, New York—struggling against poverty and meanwhile writing "Old Dog Tray," "Old Folks at Home," "Nellie Gray," "Swanee River" and other songs—125 or more. He was found dead in his room at the age of 38. 11\*

## THREE EXECUTED IN ELECTRIC CHAIR

Ossining, N. Y., Jan. 13 (AP)—A swarming youth of 21, with a final sentence of 30 years, died in Sing Sing's electric chair just before midnight, the first of three murderers to be executed. 11\*

The three put to death were Peter Harris, 21, of Olean, N. Y., and Thomas Carpenter and Charles Bates, New York negroes. 11\*

Harris entered the death chamber at 11:08 o'clock. The doctored youth looked around at the faces of the witnesses, seeming to search for an acquaintance. Then he called out: "What are you laughing at? This is no laughing matter." 11\*

Harris stepped quickly to the chair and was pronounced dead at 11:19 after Carpenter and Bates followed quickly, with the triple execution ending at 11:22. Harris killed Michael Vassil, of Olean, in a gun battle with police there after an attempt to "shoot up the town." 11\*

Carpenter and Bates died for the murder of Solomon Atkatz, a Bronx grocer, in a holdup. 11\*

## PRINCESS BORN; NATION JOYFUL

Sofia, Bulgaria, Jan. 13 (AP)—All Bulgaria was celebrating the birth of a princess this morning—the first child of King Boris III and Queen Joanna. The mother and baby girl were both reported in excellent health. 11\*

Although Bulgaria's constitution prescribes direct succession by the male line, the princess was welcomed with a warmth of affection reminiscent of the reception accorded Queen Joanna when her royal husband brought her home from Italy two years ago. 11\*

The event naturally renewed speculation as to the religion in which any child of Boris and Joanna will be brought up. The law required that the ruler of Bulgaria must be an Orthodox Catholic and special permission of the Pope was necessary before Boris married the Italian princess. 11\*

The princess' birthday falls just 17 days before her father's anniversary. The king will be 39 years old January 30. 11\*

Queen Joanna, who is 24 years old, returned to the capital only yesterday from Varna palace, where she had been staying since early in December. She spent much of her time knitting garments and frequently chatted with her parents in Rome, particularly the queen's mother, by long distance telephone. 11\*

The government was planning a political amnesty for exiles and the pardoning of hundreds of prisoners in Bulgaria in celebration of the event. 11\*

## DOUKHOBAR ADMITS COUNTERFEITING

Vancouver, B. C., Jan. 13 (AP)—Nicolos Plosnikoff, a prosperous Doukhorob storekeeper at Grand Forks, B. C., was arrested by provincial police and has confessed to manufacturing many thousands of dollars worth of counterfeit money over a period of years, it was learned today. 11\*

Plosnikoff's specialty was "raising" five dollar notes of the Canadian Bank of Commerce to \$20 denomination. The counterfeiters were so accurate that even bank officials did not detect their worklessness. 11\*

Plosnikoff, police said, did not attempt to pass the spurious money in Grand Forks but operated through friends in Nelson. 11\*

## BANK TO LIQUIDATE AT CENTRAL POINT

Medford, Ore., Jan. 13 (AP)—The Central Point state bank of Central Point, by a vote of the directors today, decided to discontinue the bank business, and turns the liquidation of the assets over to the state banking department. 11\*

The directors' statement by the directors sets forth, that owing to the proximity of the bank to Medford, the business has steadily decreased until "the income is not sufficient to pay the costs of operation." 11\*

"The statement further says that 'the bank is in sound financial condition but it is impossible to collect a great bulk of the loans at this time.'" 11\*

The directors' statement was "it is thought to be to the interests of the depositors" to voluntarily liquidate. 11\*

## WALKER WILL CASE REVERSED

Circuit Judge Lowell has handed down a decree reversing the probate court in the will contest of Elmer W. Purvine, in the matter of the estate of Dora Walker, against B. Ellis Purvine, executor of the estate. 11\*

The appeal from probate court was taken to determine the matter of heirship. Under the will of Dora Walker she bequeathed \$100 and certain other personal property specifically to Emily Walker Jeffries and left the residue of her estate to nieces surviving at the time of her death, these nieces including Emily Walker Jeffries, the residue to be shared equally between them. 11\*

Judge Lowell holds that the residue should go to the nieces of Dora Walker as individuals and not as a class, opposite to the holding in probate and that that portion of the estate which would have gone to Emily Walker Jeffries had she survived the testatrix should be divided among the heirs of Dora Walker and not go to the surviving nieces. The county court is instructed to ascertain who were the heirs of Dora Walker at the time of her death and the executor is required to recast his final account in keeping with the decree. 11\*

## SESSION FACES GRIM PROBLEM

Olympia, Wash., Jan. 13 (AP)—There will be no stalling on the state's great current problem—unemployment relief, it was evident today. The 1933 legislature started work yesterday toward a solution of what is expected to be the most controversial and important legislative item of the 23rd session. 11\*

The house yesterday learned that Washington's unemployed total more than 150,000, a new high. The report of the University of Washington, social science professors, was made to the committee on employment. 11\*

The university committee recommended an additional issue of state bonding for \$10,000,000. It was thought the bonds would be declared unconstitutional. Another plan suggested a sustained program of public works, unemployment insurance and farm rehabilitation to promote self help. ## BAUGHN MURDER TRIAL OPENS TUESDAY

The next case to be heard in circuit court by a jury and Judge McMahan will be a murder case, the trial of William Baughn for the murder of Ray Robnett of Detroit to come up in that court next Tuesday morning at 9 o'clock. 11\*

Judge Lowell, who has been sitting for Judge McMahan this week under affidavits of prejudice, was to have heard the case of Ball brothers of Turner against Associated Oil company today. However, a continuance was taken on agreement of attorneys to a date not set and inasmuch as the next case was the Baughn murder trial the jury was discharged until that time instead of endeavoring to bring the next case up for trial today. 11\*

The Ball brothers' case is for rent alleged to be due on a service station at so much per gallon for gasoline sold. The continuance was taken as the plaintiff's wished to put in a supplemental complaint bringing the case under the lease up to date, as about a year has elapsed since the complaint was filed. 11\*

## WOMAN SLAYER OF 2 MEN TO HANG

Szegedin, Hungary, Jan. 13 (AP)—Victoria Heger, a 59 year old peasant woman charged by the state with killing two men, was convicted of murder today and sentenced to be hanged. The state charged she had killed her two husbands and that she hanged them to ratters in their own barns. 11\*
