DONEY DEPICTS PROBLEMS FACED BY GRADUATES

Unemployment among college trained people as it exists is one of the greatest problems of the day, particularly with the doors of numerous institutions of higher education discharging thousands more in the past few weeks. Dr. Carl Gregg Doney, president of Willamette university, told the Rotary club Wednesday noon. The situation was characterized as almost unbelievable and tragic.

As an illustration, Dr. Doney said he had received an offer from a woman, with nine years experience and a master's degree, asking for employment as dean of women and offering to work for her board and room and \$25 a month. Other offers, which are being duplicated throughout the country, are for employment at a sufficient salary to insure living expenses. Approximately 1000 high school teachers are being released in Oregon this year, disappointed rather than suffering from physical wants, with prospects that they will become cynical and preachers of despair, he said.

Too much attention has been given to specialization with the modern trend towards training the hands rather than the head, he said. As a result of this training, when something occurs to a job the employee is unable to adapt himself to something else. Training that will broaden rather than concentrate in one direction, giving the student adaptability and an understanding of those things which tend to make life more satisfactory is the modern objective of education today, Dr. Doney said in closing.

REPUBLICANS TO ASK SALES TAX

Washington, June 7 (AP)—Senate republicans decided today to press for a sales tax of 1½ per cent as a substitute for the proposed corporation levies to finance the \$3,300,000,000 public works program in the industry recovery bill.

This provision, described by proponents as the only weapon to bring recalcitrant industries in line, was eliminated by the finance committee, then restored at the request of President Roosevelt.

The proposed sales tax, to be offered by Senator Reed (R., Pa.), would exempt food, clothing, medicine and fuel. It is designed to replace the Harrison levies against the net worth of corporations and dividends, an increase of one half a cent in the present one cent a gallon levy on gasoline, and a tax of one per cent for the privilege of filing consolidated returns.

If the sales tax fails, as democratic leaders predict, the republicans planned to propose elimination of the increase in the gasoline tax.

Twenty-seven republican regulars attended the conference. Its decisions were not binding, as in the case of a caucus.

Senator McNary, the republican leader, told newspaper men afterward: "There was a very general feeling of approval that a sales tax would be more equitable than the taxes contained in the bill."

COUNTRY TO LOAN ROAD EQUIPMENT

County Engineer Swart has notified Fire Warden Ferguson of the Clackamas-Marion Fire Patrol association that the county can loan the government two caterpillars, two plows and two scarifiers for government road work, which it is proposed to do on forest road projects not in a forest reserve but in the eastern part of Marion county.

This equipment was asked for by the government recently when plans for a new forest road program under the Roosevelt reforestation program were outlined to the court by Ferguson. This will include a road from Bridge Creek to the Crooked Finger road, an extension of the Crooked Finger road further back into the mountains, and also some additional forest trails and telephone lines for forest protection work. It is expected a government camp of about 240 men will be established to put over the proposed work.

Small Boys' Body Is Washed Ashore

Seattle, June 7 (AP)—The body of a boy, believed to be Larry Rayner, 5, was washed ashore near Port Orchard, Wash., late yesterday. The body was believed to be the son of Mr. and Mrs. Lawrence Rayner who were drowned while attempting to cross the sound last Friday. A friend Claude Carpenter, was still missing. Their shift struck bad weather and overturned.

Moody Appointed Special Prosecutor

The expected appointment of Ralph Moody of Medford as investigator and prosecutor of alleged perjury of witnesses at the L. A. Banks murder trial at Eugene was made by Attorney General I. H. Van Winkle late yesterday.

Moody headed the prosecution at the trial in Lane county where Banks was convicted of second degree murder in connection with the slaying of Constable George Prescott of Jackson county. Mrs. Banks was acquitted.

BORAH CLASHES WITH WAGNER ON WORK BILL

Washington, June 7 (AP)—In a sharp attack on the industrial recovery bill, Senator Borah, Rep., Idaho, charged in the senate today that the measure would abolish small competitive industrial units, and that supervision of anti-trust laws as provided in the measure was directly contrary to a democratic platform pledge.

Borah's attack brought him into sharp clash with Senator Wagner, Dem., N. Y., senate sponsor of the measure who opened debate with a defense of the program, which he said must be passed immediately so that the economic revival could be continued. Wagner asserted that the anti-trust laws had failed to prevent concentration of wealth and industrial monopolies.

"In my opinion this bill is a very advanced step in the concentration of wealth," Borah said.

"If we say to these vast combinations now engaged in this country 'You may further organize, monopolize and control prices' we'll have a harder time in dealing with monopolies in the future."

Borah charged that Henry I. Harrison, president of the United States chamber of commerce, accredited by many with having originated the central idea of the bill understood that "every independent will be roped and pulled in with the herd and made to run with the herd."

"It would abolish the independent completely," Borah added.

"Mr. Harrison had nothing to do with the drafting of this bill," Wagner responded.

Quoting a speech of Charles M. Schwab, steel magnate, Borah said that the steel leaders hoped, through the bill, to drive independent into the larger steel combines.

Recalling that enforcement of the anti-trust laws had been embodied in the democratic platform, Borah said this plank had been written because republican officials had failed to enforce them.

"You promised to enforce the law and now you try to destroy them," Borah shouted.

"We promised to enforce them and that's what we are going to do," Wagner answered.

"Yes, by destroying them," Borah retorted.

OREGON QUOTA SOON IN CAMP

Portland, June 7 (AP)—Oregon's quota of 2000 will be in the 62 civilian conservation corps camps within a day or so, according to C. J. Buck, regional forester in charge of the north Pacific district, Washington.

Quota of 3250 already has been taken care of and the men are now in the 50 camps in that state.

In the final allotment of civilian camps, Oregon's quota was reduced to 62 and Washington's to 50. Oregon will, in addition, have two national park camps. The reason for the reduction, Buck said, is that fewer men than anticipated will be sent from the east to Oregon and Washington, inasmuch as eastern forest camps have absorbed more men than had been expected.

Buck explained that "this does not mean that the work and camps previously outlined for Oregon and Washington have been dropped. It merely means that the camps have been placed on the deferred list and that they may or may not be filled with men later. Those men now enrolled have signed up for six months, but emergency conservation work program covers a two-year period."

SEEK GRAZING RULES FOR PUBLIC LANDS

Washington, June 7 (AP)—Secretaries Ickes and Wallace today asked the house public lands committee to approve a bill giving the head of the department of interior the right to prescribe rules and regulations affecting grazing on the 173,000,000 acres of public lands.

They pointed out that the public land companies nearly 9 per cent of the total area of continental United States and that so far as federal agency has any control over the preservation of grass and forests.

Despite their appeals, a similar one from Representative Taylor (D., Colo.), author of the bill, Representatives White (D., Idaho), and Cheves (D., N. M.), introduced they opposed any federal regulation.

MUSIC CRITIC GIVES PRAISE TO ORCHESTRA

J. L. Wallin, music critic of the Portland Journal was asked to give his opinion of the Ted-Rito Vaudeville presentation which is a current attraction at one of Portland's leading theaters this week, and is playing a theater engagement at the Elsinore theater in Salem June 12 for a matinee and first evening show appearances following the theater engagement the band will furnish the music at the armory for a dance.

Ted-Rito has refined American jazz to the point of real art without robbing it of one iota of its inimitable characteristics which perhaps better than anything express the temperament of the nation. This he is demonstrating with his famous N. B. C. and C. B. S. world famous orchestra and is touring the northwest under the personal supervision of Cole McElroy, Portland ballroom operator.

Jazz is this sort of music with revolutionary promises for more than passing consideration. It offers possibilities for development to degrees far beyond those so far obtained, through the media of tone, color and nuances.

Fio-Rito impresses one as possessing a wealth of musical ideas and as a colorist par excellence. His band is not large and still with the limited material his continuous programs as rich in tints and colorful designs as one of the rarest of Oriental rugs.

As leader, at the piano, he never intrudes, but remains a modest part of the ensemble and for that scores about 50 per cent.

Ted-Rito and his world famous N. B. C. and C. B. S. orchestra of national reputation will be featured at the Elsinore next Monday, June 12.

MAYOR PORTER OFFERS FIGHT

Los Angeles, June 7 (AP)—With wholesale change in city officials ordered by Los Angeles voters, the final result of the mayoralty election was clouded today by the possibility Mayor John C. Porter may refuse to relinquish his office without a fight.

Frank L. Shaw, chairman of the county board of supervisors, defeated Porter by approximately 31,500 votes in yesterday's election. The complete unofficial count today gave Porter 155,513 and Shaw 187,053 votes.

The mayor's son and secretary, Lee Porter, indicated his father might contend he was entitled to remain mayor until his successor-elect has demonstrated he is an American citizen. Porter claims Shaw is a Canadian.

Shaw was sought to produce proof that he is an American citizen. The city charter specifies the mayor must be a citizen and qualified elector.

Seven of the ten members of the city council who were on the ballot were defeated for re-election. Porter has served one 4-year term as mayor.

TRAINING CAMPS TO BE POSTPONED

Vancouver, Wash., June 7 (AP)—An order cancelling the scheduled meetings of the citizens' military training camp, the reserve officers' training camp, and the reserve officers' summer training for the army fiscal year of 1933, was received by the commanding officer of Vancouver Barracks today from the ninth corps area headquarters at San Francisco.

The C. M. T. C. training period of four weeks was to have started here June 23. The quota of 590 youths from Oregon and southwestern Washington has already been filled from more than 1,000 applications. Those who had been accepted were being advised today by the adjutant that the training orders have been revoked. They were told, however, to stand by for further instructions.

Hapsburg Curse Hits Alfonso's Young Son; Prince To Wed Cuban

Paris, June 7 (U.P.)—The dread "curse of the Hapsburgs" has visited another member of the family of former King Alfonso of Spain, and hastened revolt of the exiled monarch's children against his demands that they carry on the proud traditions of their line.

Gonzalo, 18, youngest son of Alfonso, lies in bed at Louvain, Belgium, where a small cut on his foot has continued to bleed for months, it was learned today.

He has hemophilia—a tendency to bleed inordinately—as has the Prince of Asturias, Alfonso's heir, who in order to escape from the court atmosphere that has enveloped the Hapsburgs for more than 1000 years intends to defy his family and marry at Lausanne, Switzerland next week, Mlle. Elizabeth de Pedro, daughter of a Cuban plantation owner.

The prince of the Asturias is reported to have been strengthened in his determination to marry a commoner by the fate that has overtaken his brother.

So, too, has been the effect on the infant Maria Christina, now 21, who when she becomes her own mistress two years hence, insists she will "make her own life," and probably go to America.

"I am anxious to make my own way, and settle down like any other girl in my own home," she confided to friends.

The Prince of Asturias also is said to want to get away entirely from Europe. He wants to go to Cuba as soon as possible, and he may supervise the properties of his fiancée. He has a large allowance from his family, but this may be cut when he marries.

All his life the prince has been under treatment for hemophilia, a strange malady that can be transmitted only through the women of a family, and only to men. Women themselves do not suffer from it.

Some progress has been reported in Asturias's case, but specialists who have been summoned to attend young Prince Gonzalo at Louvain, have been able only to confirm that he has the "Hapsburg curse," transmitted to the Spanish Hapsburgs.

Gonzalo was studying at famous Louvain university. Several months ago he cut his foot on a bit of broken glass. Bleeding persisted, and he was weakened so that he had to remain in bed.

King Alfonso, deprived of the throne to which he acceded under his mother's regency, the day he was born, is doing all he can to keep his family together. It was rumored that he even forbade the queen and princesses to write the Prince of Asturias, in Lausanne with his sweetheart. But, it was learned also, the women of the family secretly admire the prince's determination and "booster" letters to him continuously.

HAWAIIAN BILL PASSED BY HOUSE

Washington, June 7 (AP)—The house today passed the bill permitting the president to name a non-resident governor of Hawaii.

The bill requested by President Roosevelt now goes to the senate. It was rejected by the house several days ago under a procedure which required a two-thirds vote for passage. Today's passage was obtained by a majority vote.

Democrats, despite their differences with the president in the last few days over "veteran's" economy, stood almost solidly behind the new bill.

COMPARISON OF ALLOWANCES GIVEN VETERANS

Washington, June 7 (AP)—The following approximate figures made public by an authority on veterans affairs show the effect of the president's modification order in veterans' cuts, as compared with what was planned for veterans under the 1934 budget, and the cuts made under the economy act:

Service connected cases: Under the budget, 380,000 veterans were to draw \$221,000,000. Under the economy act, 225,000 veterans were to draw \$65,000,000. This was a cut of approximately 40 per cent in numbers, 50 per cent in cash. The president's modification order would give to the 225,000 veterans about \$89,500,000.

The monthly average per veteran under the 1934 budget estimate was \$48; under the economy act \$23; under the modification order \$33.

Non-service connected cases: Under the 1934 budget estimate, 501,000 veterans, with disabilities ranging from 25 per cent up, were to receive \$101,000,000. Under the economy act, 48,500 totally disabled veterans were to get an average of \$20 a month. The president's order increased this to \$30 a month. The total received would thus be raised from approximately \$10,000,000 to approximately \$15,000,000.

Spanish war veterans: Under the 1934 budget estimate, 197,000 Spanish war veterans were to receive \$107,000,000. Under the economy act, \$82,600,000. Spanish war widows, under the 1934 budget, numbered 43,000 to receive \$17,000,000; under the economy act, 41,000 widows were to receive \$7,700,000. The president's modification order changed this only by providing that the \$6 rate for veterans 62 years and over should be raised to \$13 a month.

UMATILLAS PROTEST CHEMAWA CLOSURE
