LEGION PLANS CELEBRATION

Major numbers of the American Legion Fourth of July celebration were outlined for the general committee Monday night meeting at the chamber of commerce rooms. Special attractions for the evening of July 4 is not ready for public announcement, but the program will include fireworks and dancing at night and a free program of sports for youngsters during the morning.

The American Legion celebration this year, as last, will be for the one day and will be in the main in cooperation with the three-day rodeo to be offered at the state fair grounds by Ed Wright, who had charge of the state fair rodeo last year. Concessions on the fair grounds will be operated by the Legion for the three days, but on July 4 there will be no admission charged to the grounds and a charge made only for the rodeo itself, and for some special night attraction, possibly a prize fight or wrestling match.

All day attractions will be offered at a very nominal sum and the entire celebration handled along the same general lines of last year which met with general public approval.

Continuation Of—Forest Road Work

North Santiam road was not secured without a show of opposition, however, Commissioner Carl Washburn, of Eugene, lead the fight against the allocation and construction of the South Santiam road.

Leslie M. Scott, chairman of the commission, also objected to the allocation, asserting that there has been too much concentration on the North Santiam road.

ELLIS TELLS KIWANIS ABOUT WASHINGTON

Unless a person has been to Washington, D. C., in the last few years he would not recognize the place, so many changes have been made, particularly on Pennsylvania and the park area near the union station, according to William P. Ellis, attorney, who returned a week ago from the capital city in the interests of improvement of the Willamette river and the municipal dock. Ellis admits he has lost track of his visits there in the last eight or ten years but they are somewhere between 30 and 40. The government owns property and has it under private lease to a beer parlor operator near the war college, he said.

The memorial highway between Washington and Mt. Vernon is one of the few of its kind in the country. Ellis told the Kiwanis club members Tuesday night. Commercial traffic is heavy, and a big advertising poster which reads "King, Open's Thieves' Kitchen." The day following the graduation, June 24, 1888, the following account of the exercises appeared in the Salem Statesman: "A large crowd of parents and visitors were present at the graduation exercises of a class, public schools, held at East Salem school Friday evening. Ample accommodations for a big audience had been provided in the auditorium, on the first floor, a temporary platform having been erected in the south end of the room.

The first thing on the programme was an instrumental duet finely executed by Laura Minto and Ada Stapleton. This was followed by a declamation excellently delivered by John Reynolds, and a pleasant vocal solo sung by Ida Purvine. The acting charade by Miss Lena Crump, and the Messrs. Grace Newton and Nellie Southwick and Messrs. Mark Savage and Frank Matthews was splendidly performed and was one of the best appreciated pieces on the programme. A creditably played instrumental solo by Miss Nellie Southwick, and then the salutatory was delivered in a manly manner by Wilson McNary. The address to the class by Hon. T. J. Gregg, occupied twenty minutes, was unusually good and was full of sound advice.

SPokane Fliers KILLED AT BOISE

Boise, Idaho, June 13 (AP)—Flight Lieutenants George B. Hallett and Whitney Closser of the 16th observation squadron from Falls field, Spokane, Wash., were killed here today, crushed in the wreckage of their planes which crashed during maneuvers with the Idaho national guard.

Observers said the two planes were making an attack dive on a group of national guardsmen in simulation of wartime conditions when the craft locked wings. They crashed about 200 yards apart.

The accident occurred shortly before 8 a. m. army lieutenants was advised, the planes falling at a point south of the city where the guardsmen conduct part of their field maneuvers.

Neither plane burned but both were described as total wrecks.

The two planes arrived in Boise Sunday from Spokane and were to cooperate with the national guard until Wednesday in simulating attack conditions, and in giving artillery officers an opportunity to conduct fire from the planes.

Two other pilots, Captains Robert Owen and Claude Owen, not relatives, came with the planes from Spokane, but did not go up for the attack maneuvers today.
