DEATH SCENE PHOTOGRAPHS SHOWN TO JURY

San Jose, Cal., Aug. 29 (AP)—A gruesome exhibit—newest of a series of startling displays—plectorially presented the death scene of the Alameda County murder case today at David A. Lamson's trial today.

The young defendant, blanching as the state hung on the courtroom wall a picture of the bathroom of the Lamson Palo Alto home, taken soon after Mrs. Lamson's body was found in the bathtub Memorial day.

The dead woman's head and arms dangled over the edge of the tub that formed the central features of the exhibit. Nearby was the washstand which the defense may claim was the instrument of her death.

The seven men and five women holding the former Stanford Press executive's fate in their hands stared fascinated at the picture. Tears filled the eyes of Dr. Margaret Lamson and Mrs. Willis Tholts, sisters of the man accused of beating his wife to death because she allegedly deceived him and frustrated his love.

Few paid attention to the routine testimony of H. A. Zink, chief of police of Palo Alto.

The picture brought into the trial the stark realization of the violence of the campus Y.W.C.A. secretary's death. The top of her head was indicated, her arms hung limp, palms turned outward. The dead woman's body was able to give a slipper said to be Lamson's.

Blood and water spotted the floor of the little room where, through accident or murderous attack, the former Lamar, Mo., girl came to her death.

The victims, to whom death came instantly, were identified as Harry Mackley, 25, of New York, and Frank Keller, of St. Louis.

Having accomplished their deliberate executions the killers turned and walked hastily to a waiting sedan.

The car sped away. No witnesses obtained its license number.

The automobile in which Mackley and Keller drove to the Bella Napoli cafe, scene of the slayings, was registered to Sonia Drenick, of Long Beach.

Police took her into custody for questioning but she was able to give little information. She said Mackley formerly was her husband but that they were divorced in 1928. She said he came here recently from Kansas City and that last Wednesday she loaned him her car for a brief time in return for his promise to make installment payments due on it.

Hoffman, in his last moments refused to see his 82 year old mother, Mrs. Mary Hoffman of Great Falls, declined the usual last rites of a condemned man, refused to talk with anyone, and requested that he be permitted to climb the gallows unassisted.

TWO GANGSTERS SHOT TO DEATH

Los Angeles, Aug. 29 (AP)—A double gangland execution so daring that it amazed Los Angeles authorities, confronted police today.

With but meager clues to aid them, officers sought three well dressed men who strolled calmly into a cafe last night and shot two late diners.

The victims, to whom death came instantly, were identified as Harry Mackley, 25, of New York, and Frank Keller, of St. Louis.

Having accomplished their deliberate executions the killers turned and walked hastily to a waiting sedan.

The car sped away. No witnesses obtained its license number.

The automobile in which Mackley and Keller drove to the Bella Napoli cafe, scene of the slayings, was registered to Sonia Drenick, of Long Beach.

Police took her into custody for questioning but she was able to give little information. She said Mackley formerly was her husband but that they were divorced in 1928. She said he came here recently from Kansas City and that last Wednesday she loaned him her car for a brief time in return for his promise to make installment payments due on it.

MAC NAUGHTON URGES SUPPORT OF NRA EFFORT

Complete support of President Roosevelt's program seeking a solution to present economic conditions was urged upon the Kiwanis club Tuesday noon by E. B. MacNaughton, president of the First National bank of Portland, in an address on financial conditions. Solution of the debt program is the greatest question today, he said.

Current conditions are the result of an economic war out of which grew the military war which brought debt, inflation and also nationalism, the speaker stated. The greatest barrier to prosperity is the existing debt structure, with the consuming population decreased and incomes shrunken, MacNaughton said.

Mass production has been a national fetish leading only to destruction, he continued, and as a result of decisions forced upon the president and congress, business can never be the same in the future as it has in the past. The declining population tendency will bring a stagnation with about 1950 with births and deaths about equal, it has been predicted, he said.

To those who have plenty, the prospect of the future is not too pleasant, but recognition is given to the necessity of drastic and revolutionary measures unless the mass debt class rises and demands relief from its predicament.

MacNaughton did not visualize the guarantee of bank and business, but forecast governmental operation along the civil service type of control. The secret of branch banking lies with its administration and its benefits in the main outweigh those claimed for privately owned banks, he said.

Intimate relationship with a community, lacking under this method, has proven disastrous in many instances, with the private banker whose loans have not always been wisely made.

Special Session Looms As Scene of Battle If Truck Issue Injected

If and when the state legislature is called into special session this fall, and if the bars are let down to alterations in the law regulating, licensing and taxing motor trucks in the

Farmers association, representing some 18,000 individual owners of freight vehicles large and small, would stir up a hornets nest in the legislative halls and would precipitate such a campaign of lobbying and manipulating as has seldom been seen under the capitol dome.

Lined up in one camp would be the organized haulers, the so-called common and contract carriers, the oil companies and the loggers, who have always played a conspicuous and important part in the enactment of truck and bus legislation.

In another group would be the representatives of the railroads, the countervailing influence that has kept inspired lawmakers from turning the roads and highways over to the truckers.

Representing both would be the usual galaxy of transportation experts and attorneys. While founding, untiring and puzzled legislators wrestled with the intricate problems these professionals would be drafting plans and counter-plans, schedules and counter-schedules to further confuse the neophytes.

Added to their ranks would now be still another element to seek special privilege—the newly organized association of small truck owners, who have heretofore been scarcely represented in the writing of truck legislation. By reason of the sheer weight of their numbers and the wide spread of their organization they would be an important factor for a special session to consider with either of two proposals they have already suggested would be enough to start a legislative war of major dimensions.

At a meeting of delegates of the various locals of the Truck Owners and Farmers association here yesterday A. C. Anderson, president, proposed that the mileage tax plan be applied to about 800 trucks using the state's roads be extended to include all of the 33,724 licensed trucks.

What a road that would raise, if presented before a legislative committee for serious consideration.

Another plan, even more apt to provoke an eruption by the big truckers, was advanced by E. C. Bunker of Corvallis. He would place all trucks on the tax rolls and assess property taxes against them in proportion to their value. That, if nothing else, would serve to blow the lid off a special session.

There would be the traffic experts and attorneys of the highway department and the attorney general's office, fighting their usual battle to protect highway revenues from further depletion and safeguard the roads from the wear and tear inflicted, but never fully paid for by the commercial carriers.

In this instance the Truck Owners and Farmers association is the aggressor so far as the special session is concerned. It has appointed a legislative committee to formulate a specific program and will, according to Anderson, present and fight for that plan if the legislature is called to meet.

Not is there much prospect that the legislature could escape consideration of the truck problem if it meets. The Lewelling decision and its threat to state finances has created a situation too serious to be ignored. The lawmakers would have to face the music—and what a merry time it would be.

At their meeting here yesterday, attended by representatives of 20 or more local units over the state, the truck owners re-elected Anderson as president and installed E. K. Griffen of Roseburg, vice president; W. L. Carver of Salem, secretary; Percy Clippner of Salem, assistant secretary, and Paul Wallace of Salem, treasurer.

COURT RULING CURBS UTILITIES COMMISSIONER

The public utilities commissioner does not have jurisdiction over a case where the reasonableness of rates is not in question, ruled Judge Lewelling today in overruling a demurrer in the case of Oregon-Washington Railroad & Navigation company against C. M. Thomas, commissioner. He granted a writ of prohibition against the commissioner from proceeding further with investigating the case of Pacific Elevator company instituted before the commissioner against the railroad company.

In the case the elevator company stated it shipped grain from Eastern Oregon points to Portland. The rate charged was that allowed when part of an interstate shipment. The elevator company contended it was entitled to the intrastate rate which is lower and asked damages equal to the difference between the interstate and intrastate rate.
