Sneezing will be encouraged on the stage and each member of the cast will break a mirror. Actors will act as if they were struck by lightning and will recharge last lines, a sure "sign" of bad luck, before the play opens.

Of the 219 seventh grade students examined at Leslie junior high school, only 14 showed no physical defects, according to a report issued from the Marion county health department office today by Dr. Vernon Douglas, county physician.

Fifty two were found to have defective teeth, 29 had tonsils and 32 others showed physical trouble. Others had defects of other minor nature. Pupils in the upper grades were not included in the report, only the seventh graders and those who had transferred to the school since the close of last semester being examined.

Mrs. Luella Porter, long a resident of Salem and an Oregon pioneer, passed away at her home on South 18th street shortly after 1 o'clock this afternoon. She was 78 years old. Her sister, Mrs. Fannie Craig, of St. Joseph, Mo., who is the only survivor, was at her bedside. Funeral announcements will be announced later by the Clough-Barrick company.

Frederick S. Lamport, executor of the estate of Frank Carlson, has filed his semi-annual report which has been approved in probate.

The estate of Freeman A. Sargent has been admitted to probate with Fred S. Byron as administrator. The estate is valued at \$850.

The First National bank has filed its final account as administrator of the estate of Olin H. Turner.

Applications have been filed with the county clerk to have the cases of Mary Sucevich, and Mary Sucevich, administratrix, vs. N. T. Warren on the trial closed in circuit court.

In the case of Lula Della Etchison against Emory L. Clark, exceptors have been filed to annul the bond, it being alleged the sureties are not worth the \$1500 specified in the bond.

Forty six children were immunized for diphtheria during the month of September by attaches of the Marion county health department. Dr. Vernon Douglas, county health officer stated today. The report was made following the monthly meeting of the executive board of the health department. The total immunizations made during the year up to the first of October was placed at 713. Other activities of the department included, for the month of September, 70 vaccinations, 29 tuberculin tests, 99 examinations of infants and pre-school children; 694 school examinations, 361 inspections of school children for readmission to classes and for diagnosis, 36 food and milk handlers and distributors, 184 milk samples taken, 28 blood tests made, 101 visits made by nurses to school children and 44 throat cultures taken. The health department had the benefit of 31 1/2 hours of volunteer lay helpers and 18 hours of professional assistance.

Answers have been filed by N. T. Warren and Samuel M. Steinberg to damage actions brought against them by Mary Sucevich, as administratrix of the estate of Donald Sucevich, and as mother of the deceased, for the death of her son in an automobile driven by Warren. While the accident is admitted and that the boy's death ensued, general denial is made to other allegations. Warren is on bail pending trial for manslaughter in connection with the affair.

Order has been entered in circuit court for Richard Greening to appear at 10 o'clock, October 14, to give his deposition in the case brought by him as administrator of the estate of Marjorie Ann Greening against O. F. Johnson. The case involves damages for death after an automobile accident.

The case of Gabriel Powder & Supply company against Frank Loose, involving payment for a truck, was still being heard before a jury in Judge McMahan's court today.
