Farley Says Roosevelt to Avoid Perils

Cleveland, Jan. 13 (AP)—Postmaster General James A. Farley predicted today that President Roosevelt would not "spread his sails before the inflation gale, with all the perils that beset such a course."

The democratic national chairman asserted in a speech at the annual Cleveland automotive luncheon, that neither would the president "sacrifice the advances which have occurred in commodity prices by taking the views of the international bankers part."

"I know he has plumb the depths of all the arguments. I know that his policy comes from a ripened judgment and I do not fear that any of us need fear that where he has been right so often he is likely to go wrong in this particular field."

Farley praised congress for its cooperation with the president in last year's special session and expressed confidence that the present session would be as helpful.

He prophesied defeat in the next elections of "crusted old guardians and standpaters—men who still talk and think in archaic and outmoded terms and can do nothing but quibble and grumble in dull partisanship and creak their ancient party opposition to whatever is being offered."

"The people, because of their faith in Roosevelt," he concluded, "bore the inconvenience and discomfort which resulted with patience and good temper, and the results show that their faith was not misplaced. * * *

"It is my earnest belief that under his leadership we shall in good time come to a full realization of the hopes and ambitions of all good Americans for a restoration of our country's prosperity and the greater happiness of all our people."

decision is had on the constitutionality of the act, the commission may put the agency plan into effect before opening state stores, in order to gain early control over the sale of hard liquor.

It is said there is also a possibility that the commission may open three or four stores and a larger group of agencies simultaneously over the state, and announced that the date of opening would be determined this afternoon.

Relative to licenses for the retail of beer and wine containing less than 14 percent alcohol, the chairman said that it would be the policy of the commission to require the approval of all applications for licenses by the city council of the town in which the license is located, or the county court or district attorney of the county where the licensed place of business is outside the limits of an incorporated city or town.

The matter of headquarters was not decided, McMorran said, but he said he anticipated little difficulty in securing suitable quarters at the state capitol. He stated numerous applicants for positions under the administration, including inspectors, would be heard during the late afternoon.

Commissioner James D. Burns was not at the conference today, being unable to attend because of business in Seattle. It was learned, however, that the state will include in its inspection staff deputies, auditors and the like, and in the preliminary activities of the commission these employees will be utilized in choosing locations for stores and agencies, interviewing applicants for store managements, agencies and otherwise assisting in the set-up of the commission's machinery.

He said that the commission, which has considered the problem, has not made any definite decision as to how the issuance of liquor purchase permits is to be handled. To start things off it is possible, he stated, that the permits may be available at state liquor stores, but that the permanent policy will probably be to issue them through the county clerks or some similar channel. Purchasers of liquor are required to have these permits renewed each year, for which a charge of \$1 is made.

DAVID LAMAR WOLF OF WALL STREET PASSES

New York, Jan. 13 (AP)—David Lamar, "the wolf of Wall Street" who matched his wit against financiers and the law with varying success for more than three decades, died today apparently of a heart attack in his hotel suite here.

He was found dead in an old-fashioned flannel night-gown, surrounded by a collection of patent medicines. He had been at the hotel eight days, having come from another hotel where, it was said, he left, owing rent. Lamar was 66.

His death closed one of the most colorful—and troublesome—careers in American finance.

Recently, Lamar had been living quietly. A few years ago his name was synonymous with crafty market manipulation. He was dubbed the "Wolf" because his method of harassing the great Wall Street was likened to that of a predatory beast, snapping at the heels of his victims.

At times Lamar was impudent and brazen in his operations and in his boasting of them. He admitted often having posed as a senator or congressman to further some stock deal—and afterwards demanded to know what they could do about it.

Lamar was constantly in trouble with the courts, with his clients, with legislative investigations and the suits of persons claiming to have been tricked by his methods. During the war he was tried on a charge of helping Capt. Franz von Rintelen of the German navy to foment strikes in New York and Bridgeport. He and the captain were convicted in May, 1917, but Lamar succeeded in staying out of jail by invoking a long series of court orders staying his sentence, until 1923.

STEEL LIQUOR BILL IS SIGNED

Olympia, Wash., Jan. 13 (AP)—On the 13th day of the new year, Speaker George Yantis and President Vickers today signed and sent to the governor the Steel Liquor bill setting the state up in a \$2,000,000 liquor business.

Governor Clarence D. Martin was expected to sign the bill immediately, although he had 10 days to do so, and announce his three selections for the liquor control board next week.

Signing of the bill by Yantis and Meyers today dropped the curtain on the special session of the legislature on its 41st day. Representatives went home, many of them never to return to the capitol. All house members will be up for reelection in November, while 23 senators faced another campaign.

The Steel bill setting up about \$5 state-owned liquor stores in larger cities of the state was approved with startling swiftness by the senate Friday afternoon. It had passed the house earlier in the day.

Machinery of the state control system will not get under way until the three-man board has been selected. The first duty will be to sell \$1,500,000 worth of liquor revenue bonds, to be retired out of profits. Annual business was expected to total \$6,000,000.

NO WORD FROM SIX MISSIONARIES

Poochow, China, Jan. 13 (AP)—The fate of six American missionaries, isolated when sharp fighting broke out last week between nationalists and rebel armies, remained undetermined here today as Nanking forces seemed to be breaking the insurgents' resistance.

The workers, missionaries of the American Methodist Episcopal church, were trapped near Kullen, about 50 miles from Poochow.

No word has been received here from the missionaries, since the fighting became severe. Incomplete information available here indicated that they are:
