

INCOME TAXES IN FAR WEST SHOW INCREASE

Washington, Jan. 28 (AP)—Taxpayers in the 11 far western states poured \$30,000,000 more into the treasury this year than they did in 1934.

An internal revenue report disclosed today the increase came chiefly in income tax collections from corporations and individuals. Of the \$30,245,355 increase in collections from all sources, \$25,778,852 was in the income tax division. Corporations paid \$11,487,799 more in income taxes and individuals an additional \$14,300,053.

Total collections from the 11 states, comprised of income, and AAA processing taxes and miscellaneous receipts were \$256,093,017 in 1935, compared with \$225,844,862 in 1934.

In 1935, the states paid \$102,119,755 in income taxes, while in 1934 they paid \$78,340,093. Corporations paid \$51,851,521 in income taxes last year, and individuals paid \$50,268,231.

California was the banner state in the increase column. Approximately \$20,000,000 of the entire \$30,000,000 increase in the western states was credited to that state where individual income collections increased \$10,000,000, corporation collections \$6,000,000, and miscellaneous revenue approximately \$4,000,000.

California's payment of processing taxes, however, declined \$2,000,000.

Nevada was the only state showing a decrease in the total payments to the federal government. Although individual income taxes increased \$125,000 in that state, there was a general decrease in total payments of \$750,000.

All other states showed substantial increases in nearly every division.

POWER COMPANY SEEKS REFINANCING

The Hermiston Light & Power company applied with the public utilities commission today for permission to issue two eight percent 10-year notes, one for \$55,000 and one for \$30,000.

The larger note would be issued to the American States Public Service company, the smaller to the American States Electric company, both of Baltimore.

With the application the Hermiston company filed, under oath, a statement showing it paid dividends of 450 percent on common stock in 1933, 250 percent in 1934 and 25 percent in 1935.

The company operates in Umatilla county with offices in Hermiston and Los Angeles.

Windsor. One hundred thousand mourners were assembled along the mile and a half route from the railroad station to St. George's chapel.

An honor guard carried the coffin from the train over a scarlet carpet to a gilt carriage waiting at the station door. Then the procession started its uphill journey to Windsor castle.

The bell of curfew tower rang out across the ancient battlements of the royal palace—tolling for the dead master.

The new king, Edward VIII, and his three brothers, for the second time today, fell in behind their father's coffin to walk in procession.

They were preceded in the cortege by the widowed Queen Mary, who rode in a carriage drawn by Windsor greys.

The shrill notes of a boatwain's pipe sounded "Piping Aboard," the naval honor ceremonial, as the coffin was placed on the gun carriage.

It was part of the ritual in the funeral of an admiral of the fleet.

As the curfew bell rang, a minute gun began the salute as the cortege passed along a route massed with spectators and hung with heavy crepe.

As the procession reached the castle, the Archbishop of Canterbury and the Bishop of Winchester walked from St. George's chapel and stood on the steps under the high stained windows, waiting to receive the coffin.

The slow funeral march of a military band re-echoed in the stone courtyard.

Within the chapel, Prime Minister Baldwin, his cabinet, and other high government officials who had not walked in the procession, awaited the coffin.

Sharp military commands rang out as the funeral party halted in front of the wide west doors of the chapel.

King Edward, whose uniform boots were muddy from his walks through the streets of London and Windsor, stood silently as the coffin was lifted from the gun carriage and carried into the church through lines of honor guards.

It was placed on a bier near the fluted stalls of the Order of the Garter, the oldest chivalric organization in the country, whose spiritual headquarters are in St. George's.

Twice the piercing notes of the boatwain's pipe sounded as the coffin was removed and carried into the church.

The bagpipes played a last, mournful lament and the robed choir began its first hymn, ending with a soft "amen" just as Edward reached his place at the head of the coffin and the service began.

Irrigation Project Enters Final Phase

Grants Pass, Jan. 28 (AP)—RFC financing of the Grants Pass irrigation district entered its final phase today with transfer at Portland of \$27,382.99 by the federal reserve branch bank to the state reclamation commission for initial disbursements.

Complete refinancing will reduce the debt to \$278,221.76 on a basis of 18.481 cents on the dollar. The amount will be paid in the next 35 years. A million dollars of interest is canceled.

The present disbursement is for approximately 95 per cent. The amount already voluntarily deposited, at the rate of 17.841 cents of the dollar.

FILM TRADITION SHATTERED BY MAX REINHARDT

Max Reinhardt, who remolded three centuries of stage tradition, went to Hollywood, where tradition is rooted loosely in an experimental quarter century, to make "A Midsummer Night's Dream" for Warner Bros., the mammoth spectacle which comes to the Elsinore theater one day only, Thursday, February 6, for 2 performances, matinee 2:30 and evening 8:30.

As an artist he allows neither rules nor laws to circumscribe his genius.

Max Reinhardt was discovered in 1894 by the great Otto Brahm, entrepreneur of the Deutsches theater in Berlin.

At this time, the keynote of popular drama was "naturalism," a generic term to cover the sordid realism, with its drab dullness and perverted materialism.

Reinhardt, for six years, fought for fantasy and romanticism in the theater.

In 1905, he produced "A Midsummer Night's Dream" and followed it with Moliere, Goethe, Strindberg, Wedekind, Ibsen, Shaw and others.

With the resources of the great Warner Bros. organization at his command — unlimited technical facilities, stars and writers — this man whose genius rebuilt the world's stage, has shattered the comparatively young precedents of the screen.

"A Midsummer Night's Dream" is a mighty epic of the screen produced by Max Reinhardt, and directed by himself and William Dieterle. The dances were directed by Bronislawa Nijinska and Nina Theilade and set to the beautiful music of Mendelssohn as arranged by Erich Wolfgang Korngold.

SAYS SPIRITUAL REBIRTH NEEDED

Evanson, Ill., Jan. 28 (AP)—Payment of the bonus will retard economic recovery and national security, the Rev. Raymond B. Walker, Portland, Ore., told the annual national executive conference of the Congressional and Christian churches.

"The mad scramble for advantage at the expense of others is the contrary spirit to that which the country needs," Dr. Walker said. "Most pathetic is the philosophy that national prosperity will come by the strong winning out over the weak, or that world recovery will come as long as it is each nation for itself."

"Instead of junking the gold standard, repudiating debts and getting-the-bonus-now, there should be a renaissance of religion which must begin with the average man. There is wanted a spiritual rebirth and new power which should be evoked not from outside but from within the individual."

"What we ought to want is not California's Utopia, nor Washington's Commonwealth builders, nor Dr. Townsend's pension crusaders, nor Huey Long's share-the-wealth movement, nor Father Coughlin's league, but we should work for the greatest religious renaissance in history."

HANSEN RECEIVES THREATENING CALLS

Portland, Ore., Jan. 28 (AP)—Disension among Oregon's Townsend plan supporters has taken a new turn today when Charles E. Hansen, state manager of Townsend clubs, told police he had been threatened violence.

An unidentified man called him six times Monday and told him to resign in three days or "you won't be able to get out of town."

The asserted threats were linked with removal last week of Jack Barde, Portland, steel company president, as a Townsend speaker, because of alleged political maneuvering.

The caller opened each telephone conversation, Hansen said, with the question: "Are you the man who sent out the statement that Barde has been removed from the speakers' list?" Hansen replied that he was and received the three-day ultimatum. He said he was sure the same man made all the calls.

HURRICANE VICTIMS' BODIES IN SWAMP

Tavernier, Fla., Jan. 28 (AP)—The tangled mangrove swamp of Lignum Vitae key today gave up the bodies of five more victims of the September hurricane that killed an estimated 450 world war veterans and civilians.

Peace Justice E. R. Lowe, reporting the recovery of the bodies, said two of the dead had been tentatively identified, but names of the others never will be known as long exposure forestalled even the taking of fingerprints.

City Hall Ashes Are Hot for Four Years

Montgomery, Ala., Jan. 28 (AP)—Four years ago the Montgomery city hall burned to the ground. The fire department rolled up its hose and went home and, in time, people forgot about it except when they looked at the heap of debris.

A steam shovel hit into the remains yesterday and uncovered timbers still hot and smouldering.

Death of Ensign is Declared Accident

Bend, Ore., Jan. 28 (AP)—Death of Guy G. Ensign during a hunting trip in the upper Deschutes Saturday was accidental, state police said after an investigation.

James G. Crowell, Ensign's companion on the trip, was released. Sergeant Art Tuck said Ensign was killed by a double discharge from his own shotgun.

SLAYER INSANE SAYS MOTHER OF VAN VLACK

Twin Falls, Idaho, Jan. 28 (AP)—Mrs. Carl Van Vlack of Tacoma continued her testimony here today in the trial of her son, Douglas Van Vlack, for the murder of his former wife, Mildred Hook.

At one point in her detailed story of the defendant's marital difficulties she broke into tears when she said:

"I told him that Mildred is not the only girl in the world; you've got a long time to live."

Van Vlack, for whom the state attorneys are demanding a death sentence, squirmed uncomfortably at her fantasy and romanticism in the theater.

The first time she saw her son in jail here, Mrs. Van Vlack said, he was "just unconcerned, just as if nothing had happened—as if there was nothing to it."

She said Douglas told her "Mildred has gone home," and that she replied, "she should be home by now, then."

"She went home," the defendant reiterated, without any show of concern, Mrs. Van Vlack added.

He laughed when a cousin left his cell, and said: "Go ahead out; they wouldn't think of locking me in here." He "acted crazy," his mother testified.

the various funds. The general fund state levy is placed at 3.18; elementary school fund, 2.25; general fund county, 4.29; old age pension, 1.41; county school, 4.28; county library, .04; road fund, 1.77. The total state levy is 3.43; county levy, 5.7; county school and library, 4.27. The total state tax, including state levy and elementary school as well as reformation fee is \$331,663.42; total county, \$243,182.81; total county school and library, \$182,175.45, and county road, \$73,580.76, making a total for state and county of \$730,612.44.

A total gain of 3 mills is made for Salem city and Salem school, but the increase in the school district levy is comparatively very small, being but 9-10ths of a mill while the Salem city increase is 2.1 mills.

The school levy is 16.5 mills as compared to 15.3 mills last year while the city levy is 22.9 mills as compared to 20.8 mills a year ago.

native following in that section." Instead of following Smith on "a walk," if President Roosevelt is nominated, he said middlewestern and far western liberals were "quite likely to do the contrary."

In an attack on the Liberty League, at whose banquet Saturday night Smith said the administration had failed to carry out the 1932 platform, Ickes said "when you see such a group as assembled here in the name of liberty to preach the gospel of reaction, it makes the issue stand out pretty clearly."

"A billion dollar dinner was given here the other night," Lewis said, "and that dinner was addressed by a man who had made a reputation for himself as a great commander."

Scattered bows went up from the floor when he mentioned Smith's name.

"This man appeared before that billion dollar dinner and performed for his masters," he continued. "He said he was supremely happy and comfortable. After having established his comfortable status, for one hour he undertook to assail every act performed by the greatest humanitarian president the United States has ever had in the interest of the common people of this nation of ours."

The reference to President Roosevelt was cheered.

"And Alfred E. Smith from his position of supreme happiness and comfort offered to the 14,000,000 unemployed and their dependents for their supreme happiness and comfort only the ancient face of the constitution," Lewis proceeded.

"I heard him say once that the people down in his ward, when they wanted coal or food, could neither burn or eat the constitution of the United States or a decision."

"I tell him today that the people of the United States have the same reaction today as did those people down in his ward when he honestly represented them."

At the same time, political observers were waiting eagerly to hear what Senator Borah, who is boomed by his friends for the republican presidential nomination, will say when he takes the stump tonight in Brooklyn.

The speech which Robinson, the majority leader of the senate, will (Columbia Broadcasting system) network at 10 p.m., Eastern Standard time, is expected to give an indication of the administration's attitude toward the "walk" that Smith threatens to take.

As Robinson labored on the address, its contents were not disclosed, but the title, "The Hands of Esau," gave a hint of its nature. It recalled the story in Genesis of how Jacob obtained the blessing of his blind father Isaac.

Jacob put the skins of kids on his hands to disguise himself as the hairy-handed Esau, and it is recorded that Isaac said:

"The voice is Jacob's voice, but the hands are the hands of Esau."

ARMY FLIERS CRASH AT BOLLING FIELD

Washington, Jan. 28 (AP)—Two army fliers were injured fatally today when the plane in which they left Popplefield, Fort Bragg, N. C., this morning crashed in landing at Bolling field.

They were identified as Second Lieutenant William K. Payne of the air corps reserve and Lieutenant Dudley E. Whitten of Wharton, Texas.

Payne was killed instantly and Whitten died a few minutes later. A gust of wind which sent their plane suddenly out of control was believed to have caused the crash but officers declined an opinion pending further investigation.

50 PLEDGED TO TOWNSEND PLAN

Washington, Jan. 28 (AP)—The Townsend National Weekly today listed 50 representatives as "pledged" to support a bill to pay \$200 a month pension to citizens over 60.

The magazine, official organ of the pension plan, also listed 28 as "undecided" and 14 "opposed."

The pledges were obtained in a poll of the members of the house just before congress convened this month, the magazine said.

Thirteen of the 50 pledges were from representatives of California, the home state of Dr. F. E. Townsend, originator of the plan. Nine were republicans, two farmer-labor, two progressive and five rest democrats.
