INJUNCTION ON SAILOR LISTING SET FEB'Y 20

San Francisco, Feb. 13 (AP)—The federal government and maritime unions today waited for a hearing Feb. 20 on a temporary federal court injunction to determine whether attempts to enforce the continuous discharge book provision of the Copeland safety-at-sea act would result in another tieup of shipping on the Pacific coast.

The deadline was set after government officials yesterday refused to permit crews to sign on two vessels until they had accepted the books.

Nine union members of the Sailors, Firemen and Cooks and Stewards carried their protest to Federal Judge Michael J. Roche who issued a temporary restraining order preventing the government from enforcing the discharge book provision. The injunction was made returnable Feb. 20, the day when the act was to become effective.

The order restrained U. S. Shipping Commissioner John Rylander from refusing to permit ships to leave ports if manned by seamen who do not carry the books and averted temporarily a crisis which threatened to tie up Pacific coast shipping only a week after it had been resumed after a strike of more than three months.

More than 15,000 seagoing maritime workers already have pledged themselves to refuse to accept the books, charging that they would permit shipowners and employers to discriminate against individuals.

Both federal officials and union leaders, however, said that the situation was confused by reports from Washington that the department of commerce had postponed until March 25 the date on which the Copeland act was to become effective.

It was pointed out that it was their understanding that only an act of congress could amend the act and that there had been no congressional action.

A so-called postponement previously was "explained" by department of commerce officials as being due to their inability to prepare and distribute the books on time.

This in spite of the claims of Ray Gill and others of the executive and legislative committees of the grange that organization was opposed to the measures. So active have the state grange officials been in opposition to the bills on behalf of their organized labor allies that members of the grange committee have been buttonholing members on the floor of the house.

Morton Tompkins, one of Gill's chief lieutenants, was busy circulating among members inside the rail of the house this morning while the labor bills were under consideration.

There was no definite indication of what amendments might be made to the bills in the administration committee, of which Rep. T. A. Laveley is chairman, or when they may be reported back to the house for further action. But it is considered probable that their proponents may seek to secure passage of two similar bills pending in the senate before bringing the house bills out again.

Both of the senate bills carry the names of Senator Duncan and Rep. McAllister. One defines "labor disputes" and prohibits picketing and the other provides for the submission of all labor disputes to the state board of conciliation.

Indicative of the determination of the producers and shippers behind the anti-strike proposal to force some remedial legislation is the statement made today by H. L. Snodgrass, here representing Hood River agricultural interests, who expressed disappointment with the action of the house in not passing the two bills it had before it this morning.

"I am certain that unless this legislation or some similar legislation is passed out of this legislature, the agricultural interests of the state will initiate a law to protect their interests and permit them to market their products without interference."

Adding fuel to the fire of the indignation of producers and shippers sponsoring the bills toward Gill and his Grange cohorts, whom they charge with selling out the farmers of the state to organized labor for political reasons, was a statement issued yesterday by the Grange legislative committee embodying its ideas of desirable labor legislation.

The statement advocates the creation of a separate labor conciliation board for farm troubles—a hand-picked board without powers to act in any other than an advisory capacity.

Among the board's duties and powers would be the following:

To investigate farm labor requirements in advance of the harvest season.

To encourage growers to fix harvest labor prices in advance of the harvest season and to require them to file such schedules with the board.

To notify laborers of the establishment of pay schedules and to hold hearings on any protests workers may file.

To "use its influence to conciliate the opposing opinions regarding wages scales filed."

To encourage the appointment of boards of arbitration to settle such disagreements.

To require organizers of farm laborers to show cards indicating their identity.

To hold public hearings on pay of \$5 a day and expenses for each member of the board.

thereby prolonging the life of the proposals to require all labor organizations to register with the state corporation commissioner and to forbid "sympathetic" strikes.

While it is generally understood that the move to re-refer grew out of the inability of sponsors of the bills to muster sufficient votes to override the adverse report of the committee on labor and industries, Chairman Phil Brady of the labor committee, made a vain fight to prevent re-reference.

The statement advocates the creation of a separate labor conciliation board for farm troubles—a hand-picked board without powers to act in any other than an advisory capacity.

Among the board's duties and powers would be the following:

To investigate farm labor requirements in advance of the harvest season.

To encourage growers to fix harvest labor prices in advance of the harvest season and to require them to file such schedules with the board.

To notify laborers of the establishment of pay schedules and to hold hearings on any protests workers may file.

To "use its influence to conciliate the opposing opinions regarding wages scales filed."

To encourage the appointment of boards of arbitration to settle such disagreements.

To require organizers of farm laborers to show cards indicating their identity.

To hold public hearings on pay of \$5 a day and expenses for each member of the board.
