

SECOND ANNUAL FLAX FESTIVAL PLANNED EARLIER

MT. ANGEL CLUB STARTS PROJECT MIDDLE AUGUST

At the regular meeting and luncheon held Monday noon in the Mt. Angel hotel, the members of the Mt. Angel Business Men's club decided to sponsor the second annual flax festival with a two-day celebration August 13 and 14.

The tentative program submitted by the committee in charge, W. D. Harris, O. L. Williams, Leonard Fisher, Edward C. Unger, Fred J. Schlabach, T. B. Endres and E. B. Stollwerck, was accepted by the club. Fletcher Lynn of the Vancouver Linn Mills was present at the meeting and stated that they would be glad to bring a float to this year's flax festival. He also offered to donate \$25 worth of linen yarns in prize packages and will cooperate as far as possible with the festival.

Fred J. Schwab, manager of the Mt. Angel Flax Growers' association, informed the club that the WPA will again put on a play for the festival and that the arrangements will be made at a meeting Monday evening.

The program as outlined by the committee will include a queen's contest with the girl selling the most tickets to the queen's ball as queen and the next two highest as princesses.

The queen will be allowed \$10 toward her wardrobe and the princesses will each receive \$5. The opening event of the festival will be the crowning of the queen followed by the queen's ball on Friday evening, August 13.

The queen will be crowned by Governor Martin after which she will be escorted by the governor in the grand march followed by the princesses who will be escorted by prominent officials.

On Saturday morning, August 14, an open house will be held at the flax plant from 10 to 12 with someone such as L. L. Laws present to explain about flax and several escorts or guides to be provided by the flax plant. Saturday afternoon at 2 o'clock a parade will be held with the dominant theme being flax with prizes being offered for the best floats in both the commercial and individual classes.

After the parade a softball game will be played between the All-Star players and an outside team with admission to be free. In the evening a stage play will be given by the WPA players if possible at the ball park. The festival will close late Saturday evening with fireworks by the Shell Oil company.

The Business Men's club will hold a special meeting Thursday evening in regard to the celebration.

BACH BUILDING ALMOST READY; TRIES SUICIDE

All confectionery equipment will be new with the exception of the fountain, which was salvaged from the fire and will be repaired and rebuilt.

HALF MILLION CASH BALANCE LEFT IN LINN

Albany—Linn county's treasurer has received \$1,065,940.73 from all sources since the beginning of this year, and expenditures have totaled \$555,528.33 in cash, leaving a cash balance totaling \$510,412.40 in its coffers. It was reported by the county treasurer. The report covers the period from January 1 to July 1, 1937.

The summary reveals that the county has actually received \$730,839.46 from taxes and other income sources since the first of this year, and that it started the year with a balance of \$335,101.27, consisting chiefly of delinquent tax accumulations in the several county funds.

In major current funds the following balances were noted: General fund, \$68,231.92; general road fund, \$80,204.19; road district fund, \$9,940.41; market road fund, \$21,303.13; city fund, \$7,396.96; dog fund, \$3,101.10; old age pension fund, \$24,403.54; sheriff's depository account, undistributed at the time the report was made, \$114,476.59; forest patrol fund, \$1,582.76; Linn county fair fund, \$2,057.95; tax land sales fund, \$19,047.06; state tax and elementary school fund, \$45,318.47; union high school fund, \$8,520.48; non-high school district fund, \$12,718.57; common school fund, \$55,092.31; special school district fund, \$21,312.24.

Several other funds show balances. While the semi-annual report is conclusive, county officials pointed out that it at least reveals the county's current financial condition is excellent.

The county has no outstanding indebtedness, either in bonds or warrants.

WHITE & KING FAMILIES HOLD ANNUAL AFFAIR

Victor Point—Over 100 descendants of the White and King claim for their first annual reunion at the Silver Falls state park Sunday.

A short history of the family was given by Mrs. Ledgewood, who told the group that the King family were of English descent, the Oregon branch of the family headed by Thomas King, who was born in Ross county, Ohio, September 27, 1820, later lived in Iowa and Missouri, married Harriet Downing and crossed the plains to Oregon in 1852, settling first where the city of east Portland is now located, and later moving to the Waldo Hills. They had seven children, all now deceased.

Two sons and a daughter of the Kings married two daughters and a son of Thomas Jefferson White and Rachel Merrifield White, who crossed the plains from Idaho in 1862. The Whites, upon reaching Oregon, lived at La Grande a short time and then moved to the Union Hill district. Of the eleven children only two are living and both attended the reunion Sunday. They are Mrs. Myrtle E. Hunt of Union Hill and Thomas C. White of Salem. Mrs. Hunt was the oldest member of the clan present and Clifford Keith Scott, small son of Mr. and Mrs. V. D. Scott, the youngest.

The White family are descendants of John White, who with his family came to this country on the Mayflower and the cradle of his son, Peregrine White, is now in Pilgrim Hall at Plymouth, Massachusetts. Pictures of this cradle are owned by Mrs. Myrtle Hunt, a daughter, and Miss Bernadine White, a great granddaughter of T. J. White.
