

# Stocks Rally Up to 3 Points In Light Trading

New York, March 21 (AP)—The stock market rallied today after five sessions of decline. Trading lightened. Gains ranged to more than 3 points. The advance was ascribed more to technical factors than to any real demand. The European situation was quieter and the London stock market made a substantial gain.

Bonds were better. U. S. government issues improved and Prague 7 1/2 rebounded 5 points to 35 after the recent wide break. Foreign currencies were steady. Commodities were mixed, with wheat and cotton easier and copper, rubber, hides and silk firm.

Financial sentiment was improved by indications that the country's stock exchanges and the securities and exchange commission would overcome differences and work out a plan for revision of certain sections on the securities act of 1934.

Firmer prices for copper and outlook for bigger demand for the metal for armament expansion brought good buying into copper shares. Another factor was word that the Chilean senate finance committee is considering a plan to supplement the proposed copper export tax with a higher income tax on copper producers.

Railroad issues showed gains ranging to more than a point. Motors were strong, with Chrysler and General Motors up more than a point each.

# 22 New Laws Get Sprague's Signature

Governor Charles A. Sprague today signed 22 bills passed by the recent legislative session, but saving the axe on the emergency clause of a bill appropriating \$100,000 for purchase of additional capital grounds.

The appropriation will be at the disposal of the board of control during the 1939-40 biennium to buy property adjacent to present capitol grounds.

Another bill signed today would prohibit admission of any minor child under 14 to the Oregon Industrial school for girls or the state training school.

# Expenditure Suit Delayed

Arguments which were slated today before Judge Lewelling in the case of D. E. Nickerson, executive secretary of the state federation of labor, against Horace Mecklem and others involving publication of contributions and expenditures in support of the anti-picketing bill during the last campaign, did not come off as scheduled. Judge Lewelling stated that an extension of time had been granted the attorneys because of the late adjournment of the legislature, attorneys for the defendants having stated that they did not wish the matter to come up until Ralph E. Moody had been released from his duties in connection with the legislature.

Under an agreement made at the last motion day the briefs were to have been on file by today, the defendants to file first and plaintiff to answer. However, the defendants' counsel at that time said they wished the arrangement to be predicated on the possibility of Moody being able to participate and after this agreement was made with the court for extension of time, both for filing briefs and the oral arguments.

In another labor case, that of Beutler-Quistad Lumber company vs. United Brotherhood of Carpenters and Joiners, Salem local and others, an affidavit of prejudice was filed today against Judge Lewelling.

The motion for change of judge was filed by Edwin Goodenough, local attorney, but the motion was supported by an affidavit by C. W. Cray for the unions. A demurrer also was filed alleging the complaint does not state facts sufficient to constitute a cause of action. In this suit a temporary restraining order has been filed to restrain alleged union interference with the employees of the lumber company, the case being considered a test of the new anti-picketing law.

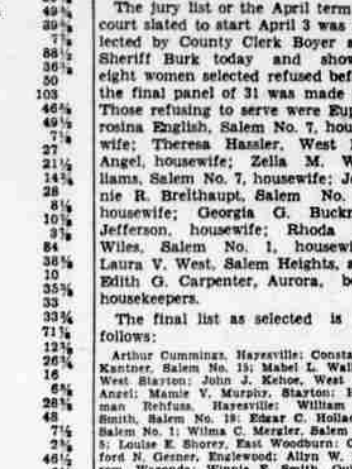

# Oregon WPA May Be Cut to 15,800

Portland, March 21 (AP)—Oregon's WPA employment quota would be cut to 15,800 persons April 3 if congress failed to appropriate an additional \$150,000,000, E. J. Griffith, state administrator, said today.

The quota in March was 18,500.

F. C. Harrington, federal administrator, advised Griffith that in selecting projects for discontinuance "an increase in efficiency of the works program be sought." He recommended eliminations of projects of all types, both construction and non-construction. No reductions, however, would be made on federal agency projects and WPA federally sponsored nation wide projects.

Proposed methods of elimination included reduction on projects where cuts would not seriously affect efficiency; termination of the least desirable projects upon completion of useful units; discontinuance of projects on which federal costs are unusually high because of insufficient local participation; possible discontinuance in areas where the operation is so small the costs are excessive; discontinuance of projects with excessive costs for transportation of workers borne by federal funds.

# Transport Pilots Called to Defense

San Francisco, March 21 (AP)—Air Transport Pilot Charles B. Stead and two airport dispatches were scheduled to testify today before Harrie Branch in an effort to retain his ratings of competency they must have to continue their aviation careers.

Their licenses were suspended after loss of a transport plane off Point Reyes, Calif., November 29, when the crash of five persons. Stead was one of two survivors. He helped save the life of his companion in the rough seas.

Philip Showalter and Thomas Van Selver, dispatchers at the Oakland airport, were criticized for directions sent en route from Medford, Ore., to Oakland, and flew far to sea before finally setting down on the water off the rocky coast.

Yesterday's testimony was largely concerned with weather conditions prevailing when the ship was given the go-ahead signal at Medford.

# Wheat Purchase Plan Approved

Washington, March 21 (AP)—A proposal for the federal wheat commodities corporation to purchase all wheat held by the commodity credit corporation when the 1938 loans expire was approved in principle yesterday by the agriculture department.

Producers would have from April 1 to June 15 to redeem the wheat. The wheat would be used in future government export programs and for domestic relief purposes.

Approximately 81,000,000 bushels were held by the commodity credit corporation.
