## College Pledged To Patriotism

Corvallis, Sept. 21 (AP)—President Frank L. Ballard pledged Oregon State College yesterday to the loyal discharge of its patriotic responsibilities to the state and nation.

The new president, addressing the faculty for the first time, urged continuation of the ideals of service, character development, co-operation and industry.

He warned against over-specialization in education and asked that consideration be given the needs of students who are unable to complete a four-year course in one institution under the state board of higher education's non-duplicating system.

## Spanish Press Exultant

Madrid, Sept. 21 (AP)—The Spanish press reflected some eagerness today over British-American collaboration and declared that Spain had never renounced her claim to leadership in Latin America.

Despite what it said were indications of United States preparations to increase aid to Britain, the press took the position that such help would be too late.

Francisco Lucientes, Berlin correspondent of the newspaper Ya, scorned as "a drop of water" proposals by which he said the United States might furnish 15 submarines and 30 freighters to the British.

(There have been no indications in Washington of any projected delivery of submarines to Britain. She obtained 50 over-age destroyers from the United States in exchange for Western hemisphere defense bases. Washington has announced that some 30 old freighters might be put up shortly for sale to the highest bidder.)

The Madrid press, counting Britain's defeat as certain, exulted over the share Spain is to have in the "reorganization of a new world" by Germany and Italy.

Ya's Berlin correspondent declared the axis powers and Spain had joined hands for a "just reorganization" of Africa.

## Bulgarians in Dobruja Again

Varna, Bulgaria, Sept. 21 (AP)—Flag-decorated border villages today welcomed the vanguard of Bulgarian officials and troops reclaiming southern Dobruja, lost in war and regained from weakened Rumania without a fight after 28 years of dispute.

While today's formal entry into Dobruja extended Bulgaria's Black Sea front to the north, many Bulgarians clamored for similar expansion to the south.

They urged that Greece be forced to return Thrace and Macedonia, which Bulgaria lost in post World war treaties, cutting her off from the Aegean sea.

Although complete occupation of the territory ceded by Rumania is expected to take ten days, Bulgarian officials said the first section would be occupied in 24 hours after the dynamiting of the old frontier markers.

## Final Rites Held for Winifred Mosher

Portland, Sept. 21 (AP)—Final rites were held here yesterday for Miss Winifred Mosher, 80, daughter of the late Judge and Mrs. L. F. Mosher of Roseburg, and granddaughter of General Joseph Lane.

Miss Mosher spent 53 years as a teacher, starting in Roseburg as a young woman. She taught in Portland schools many years.

## FDR to Name Draft Board

Washington, Sept. 21 (AP)—A civilian advisory committee designed to represent the views of non-military interests in organizing and administering the draft is expected to be named soon by President Roosevelt.

Probably consisting of six members, it will include, informed officials said today, four experts on various phases of conscription who already are working with the army and navy selective service committee on the gigantic task of drawing thousands of men from civilian life into the army.

These four are Frederick Osborne, an expert on statistics, chairman of the group; Col. William Draper, an army reserve officer and former member of the New York investment house of Dillon, Read & Co.; Joseph P. Harris, professor of political science at the University of California, and an expert on elections; and Dr. Floyd W. Reeves, director of the American youth commission.

Officials said that these men and two others probably would be named to the advisory committee when Mr. Roosevelt appoints a director of selective service, or soon thereafter.

Meanwhile in preparation for calling the first contingent of 75,000 conscripts in November, subsequent to registration of all men 21 through 35 October 16, the senate yesterday rushed a \$338,253,902 army housing bill through final passage and sent it to the White House. The money will be used to build barracks and other facilities.

## Farewell for Troops Planned

Final plans for the public farewell to Salem national guardsmen leaving Monday morning for a year's federal military training were being completed today by L. L. Pittenger, chairman of the American Legion send-off committee.

While the infantry troops leave at 8 o'clock, too early to expect any substantial turnout at the Southern Pacific, the artillerymen leave by train at 8:10 o'clock and will receive the greatest portion of the farewell. Two bands and representatives of patriotic and civic organizations will be on hand, including the sheriff's mounted posse and Cherrians. All who can be asked to wear Veteran of Foreign War or Legion caps.

Check-up of the proceeds from the benefit dance, sponsored at Crystal Gardens last night by the Chamber of Commerce, indicated receipts of approximately \$400. Tom Hill, chairman, said today. This money will be used to purchase athletic equipment for the men in camps.

## Nazi Oil Plants Bombed by RAF

London, Sept. 21 (AP)—The RAF has "visited and bombed" 90 per cent of Germany's synthetic oil plants and 80 per cent of her regular oil refineries, Hugh Dalton, minister of economic warfare, declared today in a speech at Spennymoor, near Durham.

"These targets have been heavily hit, even though production still continues at a reduced rate," he said.

Dalton added that German air raids "only are increasing our will to fight on until a decisive victory is won" and that the RAF is "destroying Hitler's power to wage war."

## Nazi Leader in Uruguay Arrested

Montevideo, Uruguay, Sept. 21 (AP)—Arrests of Germans charged with anti-governmental activities today were reported to have resulted in seizure of Arnulf Fuhmann, reputedly the leader of a Nazi movement throughout South America.

Fuhmann was said to be a native German but a naturalized Argentinian. He was said to have been arrested at Salto, Uruguay.

Three Germans were seized and detention warrants were issued against five others in a renewal of an anti-Nazi drive that started in June.

## London Steeled For Victory

New York, Sept. 21 (AP)—In a two-way trans-Atlantic broadcast today, Sir George Broadbent, former lord mayor of London, declared "London has steeled herself for resistance and victory," and New York's Mayor F. H. LaGuardia replied with a "bravo, London!"

In his broadcast to the United States conference of mayors, Sir George said London would be defended to the last as "the very bulwark of civilization as we know it."

Never before had London faced an ordeal "so cruel, so searching" as the daily bombings, he declared.

Mayor LaGuardia replied "Bravo London! We have listened to you with fascinated admiration. How trivial and unimportant are the problems we have been discussing compared with the conditions you have been so successfully meeting."

"I pray for the speedy and successful completion of your great fight. We are praying for you. Thumbs up, London, thumbs up!"

Sir George spoke on behalf of the present Lord Mayor, Sir William G. Cosen, who was in the London studio, but unable to deliver his address because of a sore throat.

## Spare Room Problem Met By Legionnaires

Boston, Sept. 21 (AP)—This city of almost 800,000 population encountered a "spare room" problem today as it welcomed throngs of American Legionnaires arriving for their second national convention here since 1930.

Legion officials said they expected an attendance of 300,000—World war veterans and their families—for the three-day session starting Monday.

With hotels and lodging houses enjoying capably business, reservations for the overflow were booked at points as distant as Worcester, 40 miles west, and Plymouth, equally far away.

Tourist camps for miles around were called into service. Some visitors planned to sleep at the homes of local Legionnaires, some in sleeping trains and others on a steamship tied up here for the occasion.

The big event of the convention—at least from the general public's viewpoint—will be the Legion's 22nd annual parade next Tuesday.

While a carnival spirit prevailed, Legion leaders heralded the convention as the most important in the organization's history, largely because of issues raised by warfare abroad. "Americanism" will be the keynote.

Ten Legionnaires have announced their candidacy for the post of national commander, now held by Raymond J. Kelly of Detroit.

## Nazi Troops Drown at Sea

Jersey City, N. J., Sept. 21 (AP)—Dutch citizens arriving yesterday aboard the American export liner Everet told of seeing thousands of German soldiers drowned while practicing maneuvers designed to prepare them for an invasion of Great Britain.

"The German soldiers," said one Dutch passenger who refused to give his name, "were heavily armed and weighted down with full equipment. They were taken a mile or so to sea (off the Netherlands coast) aboard flat-bottomed boats."

"The boats would come toward shore and the men were forced to leap out and swim. We people living near by saw thousands of bodies of officers and men floating in the water."

"Many soldiers rebelled and were chained and taken back to the interior of Germany to be punished for their insubordination."

This passenger and others who told similar stories refused to give their names because they feared harm might come to their relatives back home in German-occupied territory.

## Corwin Speaks to Hi Y Committee

Membership in Hi-Y brings with it an increasing interest in public affairs, a situation which is highly desirable at this time was the statement of George Corwin, member of the national council of Hi-Y of New York City, during an informal address before the boys' work committee of the Salem YMCA Saturday noon.

Corwin brought his impressions of the various trends in boys' work gathered from his travels throughout the nation.

Corwin declared that the Hi-Y clubs were proving "great training grounds for democracy." Renewed interest in Christian emphasis is directly the result of the Hi-Y, the speaker said.

Corwin, who has been touring the state with Everett Harding of the Portland YMCA, will attend the local Y's annual planning conference to be held tonight and Sunday at the Silver Creek recreation area.

## New Hebrides Goes Over to de Gaulle

Vichy, France, Sept. 21 (AP)—The colonial administration of the New Hebrides, French islands in the Pacific, has gone over to General Charles de Gaulle and the government of New Caledonia, a French spokesman said today.

The New Hebrides, some of whose natives still practice cannibalism, are about 50 miles from New Caledonia and the administration is shared by British and French commissioners. They amount to 5,700 square miles with a population of about 40,000 natives and about 1,000 Europeans.

The alignment of New Caledonia with the so-called "free" French government at London under General de Gaulle was effected several days ago.

## Elliott Roosevelt Enlists in Air Corps

Hyde Park, Sept. 21 (AP)—Stephen Early, White House press secretary, said today the president's son, Elliott Roosevelt, had applied in Washington yesterday for a commission in the air corps.

Pointing out that the action was entirely on Elliott's initiative, Early said the president had no connection with the matter.

## Pollution Fight Tentatively Planned

Portland, Sept. 21 (AP)—Plans for a joint survey of pollution in the Columbia river have been tentatively agreed upon by Oregon and Washington bodies, the Oregon sanitary authority announced yesterday.

The authority ordered Lebanon to eliminate pollution in the South Santiam river and Marks slough and warned cities in the Tualatin and Willamette river watersheds against polluting streams.
