McEwen Held on Murder Charge

Edward Charles McEwen, in county jail here awaiting ar-rival of officers from Phoenix, Ariz., who expect to return him there where he will answer to a murder charge, will also be looked over Wednesday by Deputy Sheriff Probst from Amaril-lo, Texas, to see if he can be tied in with a murder commit-ted there June 22.

The deputy sheriff from Tex-as contacted Sheriff Denver Young by telephone from Grants Pass saying he was out here on an investigation of that murder and he would like to get a chance look at McEwen and talk to him as there were some similarities in description be-tween the Texas suspect and McEwen, enough at least so he thought it would warrant a trip here to look him over. Sheriff Young told him to come ahead. McEwen is wanted at Phoe-

nix, Ariz., as a suspect in con-nection with the murder of a rancher there.
