## Farm Sessions On Schedule

The first of a series of meetings involving growers of various agricultural commodities will be held next week, according to announcement by William H. Byers, recently named coordinator for the farm labor council.

Byers and Claude Litchfield, farm labor market man for the employment service, will attend the conferences.

Monday noon in the Marine room of the Marion hotel, hop growers will meet with the coordinator, Strawberry, cane fruit and other berry growers will meet at 8 o'clock Monday night in the Blue Lake cannery cafeteria. Prune and nut growers will confer at 8 o'clock Tuesday night at Blue Lake and onion, mint, flax, peach, carrot and growers of miscellaneous crops are slated to confer at 8 o'clock Wednesday night at the Blue Lakes plant.

All groups will name representatives to the farm labor council as well as elect five members to represent their commodity organizations.

Growers are being urged to attend their divisional conferences.

## Hop Growers Protest Pact

Portland, March 21 (AP)—The transfer of hop marketing rights from one grower to another under the diversion privilege of the federal hop marketing agreement, was sharply criticized by hop growers discussing the marketing program.

"Any type of diversion privilege defeats the purpose of the program," Milo Lesh, Yakima, manager of the Washington state hop growers cooperative, told a hearing on proposed agreement amendments. His view was supported by other Washington growers. One, William Kamasah, Yakima, said he got more for marketing certificates on 40 acres of unharvested crops than for the 40 acres of hops he harvested.

Laurence Brulotte, another Yakima grower, told the hearing the small grower is restricted by the diversion privilege, but that the big growers who can lease additional acreage to get more marketing rights are helped.

Two Oregon growers, Harvey Kaser, Silverton, and Eugene McCarthy, Salem, testified they bought diversion certificates from other growers so they could market their own surplus hops last year.

West coast growers are considering 18 proposed changes in the marketing agreement. The diversion privilege is the most controversial.

California and Idaho growers favor a proposal to limit diversion to half of a grower's unharvested crop.

## 150 Fail to Seek Pensions

An approximately 150 persons, 65 years or older, living in the Salem area and who are entitled to old age insurance checks have failed to make application for the money to which they are entitled. This is the estimate of Richard C. Stillwell, manager of the Salem office of the U.S. bureau of old age and survivors insurance.

Unless the persons involved make application before April 1 they will lose benefits of last September. Under the law the agency can reach back no more than six months to make payments.

Many persons who are protected under the act do not realize that they are entitled to monthly checks, states Stillwell. He suggests that those who feel they may be covered contact his office, located in the post office building. A thorough investigation will then be made.

Stillwell states that every possible clue is being run down by his office in order that those entitled to pension that may be received.

## Big Week-end At Air Facility

## Oregonian Killed In Philippines

Manila, March 21 (AP)—U. S. Ambassador Myron M. Cowen tonight warned Americans in remote areas to take precautions for their safety.

His warning followed his investigation of the executions last night of two Americans—one of them from Oregon—and an Australian by communist-led Hukbalahaps 15 miles east of Manila. An eyewitness told Cowen the three were bound and shot to death after 50 hukbalahaps looted their dairy farm.

Army patrols directed by Defense Secretary Ramon Magsaysay clashed today with 50 Huks, reported to be the raiding band. The Huks escaped.

The slain Americans were John Hardie, a native of Condon, Ore.; his wife, Irene Wilkins Hardie, reported a native of Hilmar, Calif., and Australian Donald Capuano, their farm manager.

Paul Day, a mechanic at the dairy, said 30 Huks looted the place, then left a 10-man execution squad which tied their victims' hands, marched them into the yard and shot them down with automatic weapons.

Day said he and 35 Filipino employees were kept under guard while the Huks looted the place, then killed the three.

Cowen expressed concern over the killings. He visited the scene today. He said he calmed the fears of some Americans who had expressed doubt the Filipino army could protect them.

John Hardie, slain in the Philippines, was a brother of James A. Hardie, who lives in Salem at 1748 B street and is with the state highway department; also a brother of State Senator Stewart Hardie of Condon.

Other survivors are brothers William and Alex Condon; and four sisters, Mrs. Charles Palmer and Mrs. Grace Stenfield, Condon; Mrs. Madge Seull, Moro, and Mrs. Adolph Andries, San Francisco.

Condon, March 21 (AP)—Hardie was a member of a prominent family of eastern Oregon.

An Oregon State college graduate, he served in the Philippines in World War II with the rank of captain. He taught school and operated a dairy at Hilmar, Calif., before the war. He was married in California.

Much of the equipment and stock on the Hardie dairy farm was shipped to Manila from Condon.

## Costello Again

With the same sullen stubbornness he has displayed when the matter came up previously, Costello said the committee was asking for information it had no right to.

Prior to Costello's appearance, the committee issued a second invitation to New York Gov. Thomas E. Dewey to appear before it about gambling at Saratoga Springs, N.Y.

Sen. Charles Tobey (R., N.Y.) said Costello's refusal to answer "makes us suspicious and I don't want to be suspicious."

"The world can't think well of a man who covers up," he added.

Costello had disclosed he has around \$150,000 in cash in his home safe and in two bank accounts, but beyond that, he contended his holdings are his own affair.

"Do you have a safe deposit box anywhere else other than in your home?" asked Committee counsel Rudolph Halley.

Costello stared at the ceiling momentarily, blinking into the white, hot glare of Klieg lights. Then he said in his hoarse, thin voice: "No."

## Half Chance to Avoid War, Eckhardt Tells Audience

Dr. Tibor Eckhardt, former member of the Hungarian parliament and unquestionably the most brilliant person yet to appear before the Salem Knife and Fork club, gave a forthright and deadly serious talk concerning the political, ideological and deadly military struggle in Europe, Tuesday night.

Dr. Eckhardt, at the outset of his address, remarked that it is much more difficult to work out a satisfactory peace treaty than it is to win a war. In this connection he believes there remains a 50 percent chance to avoid war between the western world and Russia. However, the United States remains the only country that is powerful enough to successfully assume the role of "the last hope of the world."

The most serious mistake the allies made at the close of World War II was their failure to maintain military strength in Europe, asserted Dr. Eckhardt. Since force is the only thing that impresses an Oriental mind like that of Stalin, a show of military power would have kept the communists in bounds.

**Present Set-up Can't Remain**  
Partition of Europe into two parts, an arrangement to which the United States was a party, cannot remain, declared Dr. Eckhardt. "Either Russia will grab all of Europe or, if convinced that war would be fatal to its aspiration, it will retreat behind its own boundaries."

The provision that Marshall plan money could not be used for military purposes was another mistake, in the opinion of the former Hungarian official. The allied plan of forming political parties to the neglect of military strength was quickly seized upon by Stalin who now is able to exert armed force pressure upon all countries bordering on Russia. Dr. Eckhardt pointed out that by July 1 Hungary alone will have 12 divisions. This is one more than the United States has under arms.

Stalin was pictured as a shrewd calculating Oriental who always tries the less dangerous methods of gaining his ends. "The greatest progress at the least cost."

The United States has the ability to restore confidence and self reliance among the European peoples. "Not by military strength alone but by political, religious and cultural ideas" can this be accomplished.

Questioned concerning the United Nations, Dr. Eckhardt replied that while the organization is not perfect it is entirely necessary and could easily provide the ground work for world peace.
