

Mayor to Mail Reports for Closer Public Relations

As a matter of public relations Mayor Al Loucks has picked at random a group of Salem citizens to whom will be mailed each month the monthly report of City Manager J. L. Franzen on city activities.

In a letter to the citizens the mayor asks their reaction and their answers to certain questions.

"Each month," says the mayor's letter, "the city manager submits to the council a report covering activities of the various departments for the preceding month . . . in order that, so far as possible, the public may be kept informed as to the operations of the city government, the council has authorized the distribution of these reports. We have been distributing them over the desks of the water department and the public library. To make further distribution and to further expand the distribution, we have selected a group of approximately 100 Salem citizens to whom we plan to send a personal copy of this report for the next several months.

"I would very much appreciate your careful study and your reaction as follows: "As to the contents; how do you feel about the departmental reports, expenditures as listed, and the budget of departments as shown? "Do you have personal friends or business acquaintances whom you feel would like to see on this mailing list? "Is this report as prepared for our citizens essential to the public relations program of the city in your opinion? "What suggestions of any kind do you have concerning this program?"

"It seems to me that whatever comments you may have, either favorable or unfavorable, will be of considerable assistance to the city."

School System Fully Staffed

As of this date the Salem public school has a full staff of teachers for the 1951-52 term, Superintendent Frank B. Bennett reported Friday.

There is the possibility that there may be a few resignations, but this will become less likely as the time for opening the fall term in September draws nearer.

The staff will be increased by about a dozen instructors this fall due to the growth in school population which necessitated the addition of several class rooms. Whether all of these extra class rooms will be ready by the first day of school is problematical.

Last spring the board authorized the hiring of nine additional elementary teachers, two junior high instructors and one for senior high school work.

The superintendent states that he has had less difficulty in filling his staff because the turnover on the elementary level has been less than for a number of years. Increased pay is believed responsible for this situation.

Senior and junior high school teachers have become more numerous, although elementary instructors remain fairly scarce on a state wide basis, stated the superintendent. The Salem school system has been able to take advantage of the fact that it is the capital of the state, and that teachers have a tendency to go to those schools that have tenure.

Suburban Folk Voice Protests

Property owners of Norman and Dietz streets in the suburban areas of Salem appeared before the county court Friday and voiced objections to the manner in which recent roadway improvements had been made.

The complainants declared the ditches had been dug too deep, leaving their property as much as 18 inches below the surface of the streets. This, they contended, depreciated the value of their holdings.

It was explained by the county engineer that the roads had to be sufficiently high to prevent damage through lack of proper drainage.

There was no objection as to the cost of either project and the court stated that discussions as to ditches and elevation of the roadway should have been taken up prior to the letting of the contracts.

Arabia Agrees to Use of Airfield

Washington, July 13 (AP) — The United States disclosed today Saudi Arabia has agreed to let American planes use strategic Dhanran airfield for the next five years.

The state department said the accord was signed at Jidda June 18 and has provisions for a five-year renewal.

The U. S. helped build the field during World War II and has been using it on a year-to-year basis since then. The field is located in southern Saudi Arabia near the Arabian sea.

In another move to build a ring of air bases overseas, the house armed services today approved \$1,071,638,000 worth of secret air force construction in Europe and areas rimming the Soviet. Included are new and expanded bases.

In addition, the committee tentatively approved multimillion dollar construction at eight bases in the Alaskan area and Puerto Rico and six within the United States.

The work is proposed as part of a \$6,561,252,000 global military construction program which the committee is taking up on an item by item basis.

Acheson Talks On Armistice

Washington, July 13 (AP) — Secretary Acheson indicated today he feels any Korean armistice should be based on the present battle lines rather than on the 38th parallel.

At a news conference, Acheson also fully endorsed Gen. Matthew B. Ridgway's demand on the communists for a completely neutral zone at Kaesong and for full freedom of movement to and from that armistice negotiation city.

The secretary of state said it is impossible to carry out free negotiations without complete reciprocity and where one party has freedom of movement and another has not.

The question of a truce line came up when Acheson was reminded that during the senate MacArthur hearings several weeks ago he had said he believed a settlement of the war on the 38th parallel would constitute a victory for the United Nations.

In broadcasts to the world, the U. S. radio is accusing the communists of "bad faith" in the negotiations and saying this forced suspension of the talks at Kaesong.

The three young Williamson children were reported improved today at Salem General hospital. Verda Mae, 6, was described in "good condition." Leandra Sue, 18 months, and Patricia Ann, 3, were more seriously hurt but reported improving. A fourth child was still-born at the time of the accident.

Mrs. Williamson is survived by her widower, James Williamson of Salem; her parents, Mr. and Mrs. Carl C. Johnson of Bakersfield, Calif., and five brothers and sisters, all in California.
