4-H CLUB AGENT: Clerical Hire, Traveling Expense, Materials & Expenses, etc.

HOME DEMONSTRATION AGENT: Traveling Expenses, Materials & Expenses, Telephone & Telegraph, etc.

HEALTH CONSERVATION: OFFICE OF COUNTY HEALTH OFFICER: Public Health Physician, Senior County Sanitarian, etc.

GARBAGE DISPOSAL: REGISTRATION OF VITAL STATISTICS, HEAD INSPECTOR, T. B. & Bangs Testing Fee, etc.

INDUSTRY FOR SLAUGHTER OF DISEASED CATTLE: Inspected Paid, CHARITIES & CORRECTIONS, etc.

CARE OF POOR: Insane Paid, Assistance for Blind, Aid to Dependent Children, etc.

MARKET ROADS MAINTENANCE AND IMPROVEMENT: Maintenance and Improvement of Market Roads, Bridge Construction, etc.

ESTIMATE OF RECEIPTS: MARKET ROAD REVENUE, DELINQUENT TAXES, MISCELLANEOUS REVENUE, etc.

GENERAL ROADS & HIGHWAY FUND: Road Districts Outside of Salem, Road Construction & Maintenance, etc.

COUNTY SCHOOL FUND: Ten Dollars per Capita on Pupils, Less Estimated Miscellaneous Revenue, etc.

COUNTY SCHOOL LIBRARY FUND: Ten Cents per Capita on Pupils, Less Estimated Miscellaneous Revenue, etc.

ESTIMATED MISCELLANEOUS REVENUE: Estimated Receipts for Year 1951-52, Estimated Receipts for Year 1952-53, etc.

ROAD & HIGHWAY REVENUE: Delinquent Taxes, Forest Rental & Sales, Fines & Bail Forfeitures, etc.

IMPROVEMENT OF PUBLIC ROADS REVOLVING FUND: Public Road Improvement, Total Appropriation, etc.

REVENUE: Revenue from Road Fund Interest & Rebate, Surplus from Road Fund Interest & Rebate, etc.

ROAD OPERATIONS-REVOLVING FUND: Salary of Dog Control Bear, Gasoline, Oil, Repairs, Operators' Wages, etc.

COUNTY PROPERTY REVOLVING FUND: Salary of Property Clerk-part time, Salary of Office Clerk, etc.

LABORATORY REVOLVING FUND: Revenue, Expense, etc.

PHOTOGRAPH AND MULTILITH REVOLVING FUND: Salary of Multilith Operator, Photostat Supplies, etc.

DOG LICENSE REVOLVING FUND: Salary of Dog Control Enforcement Officer, Indemnity to Sheep Owners, etc.

COUNTY FAIR FUND: Revenue, Expense, etc.
