CHICAGO—The wiring system of every F-86D Sabre jet plane in the Air Defense Command was ordered rechecked Friday following the accidental discharge of a combat loaded rocket at O'Hare Air Force Base.

AFL Musicians Come to Terms

NEW YORK—AFL musicians and the nation's three largest radio-TV networks have agreed on a five-year contract providing for a 20 per cent wage increase over that period.

James C. Petrillo, union president, announced the settlement Friday night with NBC, ABC, and CBS. The mutual network, with only "observers" at the contract sessions, is expected to fall in line later.

The musicians get a 10 per cent wage boost effective at once, and another 10 per cent at the end of three years.

Under the agreement, the number of studio staff musicians will remain at the old quotas. Union members involved, including some 600 here, work on TV shows originating from New York, Chicago and Los Angeles.

A threatened strike against the networks earlier in the week was postponed so negotiations could be continued.

The present wage scale is \$182.50 weekly.

Pope's Recovery to Be Over Long Period

VATICAN CITY—The Vatican apparently answering rumors that Pope Pius XII has taken a turn for the worse, announced Saturday that his "gradual, slow recovery continues normally."

A communique, the first issued in several days on the ailing Pontiff's health, said his convalescence from a persistent stomach ailment was expected to be a long one.

"A good period of repose," is needed before the Pope can regain his normal health, the Vatican said.

Army Declines to Obey Demands of McCarthy

WASHINGTON—The next move is up to Sen. McCarthy (R-Wis.).

The Army has declined to comply with the senator's demand that it produce the names of all personnel who had anything to do with the promotion and honorable discharge of a reserve dentist whom McCarthy has labeled a Communist.

The Wisconsin senator laid down a 24-hour ultimatum Thursday during a New York hearing at which the dentist, Dr. Irving Peress, refused to answer 33 questions about possible Communist activities and connections. He invoked the Fifth Amendment against self-incrimination.

"Either the Army will give the names of men coddling Communists," McCarthy said, "or we will take it before the Senate and attempt to have cited for contempt those responsible for a shameful situation."

Income Tax Return Short Form 1040
Income Tax Return, Form 1040, may be used either as a short form or as a long form. The short form is simpler than the long form. It differs from Form 1040A in that (a) you must find your own tax; (b) you may include income from sources not eligible for reporting on Form 1040A; and (c) you may deduct travel and reimbursed expenses from your wages. Therefore, if your income was less than \$3,000 and you do not desire to itemize non-business deductions (contributions, interest, etc.), find your tax from the table on the back of the form, tear off the first sheet and file it as a Short-Form 1040.

More Funds for Dams Sought

WASHINGTON—A House appropriations subcommittee Friday was asked to increase appropriations for The Dalles and Chief Joseph Dams and to appropriate money for new power dams in the Pacific Northwest.

The subcommittee was given a letter by Oregon's Gov. Paul Patterson, who said he also represented the governors of Washington, Idaho and Montana, urging the enough money be appropriated for The Dalles and Chief Joseph so that construction schedules can be maintained.

He has estimated that the recommended appropriations for Chief Joseph and The Dalles, 27 million dollars and \$34,100,000, would result in a one year's delay in the two projects.

C. A. Erdahl, Northwest Utilities Conference Committee chairman, and J. Frank Ward, managing director of the Washington State Power Commission, joined Patterson and also requested additional funds to start new projects in the area.

Corrupt Practices Act Weak, Says Neuberger

Oregon is a "one-party" state because the Republicans have huge campaign funds while the Democrats are unable to raise more than a pittance, State Senator Richard L. Neuberger declared at a Democratic meeting held Friday night at the Bush school.

Neuberger suggested a limit of 50,000 expenditure in behalf of any major candidate by a committee and \$25,000 for the candidate himself.

For congressmen, Neuberger would limit campaign outlays to \$15,000 with limits tapering off in accordance with the importance of the job. He said that the limits in larger cities would, of necessity, be higher than in the smaller communities.

The Multnomah county senator and writer decried the attack on Chief Justice Earl Warren, an attack which he placed on charges "without evidence" by Senator McCarthy.

Neuberger, when asked if he would be a Democratic candidate for United States Senator said that he hadn't made up his mind yet.

Dave Beck Loses First Round in Gain of Power

MIAMI BEACH, Fla.—Dave Beck apparently has lost an initial skirmish to gain more power in the giant AFL Teamsters Union. Lesser leaders succeeded at a general executive board winter meeting which ended yesterday in thwarting Beck's efforts to gain more supervisory control over rich union welfare funds.

Beck, whose announced aim is to negotiate national contracts on a coast-to-coast basis in the trucking industry, apparently met staunch opposition from teamsters local and district council bosses jealous of retaining their power.

The board declined to give Beck the sweeping authority he sought to prevent "racketeering and overt acts" in local handling of union trust funds. Teamster contracts and trust funds are presently negotiated on a local basis.

Union administration of welfare funds has been under fire from congressional investigators, particularly in the 1,300,000-member Teamsters Union, and Beck has made go.
