Nine-month budget discussed at public meeting

Tribal Council presented the cated. Approximately \$100,000. nine-month budget, adopted by resolution #7108 February 27, at a public meeting March 25 at the Agency Longhouse. The budget, which shows a \$2.1 million surplus for 1986, will go into effect April 1. Over 100 tribal members from all three districts attended the meeting.

By comparison, the nine-month budget, in addition to the threemonth operations appropriations, is larger than the original operating budget that was adopted and petitioned late last year. The total budget authority for 1986 is \$19,017,356. The \$1.5 million difference is due to increased per capita payments, appropriations for Kah-Nee-Ta, interest on an EDA loan and for KWSI.

Per capita payments made to all enrolled members were increased from \$75 to \$100 per person. The last time per capita 1979, that jump being from \$60 to \$75.

Rather than authorize Kahwere appropriated for the resort. will eventually employ 57 people. An additional \$58,000, carried over from 1985, was also allo- Continued on page 2

of the funding will be used for capital improvements at the resort.

Payment to the Credit revolving loan fund by Kah-Nee-Ta was delayed until the second quarter, resulting in an additional \$1,034 in interest on the EDA loan.

Because grant applications for KWSI are still in the review process in Washington, D.C., an additional \$7,240 was provided for the station.

One tribal member questioned the \$25 increase in per capita payments. "I think it's kind of bad business, when we're not making any money," he said. Chairman Zane Jackson stated that the Tribe is "not projecting additional monies appropriated at working at a deficit. We'll be making a profit. People have asked for an increase. People need the increase," Jackson said.

The same member asked why the money used for the per payments were increased was in capita increase couldn't be used for increasing the number of jobs on the reservation. Apportionment will be decided by voters on May 15

Thursday, May 15, has been whether or not the Warm Springs set aside for an election called by the Secretary of the Interior to determine the fate of the apportionment issue. The need for a secretarial election arose when apportionment advocates circulated a petition in January gaining the signatures of 562 eligible tribal voters at least 18 years of age.

According to Warm Springs superintendent Bernard Topash, the final version of an information pamphlets, just recently completed, was mailed March 27 to all voters. Also mailed were registration forms. All tribal members at least 18 years of age by May 15 are required to register.

Topash stressed that all voters must register to vote. The last day to register will be April 24 and a final voters' list will be posted by the BIA April 25. Absentee votes must be received by the superintendent's office by May 14.

Registration forms can be obtained at the superintendent's office.

Rules

Rules to govern the election to vote on amending the constitution and by-laws of the Confederated Tribes of the Warm Springs Reservation of Oregon. These rules are in accordance

with Part 81, Chapter 25 of the Code of Federal Regulations. 1. Election Date: May 15,

1986.

2. Time of election: 8:30 a.m. to 7:00 p.m..

3. Polling Place: Warm Springs Community Center.

4. Eligible Voters: All enrolled members who are at least 18 years of age on election day. and registered to vote. You must register to vote to be entitled to vote on this amendment to the constitution.

5. Registration: The Election Board has arranged for the registration for all those wanting to vote. On page 9 of this pamphlet is the form you must complete and return to the election Board Chairman. A self-addressed envelop is enclosed for you to return your registration form.

6. The registered voters list shall be in alphabetical order and shall be posted for review at the following places: Warm Springs Agency, Macy's Store, Simnasho Longhouse, Indian Health Service, Tribal Council Office and the Portland Area Office, Bureau of Indian Affairs. 1425 N.E. Irving Street, Portland, Oregon 97208.

Deadline for voter registration is April 24, 1986.

7. Claims and Challenges: Anyone whose name is not on the official eligible voters list can claim the right to vote by presenting a written claim to the Election Board.

The right to vote of anyone whose name is on the list may also be challenged in writing to the Election Board.

Such claims or challenges must be sent to the Chairman of the Election Board, Bernard W. Topash, Warm Springs Agency, Bureau of Indian Affairs, P.O. Box B, Warm Springs, Oregon 97761. Claims and challenges must be presented to the Election Board Chairman before 9:00 a.m. May 5, 1986. The Election Board shall meet on the same day to pass on any claim or challenge; it's decision shall be final.

The final official list of those entitled to vote will be posted at the Superintendent's Office, Bureau of Indian Affairs, Warm Springs Agency on the same day.

8. Absentee voting: Eligible voters may vote by absentee ballot, if she/he is unable to vote at the poll. A request for
