

# Native American guide published

RRS Press announces the publication of Robinson's Redbook: A Native American Guide to Washington, D.C., 1990 edition.

Due out in November 1989 in time for the Christmas-giving season, the 40-plus paged Guide contains over 100 entries listing contacts in the Nation's Capitol that will be of interest to Native Americans and those involved in business in Washington, D.C. related to Native American affairs. It continues the popular D.C. Directory issued, until 1985, by the Phelps Stokes Fund.

Bound in a 5 1/2 x 7 1/2 format to fit into purse or briefcase, the Redbook contains the names and addresses of individuals and offices Indians often need to contact in the Nation's Capitol. It includes everyone from Bush the President of the American Indian Society of Washington, D.C. to Bush the President of the United States.

Want to know where Indians "hang out" after their work is done? The Redbook gives you what, where, when and who to call on area Indian "doings" like bowling and softball leagues, monthly meetings of community groups, powwows, annual dinners and even some "watering holes."

Did you know that there are about 50 Indian private and non-profit organizations in D.C.? They mostly do business with the Government and with Indians, but Gary's is a restaurant, Red Bear Limited is a specialty craft firm and Frankie Welch of America is a top fashion designer.

If you fail to appear as so ordered, the Tribal Court shall enter a complaint for contempt of court and issue a warrant for your arrest. If you have any questions, you should seek legal assistance immediately.

## Tribal Court news— Affidavit of Prejudice explained

In an effort to provide community assistance, awareness and education, the Tribal Court will be submitting articles such as the following regarding "Affidavits of Prejudice." The information and sections of the Tribal Code will hopefully enable you to submit documents necessary with all of the required information for an immediate response by the Court.

Many documents cannot be accepted and are sent back due to lack of specific information. I'm sure you've heard the statement form "Dragnet" where Sergeant Friday says, "Just the fact, ma'am." Well, that is what the Court requires, "the facts."

The Affidavit of Prejudice is self-explanatory in the Code section 200.270(2). The facts must be stated specifically why you believe a fair hearing or trial decision could not be received from that judge.

**Filing an Affidavit of Prejudice**  
WSTC 200.270 Disqualifications—A Tribal Court judge may be disqualified from presiding over a particular case where there is a conflict of interest, a request for disqualification or a self-disqualification.

1. No judge shall be qualified to act as judge in any case wherein that judge has a direct interest or where any party to the action is a relative by marriage or by blood in the first or second degree. Removal of the judge from the case in these circumstances is mandatory. Parties to the case may not waive this disqualification rule.

2. A judge may be removed from the case upon the basis of an Affidavit of Prejudice which has been filed by one of the parties. The Affidavit must be in writing and must offer facts and evidence to support the request. The reasons presented must be sufficient to lead a reasonable person to believe that the party could not receive a fair trial by the judge being opposed. Decision on the request by an impartial judge is discretionary and final.

3. In some cases a judge may elect to disqualify himself or herself. This is a personal decision and is not mandatory. Such decision will normally be made where the affected judge feels that a decision on the case could not be fairly made without bias or prejudice. This very personal decision may not be challenged.
