Home Improvement Coordinator Housing Department	Responsible for developing a housing need assessment of all reservation housing and writing grant applications to outside funding programs to endure maximum funding for repair replacement and new construction of Tribal member housing. High school diploma required or equivalent, 6 to 8 years related experience, must possess Oregon driver's license.
Accounting Supervisor Enterprise/Accounting	Bachelors Degree in accounting or related field. Must have a minimum of five years experience in industry and/or municipal accounting and in managing all of the major operational functions within an accounting department. Experience in operating a microcomputer including Lotus 1-2-3 and Wordperfect.
Power Sewing Machine Operators (W.S.A.I.)	Desire to learn, able to communicate well and have positive thinking. WSAI will train for existing positions.
Maternal and Child Health Specialist (Community Health Promotion)	MCH specialist shall be responsible for the direction of the Tribal Maternal Child Health Program.
