This would save travel to other places to do all the shopping. A person can shop with his neighbors right at home without having to travel in all sorts of weather.

Proper consideration needed regarding Council compensation

To the editor,

Reference to Zane Jackson's letter October 8, 1991 inviting suggestions on Tribal Council compensation, the following questions and statements are submitted:

Prior to considering Tribal Council pay, an understanding of serving on the Tribal Council should be clarified.

Serving on the Tribal Council should not be considered a full time job to support a family as that was not the original intent.

It appears that some of the Tribal Council business, agenda items, can be trimmed, eliminated or delegated.

A good, close working relationship should exist between the tribal council and management (CEO, managers, supervisors) that would ensure adequate information for the Tribal Council to make decisions. At least one Tribal Council chairman in the past has had to leave Tribal Council meetings to seek more information so that a decision could be made. There are various degrees of similar situations (Time manage-

Are evening meetings out of order? School boards, county commissioners, city councils, etc., have night meetings.

An hourly rate should be involved with Tribal Council pay, otherwise if only a daily rate is in effect, a Tribal Council member could be paid the full daily rate if they attended one or just several hours of an official meet-

What rates of vacation and sick leave are you suggesting?

Rates of pay with other tribal councils is difficult to compare if their organizations are not similar. The Yakima tribes never adopted the Wheeler-Howard bill like the Warm Springs Tribes. I believe the Yakima tribal chairman is also an administrator. The Yakima General Council is

important in their organization.
What other tribal organizations are similar to the Warm springs Tribal Organization?

In serving on the Tribal Council, why should Warm Springs tribal members employed by the Tribes have an advantage over other tribal members that are employed by organizations other than the Warm

Springs Tribes. The benefits are not the same or similar. Questions of conflict of interest arise when tribal employees serve on the tribal council

Apparently I have been taken off the list to receive CURRENT minutes of Tribal Council meetings.

Tribal constitutional changes are very important; therefore, more information is needed before proper consideration can be given to an increase in Tribal Council compensations, and if other benefits are to be considered.

Concerns expressed by Thomas

To the editor,

I am responding to a concern being addressed by the Tribal Council
Chairman per Tribal Council members that Council men and women
are experiencing difficulty supporting a home and family on the amount
they are presently being paid, well, I
also have a concern I would like to
address.

Human services are limited to Tribal members living on the reservation, ie. hospital, medical and housing. I am a Tribal member living 26 miles out of the service area and have come up against these problems recently.

In order to receive housing I must return to the reservation and live with relatives, have verifiable employment just to get on a waiting list.

I have on occasion parked at Macy's store and observed workers shopping during work time. On one day you will notice that between 8:30-9:15 a.m., all the drive out workers, driving government vehicles, probably forestry and tribal management vehicles, occupants ranging from 2 to 4 persons. In that 45 minutes, 15 to 20 employees are taking at least 30 minutes work time to shop for snacks. This costs the Tribes approximately \$5.50 per hour, a minimum of \$35.00 per day, \$175.00 per week. Many other employees spend work time at the store or in Madras at Aherns, Dairy Queen, Video Shops and at Kah-Nee-Ta, that would be hard for me to believe are Tribal affairs.

Referring back to raises for

Council members and chiefs, what is not mentioned is: what benefits do they now receive?: Per diem, meals, lodging with housing, wood, medical other than Indian Health Insurance? How much is pure dedication

to the Tribes personal sacrifice?

It really hurts my heart to only be treated like a Tribal member when you need a vote like this and not when I need it. I have in the past year been hospitalized 3 times and have not been able to get assistance and have been treated like a stranger. This really hurts.
